**ORDER**

WHEREAS, in terms of Section 14/15(3)(a) of NCTE Act, 1993, the institution namely "Shree Swaminarayan Vishvamangal Gurukul, Opp. GIDC, Highway Ta. Kalol, Gandhinagar-382725, Gujarat" was granted recognition for B.Ed. course of one year duration with annual intake of 100 for the academic session 2005-2006 vide Order No. WRC/2-32/323132/67/2005/580 dated 14.02.2005 with name of affiliating body as Gujarat University, Ahmedabad.

2. AND WHEREAS, in pursuance of NCTE Regulations,2014, Revised Order vide F.No. WRC/APW00496/323132/2015/139565-572 dated 31.05.2015 was issued to institution viz.Shri Swaminarayan B.Ed. College, Managed by Shree Swaminarayan Vishvamangal Gurukul, Opp. GIDC, Highway, Taluka- Kalol, District- Gandhinagar-382725, Gujarat for conducting B.Ed. course of two years duration with annual intake of 50 students (one basic unit) from the academic session 2015-2016 subject to fulfilment of the conditions mentioned therein with name of affiliating body as Gujarat University, Ahmedabad.

3. AND WHEREAS, in pursuance of order dated 24.12.2020 in W.P.(C) 11103/2020 passed by Hon'ble High Court of Delhi, matter was considered in 329<sup>th</sup> meeting of WRC held on 17<sup>th</sup> to 19<sup>th</sup> February 2021. Accordingly, second Revised Recognition Order dated 24.02.2021 was issued to the institution viz. Shree Swaminarayan B.Ed. College, Managed by Shree Swaminarayan Vishvamangal Gurukul, Opp. GIDC, Highway, Taluka- Kalol, District- Gandhinagar-382725 for B.Ed programme for one more unit (50. intake) from the academic session 2021-22, thus making the total intake of 100 (two units) with name of affiliating body as Gujarat University, Ahmedabad.

4. AND WHEREAS, Swaminarayan University, Kalol, District – Gandhinagar, Gujarat" has submitted proposal vide letter No.SO/NCTE-Correspondence/2023/713 dated 24.11.2023 for updating the status of institution on NCTE website showing the affiliating body as Swaminarayan University and another letter vide No.SU/NCTE/2024-25/812 dated 02.12.2024 in the matter of de-affiliating letter of Shree Swaminarayan B.Ed. College (WRC Code-APW00496/ 323132) from Gujarat University and recognizing the college under Swaminarayan University since inception i.e. June 2022 onwards.




8. The terms and conditions shall remain same as mentioned in the revised recognition orders issued dated 31.05.2015 and 24.02.2021.
