**REVISED WITHDRAWAL ORDER**

WHEREAS, the institution, namely, **Harnam Dass Lekhraj Institute of Education, Chak 24 B.B. Killa No. 18,23 Gajsinghpur Road, Padampur, Sriganganagar- 335041, Rajasthan** was granted recognition by WRC, NCTE for **B.Ed. Course** vide Order No. F.NRC/NCTE/RJ-1593/2008/59024-30 dated 26.08.2008 of one years duration with an annual intake 100 students.

2. **AND WHEREAS**, Revised Recognition Provisional Order (RPRO) was issued to the institution vide Order No. **F.No./NRC/NCTE/RJ-1593/2015/96088-093 dated 29.04.2015 for B.Ed. Programme** of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session **2015-2016**.

3. **AND WHEREAS**, a verified complaint has been received from Complaint Division dated 01.02.2024.

4. **AND WHEREAS**, the matter was considered by WRC in its 402<sup>nd</sup> Meeting held on 27<sup>th</sup> March, 2024 and the Committee decided as under:

*"The original file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee decides as under:*

*Copy of verified complaint received against the institution be forwarded to the affiliating body for its comments and to submit status report within 30 days from the date of issuance of communication by WRC, NCTE."*

Accordingly, the letter was issued letter no. WRC/NCTE/RJ-1563/B.Ed./402<sup>nd</sup> Meeting/2024/225025 on dt. 06.04.2024 to the Affiliating body.

5. **AND WHEREAS**, Show Cause Notice (SCN) was issued to the institution on 22.01.2021. The institution has not submitted the reply of SCN.

6. **AND WHEREAS**, further, again a confirmed complaint has been received from Complaint Division, NCTE, New Delhi dated 30.05.2024.

7. **AND WHEREAS**, the matter was considered by WRC in its 408<sup>th</sup> (Part-1) Meeting held on 12<sup>th</sup> -14<sup>th</sup> November, 2024 and the Committee decided as under:

*"The application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee decided as under:*

*A letter be issued to the concerned affiliating body/ University and Collector/ District Magistrate (DM) together with copy of the complaint received from Shri Deepak Chhabra, District – Sirsa, Haryana received through Complaint Division, NCTE Hqs., New Delhi for point-wise reply on the complaint within 21 days from the date of issue of the letter. Copy of the complaint be also forwarded to the concerned institution for point-wise reply on the allegations made in the complaint within 21 days from the date of issue of letter along with following documents and clarification thereon:*

- i. *Copy of the Registered Land Documents of the institution.*
- ii. *Copy of the Certificate of Land Mutation of the institution.*
- iii. *Copy of the Certificate of Land Use (CLU) of the institution.*
- iv. *Copy of the Building Safety Certificate of the institution.*
- v. *Copy of the Approved Building Plan issued by the competent Govt. Engineer.*
- vi. *Copy of the Approved Building Completion Certificate issued by the competent Govt. Engineer.*
- vii. *Copy of the Fire Safety Certificate issued by the competent Govt. Authority.*
- viii. *Copy of the Letter issued by the competent Govt. Authority for Disability Friendly Certificate.*
- ix. *Updated approved faculty list issued by the concerned university together with approval letter issued by the University as well as details of salary disbursed to the faculties for last 6 months."*

Accordingly, three Reminders vide letter dated 20.12.2024 was issued to the District Magistrate, Affiliating Body of the Registrar and the Institution.

**8. AND WHEREAS,** the reply has been received from the Affiliating Body of the Registrar vide letter dated 08.07.2024.

**9. AND WHEREAS,** the matter was considered by WRC in its 417<sup>th</sup> Meeting held on 07<sup>th</sup> 10<sup>th</sup> April 2015 wherein the Committee decided as under:

*"The application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time along with verified complaint related correspondences and the Committee decided as under:*

*Show Cause Notice u/s 17 be issued to the institution to submit compliance regarding fulfillment of following deficiencies on the verified complaint matter:*

*1. The institution did not submit any reply in response to WRC letter dated 20.12.2024 seeking point wise reply on the allegations made in the complaint along with following documents and clarification thereon:*

- i. *Copy of Registered Land Documents of the institution.*
- ii. *Copy of the Certificate of Land Mutation of the institution.*
- iii. *Copy of the Certificate of Land Use (CLU) of the institution.*
- iv. *Copy of the Building Safety Certificate of the institution.*

- v. Copy of the Approved Building Plan issued by the competent Govt. Engineer.
  - vi. Copy of the Approved Building Completion Certificate issued by the competent Govt. Engineer.
  - vii. Copy of the Fire Safety Certificate issued by the competent Govt. Authority.
  - viii. Copy of the Letter issued by the competent Govt. Authority for Disability Friendly Certificate.
  - ix. Updated approved faculty list issued by the concerned university together with approval letter issued by the University as well as details of salary disbursed to the faculties for last 6 months.
2. Reminder be issued to District Magistrate, Sri Ganganagar enclosing the copy of previous letter along with copy of complaint to submit reply within 15 days from the date of issue of letter."

Accordingly, two letters were issued First letter was issued to the District Magistrate, Sri Ganganagar, Rajasthan dated 16.05.2025 and Second Show Cause Notice was issued to the institution dated 16.05.2025.

**10. AND WHEREAS,** the institution has submitted reply to Show Cause Notice vide letter dated 15.05.2025 and 06.06.2025. The matter was considered by WRC in its 430<sup>th</sup> (Part-III) Meeting of WRC held on 17<sup>th</sup> – 18<sup>th</sup> July, 2025 and the Committee decided as under:

*"The application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time the Committee observed as under:*

*Recognition was granted for B.Ed. course of one year duration with annual intake of 100 from the academic session 2008-2009 vide order dated 26.08.2008 followed by revised order dated 29.04.2015 for B.Ed. course of two years duration with annual intake of 100 for two basic units of 50 students each from the academic session 2015-2016 subject to fulfillment of the condition mentioned in the revised order before 31.10.2015.*

*In response, compliance report submitted by the institution vide letter dated 31.10.2015 received on 05.11.2015.*

*The matter was considered by NRC and Show Cause Notice under Section 17(1) was issued dated 12.04.2018 to the institution with direction to comply the deficiencies mentioned therein.*

*The verified complaint against the institution received through Complaint Division, NCTE HQrs. was considered by WRC in its 402<sup>nd</sup> meeting held on 27<sup>th</sup> March, 2024 and matter was forwarded to the affiliating body vide letter dated 06.04.2024. Complaint against institution was again received vide Complaint Division, NCTE letter dated 30.05.2024 followed by reminder dated 24.09.2024.*

*Matter was considered in 408<sup>th</sup> (Part-1) meeting of WRC held on 12<sup>th</sup>-14<sup>th</sup> November, 2024. Accordingly, point-wise reply on the allegations made in the complaint was sought from the institution and reminder issued to affiliating body, letter to DM, Sri Ganganagar vide WRC letters dated 20.12.2024. Reply was not submitted by the institution. Reply vide letter dated 08.07.2024 was submitted by affiliating body (received in WRC on 29.01.2025). Second reminder dated 18.02.2025 was received from complaint division, NCTE seeking action taken report on complaint matter.*

*The Committee considered all documents available in institution file in its 417<sup>th</sup> meeting held on 07<sup>th</sup>-10<sup>th</sup> April, 2025. Accordingly, Show Cause Notice u/s 17 was issued dated 16.05.2025 to the institution with direction to submit compliance regarding fulfillment of following deficiencies within 21 days:*

1. The institution did not submit any reply in response to WRC letter dated 20.12.2024 seeking point wise reply on the allegations made in the complaint along with following documents and clarification thereon:
  - i. Copy of Registered Land Documents of the institution.
  - ii. Copy of the Certificate of Land Mutation of the institution.
  - iii. Copy of the Certificate of Land Use (CLU) of the institution.
  - iv. Copy of the Building Safety Certificate of the institution.
  - v. Copy of the Approved Building Plan issued by the competent Govt. Engineer.
  - vi. Copy of the Approved Building Completion Certificate issued by the competent Govt. Engineer.
  - vii. Copy of the Fire Safety Certificate issued by the competent Govt. Authority.
  - viii. Copy of the Letter issued by the competent Govt. Authority for Disability Friendly Certificate.
  - ix. Updated approved faculty list issued by the concerned university together with approval letter issued by the University as well as details of salary disbursed to the faculties for last 6 months.
2. Reminder be issued to District, Magistrate, Sri Ganganagar enclosing the copy of previous letter along with copy of complaint to submit reply within 15 days from the date of issue of letter.

Accordingly, reminder was issued to DM, Sri Ganganagar vide letter dated 16.05.2025 in continuation of previous letter dated 20.12.2024 and reply not received. The reply submitted by the institution vide letters dated 15.05.2025 and 06.06.2025 in response to WRC letter dated 20.04.2024 and SCN dated 16.05.2025 respectively has been examined by Committee and it is observed that the institution is still deficient on the following grounds of show cause notice u/S 17:

- i. Photocopy of Building Plan approved by Sahayak Abhiyanta, PWD, Sub-Division, Padampur, Rajasthan submitted by the institution has not been approved by local govt. authority and date not reflected therein.
- ii. Photocopy of faculty list for the year 2024-25 submitted by the institution comprising 01 Principal +15 Lecturers, which is not in NCTE prescribed format and same is not approved by Registrar of Affiliating University. Faculties in Perspectives in Education and Pedagogy subjects as required under NCTE norms-Appendix-4 is not reflected in the faculty list/ have not been appointed.
- iii. Letter of approval regarding selected/appointed faculties issued by Affiliating University as per laid down procedure/policy of Affiliating Body is not submitted.
- iv. Details of salary disbursed to the faculties for last 6 months is not submitted.
- v. Duly filled in Form 'A' in original issued by authorised signatory of concerned bank towards maintaining of Joint FDRs towards Endowment and Reserve Fund as per provision of NCTE Regulations is not submitted.
- vi. Submitted copy of Building Completion Certificate is not approved by competent Govt. Authority and date of approval of BCC is not reflected therein.
- vii. Fire Safety Certificate issued by designated Fire Safety Department of Government of Rajasthan is not submitted.
- viii. The institution has not submitted Certificate to the effect that the building is differently abled friendly from the Competent Government Authority.

- ix. Downloaded copies of documents from the institutional website with hyperlink of the same in compliance to provisions under Clause 7(14)(i), 8(6), 8(14) and 10(3) of NCTE Regulations, 2014 as amended from time to time is not submitted.

*In view of the above, the Committee decided that recognition granted to B.Ed. course be withdrawn u/S – 17 of NCTE Act, 1993 from the academic session next following the date of issue of withdrawal order with a copy to State Government, Affiliating Body and all concerned."*

11. **NOW, THEREFORE**, in exercise of the powers conferred under Section 17(1) of the NCTE Act, 1993, recognition granted for **B.Ed. programme** in respect of the institution viz. "**Harnam Dass Lekhraj Institute of Education, Chak 24 B.B. Killa No. 18,23 Gajsinghpur Road, Padampur, Sriganganagar- 335041, Rajasthan** is hereby withdrawn from the end of the academic session next following the date of communication of the said withdrawal order.

12. इसके अलावा, यदि संस्थान और संबद्ध निकाय को एनसीटीई अधिनियम, 1993 की धारा 17(4) के निम्नलिखित प्रावधानों के बारे में सूचित किया जाता है:-

(4) यदि कोई संस्था (1) के अधीन मान्यता वापस लेने वाले आदेश के प्रवृत्त होने के पश्चात अध्यापक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रस्थापित करती है तो, या जहां अध्यापक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रस्थापित करने वाली कोई संस्था नियत दिन के ठीक पूर्व अधिनियम के अधीन मान्यता या अनुज्ञा प्राप्त करने में असफल हो जाती है या उपेक्षा बरतती है वहां, ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसरण में या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण करने के पश्चात प्राप्त अध्यापक शिक्षा में अर्हता को, केन्द्रीय सरकार, किसी राज्य सरकार या विश्वविद्यालय के अधीन या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी विद्यालय, महाविद्यालय या अन्य शिक्षा निकाय में नियोजन के प्रयोजनों के लिए, विधिमान्य अर्हता नहीं मानी जाएगी।

13. Further, the institution and affiliating body are hereby informed about the following provision of Section 17(4) of NCTE Act, 1993:-

*"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government."*

14. इसके अलावा, यदि संस्थान इस आदेश से संतुष्ट नहीं है, तो इस आदेश की जारी होने की तिथि से 60 दिनों के भीतर एन.सी.टी.ई अधिनियम, 1993 के धारा 18 के अंतर्गत एक अपील की जा सकती है जो ऑनलाइन होगी तथा एन.सी.टी.ई की वेबसाइट [www.ncte.gov.in](http://www.ncte.gov.in) पर उपलब्ध है।

Further, if the institution is not satisfied with the Order, it may prefer an Appeal against the aforesaid order under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of issue of this order. The guidelines for filing the appeal may be seen on NCTE website.

16. The previously issued Withdrawal Order vide F.No.NCTE/WRC/CF-84623/RJ-1593/430<sup>th</sup> (Part-III)/2025/7732-38 dated 29.09.2025 is treated as cancelled and the present Revised Withdrawal Order shall come into effect.
