WITHDRAWAL ORDER

WHEREAS, recognition was granted to the institution namely **GOVT. INSTITUTE OF ADVANCE STUDIES IN EDUCATION, GANGA NAGAR ROAD, DISTT.- BIKANER- 334001, RAJASTHAN** Vide Order No. F. No. F-3(4) RJ-1,(49)/98/881-936 dt. 01.06.1998 for **B.Ed.** course of 1 year duration with an annual intake of 170 students.

AND WHEREAS, Revised Recognition order was issued to **GOVT. INSTITUTE OF ADVANCE STUDIES IN EDUCATION, GANGA NAGAR ROAD, DISTT.- BIKANER- 334001, RAJASTHAN** dated 08.09.2015 for B.ED of Two Years Duration with an annual intake of 100 students (Two basic unit of 50 students each) from the academic session 2015-2016.

AND WHEREAS, the matter was placed in 281st Meeting of NRC held on February 20-21, 2018 and the Committee decided that "The Committee decided to issue show cause notice to all such institutions which have not submitted compliance of the revised recognition order."

Accordingly, a Show cause notice was issued to the institution on 24.03.2018 and its reply not received.

AND WHEREAS, the matter was placed in 316th Meeting held on August 27-28, & September 03rd 2020 to verify the compliance of NCTE Regulation s, 2014 and the Committee decided to issue show cause notice dt. 14.10.2020.

AND WHEREAS, the matter was placed in 325th Meeting held on January 09, 2021 of WRC and the Committee decided that:-

"...The WRC considered the PIL and also the complaint received against the institution (s) and decided that the institution may be directed to submit the faculty list duly approved by the affiliating body, for all the courses being run in the institution (s)."

The WRC also decided that the copy of Show Cause Notice also be marked to the Higher Education Department, Govt of Rajasthan."

Accordingly, a Show Cause Notice was issued to the institution on 22.01.2021 and its reply not received.

AND WHEREAS, the matter was placed in 336th Meeting held on 24-25 March, 2021 of WRC and the Committee decided as under:-

... The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:-

- a) The institution has not submitted certified copy of Land Documents.
- b) The institution has not submitted Land Use Certificate issued by the competent authority.
- c) The institution has not submitted Non - Encumbrance Certificate issued by the competent authority.
- d) The institution has not submitted staff list in prescribed format duly approved by the Registrar of concerned affiliating body.
- e) The institution has submitted Building Plan which is not approved by the competent authority.

Hence, the Committee decided to issue Final Show Cause Notice u/s 17 of NCTE Act 1993 to submit the notarized / certified documents on the above-mentioned grounds within 30 days from the date of issue of this Final Show Cause Notice."

Accordingly, a Final Show Cause Notice was issued to the institution on 05.04.2021 and its reply received on 04.05.2021.

AND WHEREAS, the institution had approach to the Judicature for Rajasthan at jodhpur. in W.P. (C) 12117/2019 dt. 01.12.2021.

AND WHEREAS, the matter was placed in 370th Meeting held on September 10th and 12, 2022 of WRC and the Committee decided that:-

...The original file of the Institution along-with other related documents, were carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- Initially, recognition was granted for B.Ed. course of one year duration with intake of 170 vide order dated 01.06.1998.
- Revised order dated 08.09.2015 was issued for B.Ed. course of two years duration with intake of 200 in light of NCTE Regulations, 2014.
- As decided by NRC in its 281st meeting held on 20-21 February, 2018, Show Cause Notice u/s 17 was issued dated 24.03.2018 for submission of compliance regarding adherence of conditions/ standards stipulated under NCTE Regulations, 2014.
- Matter was considered by WRC in its 316th meeting held on 27th to 28th August & 4th September, 2020 and as decided by WRC, Show Cause Notice u/s 17 was issued dated 14.10.2020 with direction to submit compliance of conditions mentioned in the revised recognition order and the documents mentioned therein.

- WRC in its 325th meeting held on 9th January, 2021 considered the D.B. Civil Petition PIL No.12447/2019 filed in the Hon'ble High Court of Judicature Rajasthan at Jodhpur i.e. complaint against the institution and the Committee decided that the institution may be directed to submit the faculty list duly approved by the affiliating body, for all the courses being run in the institution(s). The WRC also decided that the copy of Show Cause Notice also be marked to the Higher Education Department, Govt. of Rajasthan. Accordingly, Show Cause Notice u/s 17 was issued dated 22.01.2021 with a copy endorsed to State Govt. and Affiliating Body.
- As decided by WRC in its 336th meeting held on 24th-25th March, 2021, final Show Cause Notice u/s 17 was issued dated 05.04.2021 for compliance of following deficiencies:
 - I. The institution has not submitted certified copy of land documents.
 - II. The institution has not submitted Land Use Certificate issued by the competent authority.
 - III. The institution has not submitted Non-Encumbrance Certificate issued by the competent authority.
 - IV. The institution has not submitted staff list in prescribed format duly approved by the Registrar of concerned affiliating body.
 - V. The institution has submitted Building Plan which is not approved by the competent authority.
- In response, representation vide letter dated 22.04.2021 with enclosures, received on 04.05.2021 from the institution. Subsequently, an order dated 01.12.2021 passed by Hon'ble High Court of Judicature for Rajasthan at Jodhpur in D.B. Civil Writ Petition No. 12117/2019 with direction to NCTE to take a final decision on the show cause notice dated 07.03.2021 and 05.04.2021, preferably within six months for the date of issue of order.

The Committee considered the whole facts enumerated above and observed that the institution is still deficient on the following:

- The institution has not submitted faculty list for B.Ed. course in NCTE prescribed format duly approved by the Registrar of concerned affiliating body.


In view of the above, the Committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Western Regional Committee now hereby **Withdrawn** recognition of **GOVT. INSTITUTE OF ADVANCE STUDIES IN EDUCATION, GANGA NAGAR ROAD, DISTT.- BIKANER- 334001, RAJASTHAN** granted for B.Ed. course on the grounds mentioned above effect from the end of the academic session next following the date of communication of the said order.
