AND, WHEREAS, the matter was placed before the NRC in its 277<sup>th</sup> Meeting held from 05<sup>th</sup> to 06<sup>th</sup> December, 2017 and the Committee decided to constitute VT for conducting inspection so as to ascertain the preparedness of the institution for shifting of its premises.

AND, WHEREAS, the VTR received in the NRC office on 23.01.2018 was considered by the NRC in its 280<sup>th</sup> Meeting held from 06<sup>th</sup> to 07<sup>th</sup> February, 2018 and the Committee decided as under:-

- The institution is permitted to shift its premises from Narsingh Vihar, Ram Nagriya, Jagatpura, Jaipur to Khasra No. 955/2, Village- Muhana, Tehsil- Sanganer, Jaipur.

AND, NOW, therefore, the Northern Regional Committee hereby grants permission to Sadguru Institute for Professional Education, to shift its premises from Sadguru Campus, Shri Narsingh Vihar, Ram Nagriya, Jagatpura, District – Jaipur, Rajsthan to Khasra No. – 955/2, Village – Muhana, Tehsil – Sanganer, District – Jaipur, Rajsthan under clause 3(9) of the NCTE Regulations, 2014 for conducting B.Ed. course with an annual intake of two units of 50 students each.
