WITHDRAWAL ORDER

WHEREAS, recognition was granted to the institution namely, "Sadguru Institute of Professional Education," Sadguru Campus, Khasra No. 955/2, Village-Mohana, Tehsil-Sanganer, District- Jaipur, Rajasthan vide order No. NRC/NCTE/RJ-886/2008/56071-77 dated 12.08.2008 for B.Ed. course of one year duration with an annual intake of 100 students from the academic session 2008-2009.

2. AND WHEREAS, after promulgation of NCTE Regulations, 2014 the institution had consented to come under new Regulation by affidavit and the Revised Provisional Recognition Order (RPRO) was issued to the institution 21.04.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 student (two basic units) from the academic session 2015-2016 for compliance of certain.

3. AND WHEREAS, an E-mail from Dr. Mamta Sharma, Jaipur alleging complaint against the institution was received dated 09.11.2017. The matter was considered by NRC in its 289th meeting held on 08th to 09th October, 2018 and the Committee decided as under:

"The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by NRC and following observation was made:

Complaint be forwarded to the institution for obtaining comments."

Accordingly, a letter was issued to the institution on 23.10.2018.

4. AND WHEREAS, the institution has submitted compliance of conditions in pursuance of revised provisional recognition order vide letter dated 02.05.2018 received in NRC office dated 16.05.2018. Further, the institution has submitted a reply to a Complaint vide letter No. SIPE/B.Ed.2018/73 dated 20.11.2018, received in NRC office dated 05.12.2018.

5. AND WHEREAS, the matter was considered by WRC in its 293rd Meeting held on 17th to 19th December 2018 wherein the Committee decided as under:

"The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by NRC and the following observation was made:

The NRC-NCTE has received a complaint against the institution from Dr. Mamta Sharma. Same was considered by the Committee in 289th meeting held on 08th to 09th October, 2018 and it was decided that the complaint should be forwarded to the institution for seeking comments. Accordingly, a letter was issued on 23.10.2018 along with complaint.

The institution has submitted its reply along with a few documents to prove the complaint is completely fake. The Committee considered this issue in its meeting and decided that no further action is required."

Accordingly, a letter was issued to the institution vide NRC letter dated 14.01.2019.

A letter was received dated 07.12.2018 from complainant viz. Dr. Mamta Sharma, alleging complaint against the institution.

6. AND WHEREAS, the matter was considered by WRC in its 316th Meeting held on 27th to 28th August & 04th September, 2020 wherein Committee decided that Show Cause Notice u/s 17 of the NCTE Act, 1993 be issued to all such institutions of Rajasthan which were issued Revised Recognition orders with a direction to submit compliance to the conditions mentioned / stipulated in the Revised Recognition order issued by NRC-NCTE. Accordingly, Show Cause Notice u/S 17 was issued dated 05.12.2020 received in WRC on 09.12.2020.

7. AND WHEREAS, a verified complaint against the institution received through the Complaints Division NCTE HQrs. vide letter F. No. NCTE-C/PG011/22/2017-US(Complaints)-HQ dated 08.11.2017 followed by reminder letter F. No. NCTE/PG011/22/2017 dated 01.05.2018 and Further, confirmed complaint received vide NCTE HQrs. letter F. No. NCTE-C/PG011/22/2018-Complaint Section-HQ/125901 dated 04.07.2024 along with related documents against the institution.

8. AND WHEREAS, the matter was considered by WRC in its 410th Meeting held on 30th -31st December, 2024 and the Committee decided as below:

"The application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee decided as under:

Reply of SCN u/S 17 vide letter dated 05.12.2020 received on 09.12.2020 is to be scrutinized together with compliant against the institution and be placed in the WRC meeting."

9. AND WHEREAS, reminder-I verified complaint has been received from Complaint Division, NCTE HQrs. letter F. No. NCTE- C/PG011/22/2018-Complaint Section-HQ/128188 dated 10.02.2025.

10. AND WHEREAS, the matter was considered by WRC in its 413th Meeting held on 27th -29th January, 2025 whereas the Committee decided as under:

"The application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

The Committee considered the complaint received against the institution forwarded through NCTE Hqrs. Complaint Division letter dated 04.07.2024 along with reply of SCN u/S 17 of NCTE Act, 1993 and decided as under:

1. The copy of complaint be sent to State Government i.e. Department of Higher Education, Government of Rajasthan and Affiliating Body i.e. University of Rajasthan seeking comments on the allegations made by the Complainant in its complaint and to furnish report in this regard.
2. Final Show Cause Notice u/S 17 of NCTE Act 1993, be issued to institution to submit following documents within 15 days from the date of issue of final SCN:
 - a. The institution is required to submit latest Fire Safety Certificate issued in favour of the institution issued through online LSG portal, Government of Rajasthan.
 - b. The institution is required to submit latest/current faculty list approved & signed each page by concerned Registrar of affiliating body in original with the details of their teaching subject, date of birth, date of selection/appointment, date of joining, academic qualifications, teaching experience, NET/Ph.D. (NCTE's GoI dated 09.06.2017), salary structure and related documents duly attested by authorized representative of management along with copy of approval letter of affiliating body.
 - c. The institution is required to submit notarized original affidavit on Rs.100/- on non-judicial stamp paper by the management and Rs.10/- non-judicial stamp paper by each selected/appointed faculty in the NCTE prescribed proforma.
 - d. The institution is required to submit details of salary disbursed to the faculty along with six months Bank statement and account number of each faculty member.
 - e. The institution is required to furnish comments on the allegations made by the Complainant in its complaint supported with documentary proof.”

Accordingly, letters were issued dated 18.03.2025 to the Commissioner, Department of College Education, Government of Rajasthan and Affiliating Body, The Registrar, University of Rajasthan, and Final Show Cause Notice u/S 17 was issued to the institution.

11. AND WHEREAS, the institution letter dated 27.02.2025 has submitted reply of Final Show Cause Notice dated 18.03.2025 received in WRC office dated 10.03.2025 and 03.04.2025 along with related documents.

12. AND WHEREAS, again reminder-II received from the Complaint Division, NCTE HQrs. dated 22.04.2025. The matter was considered by WRC in its 432nd (Part-II) Meeting held on 06th – 08th August, 2025 wherein the Committee decided as under:

“The application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- i. Recognition was granted for B.Ed. Course with annual intake of 100 vide order dated 12.08.2008 followed by Revised order dated 21.04.2015 for compliance of conditions mentioned therein.
- ii. Shifting of institution from old premises to new premises bearing address: Khasra No. 955/2, Village-Mohana, Tehsil-Sanganer, District-Jaipur, Rajasthan, has been permitted vide order dated 09.02.2018.
- iii. Based on complaint received against institution, as decided by WRC in its 316th Meeting held on 27th – 28th August & 04 September, 2020, Show Cause Notice u/S 17 was issued dated 05.11.2020 of which institution submitted its reply vide letter dated 05.12.2020 received on 09.12.2020.
- iv. Based on another verified complaint received against institution, WRC in its 410th Meeting held on 30th – 31st December, 2024 decided that reply of SCN u/S 17 vide letter dated 05.12.2020 received on 09.12.2020 is to be scrutinized together with compliant against the institution and be placed in the WRC meeting.
- v. WRC in its 413th Meeting held on 27th – 29th January, 2025 considered the matter and as decided letters were issued dated 18.03.2025 to the Commissioner, Department of College Education, Government of Rajasthan and Affiliating Body i.e. Registrar, University of Rajasthan seeking comments on the allegations made by the Complainant in the complaint and to furnish report in this regard.
- vi. The institution was issued Final SCN u/S 17 dated 18.03.2025 on the following grounds:
 - a. The institution is required to submit the latest Fire Safety Certificate issued in favour of the institution issued through online LSG portal, Government of Rajasthan.
 - b. The institution is required to submit latest/current faculty list approved & signed each page by concerned Registrar of affiliating body in original with the details of their teaching subject, date of birth, date of selection/appointment, date of joining, academic qualifications, teaching experience, NET/Ph.D. (NCTE's Gol dated 09.06.2017), salary structure and related documents duly attested by authorized representative of management along with copy of approval letter of affiliating body.
 - c. The institution is required to submit notarized original affidavit on Rs.100/- on non-judicial stamp paper by the management and Rs.10/- non-judicial stamp paper by each selected/appointed faculty in the NCTE prescribed proforma.
 - d. The institution is required to submit details of salary disbursed to the faculty along with six months Bank statement and account number of each faculty member.
 - e. The institution is required to furnish comments on the allegations made by the Complainant in its complaint supported with documentary proof.”
- vii. The reply of institution vide letter dated 27.02.2025 and 29.03.2025 in response to Final SCN u/S 17 dated 18.03.2025 was considered by WRC in its 432nd (Part-II) Meeting wherein the Committee observed that the institution is still deficient on the following grounds:
 - a. The institution has not submitted Fire Safety Certificate issued by Competent Authority of Fire Safety Department, Government of Rajasthan verifiable on the official portal of the Fire Department, Government of Rajasthan at URL https://lsgonline.rajasthan.gov.in/track_application.aspx.



- b. The institution stated in its reply that approval of faculty is under process. However, the institution has not submitted the latest list of teaching staff approved and countersigned by the Registrar of affiliating body in the prescribed format of NCTE as per qualification contained in the NCTE Norms and Regulations as amended from time to time.
- c. Copy of Affiliation form 2024-25 in connection with provisional extension applied to University of Rajasthan generated on 24.02.2024 countersigned by Principal.
- d. Copy of Bank statement submitted without mentioning account details of each faculty.
- e. Documentary proof on the complaint has not been received from the institution.

In addition, the Committee observed that no response received from affiliating body i.e. Registrar, University of Rajasthan and State Government i.e. Commissioner, Department of College Education, Govt. of Rajasthan on the complaint matter.

In view of the above, the Committee decided that recognition granted to B.Ed. course be withdrawn u/S – 17 of NCTE Act, 1993 from the academic session next following the date of issue of withdrawal order with a copy to State Government, Affiliating Body and all concerned.”

13. NOW THEREFORE, in pursuance of decision of WRC and in exercise of the powers conferred under Section 17(1) of the NCTE Act, 1993, recognition granted for B.Ed. programme in respect of the institution viz. “Sadguru Institute of Professional Education, Sadguru Campus, Khasra No. 955/2, Village-Mohana, Tehsil- Sanganer, District-Jaipur, Rajasthan” is hereby withdrawn from the end of the academic session next following the date of communication of the said withdrawal order.

14. इसके अलावा, यदि संस्थान और संबद्ध निकाय को एनसीटीई अधिनियम, 1993 की धारा 17(4) के निम्नलिखित प्रावधानों के बारे में सूचित किया जाता है:-

(4) यदि कोई संस्था (1) अधिन मान्यता वापस लेने वाले आदेश के प्रवृत्त होने के पश्चात् अध्यापक शिक्षा मे कोई पाठ्यक्रम या प्रशिक्षण प्रस्थापित करती हैं तो, या जहां अध्यापक शिक्षा मे कोई पाठ्यक्रम या प्रशिक्षण प्रस्थापित करने वाली कोई संस्था नियत दिन के ठीक पूर्व अधिनियम के अधीन मान्यता या अनुज्ञा प्राप्त करने में असफल हो जाती हैं या उपेक्षा बरतती हैं वहां, ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसरण में या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण करने के पश्चात् प्राप्त अध्यापक शिक्षा में अर्हता को, केंद्रीय सरकार, किसी राज्य सरकार या विश्वविद्यालय के अधीन या केंद्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी विद्यालय, महाविद्यालय या अन्य शिक्षा निकाय में नियोजन के प्रयोजनों के लिए, विधिमान्य अर्हता नहीं मानी जाएगी।


15. Further, the institution and affiliating body are hereby informed about the following provision of Section 17(4) of NCTE Act, 1993:-

“If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government.”



16. इसके अलावा, यदि संस्थान इस आदेश से संतुष्ट नहीं हैं, तो इस आदेश की जारी होने की तिथि से 60 दिनों के भीतर एन.सी.टी.ई. अधिनियम, 1993 के धारा 18 के अंतर्गत एक अपील की जा सकती हैं जो ऑनलाइन होगी तथा एन.सी.टी.ई. की वेबसाइट www.ncte.gov.in पर उपलब्ध हैं।

17. Further, if the institution is not satisfied with the Order, it may prefer an Appeal against the aforesaid order under Section 18 of the NCTE Act, 1993 through “online mode” available on NCTE’s website www.ncte.gov.in within 60 days from the date of issue of this order. The guidelines for filing the appeal may be seen on NCTE website.
