**WITHDRAWAL ORDER**

**WHEREAS**, recognition was granted to the institution namely, “**Dr. B.R. Ambedkar P.G. College**”, **Vill-Jaipur, Street-60 Feet Road Mahesh Nagar, Taluka-Jaipur, Town-Jaipur, Dist.-Jaipur, Rajasthan-302015** for **B.A. B.Ed./B.Sc. B.Ed.** programme with an annual intake of 100 students (two units of 50 students each) vide Order No. WRC/NRCAPP-16497/B.A.B.Ed./ B.Sc.B.Ed./345<sup>th</sup> Meeting/2021/218309-218315 and 218384 dated 24.11.2021.

**2. AND WHEREAS**, the matter was considered by WRC in its 380<sup>th</sup> Meeting held on 10<sup>th</sup> February 2023 and the Committee decided as under:

*“The original file of the Institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:*

- The institution applied on 30.06.2016 seeking grant of recognition for B.A.B.Ed./B.Sc.B.Ed. course and hard copy received on 04.07.2016.
- Inspection was conducted on 29<sup>th</sup>-30<sup>th</sup> July, 2019.
- Letter of Intent prior to grant of recognition under Clause 7(13) of NCTE Regulations, 2014 issued dated 05.12.2020.
- Recognition was granted for B.A.B.Ed./B.Sc.B.Ed. course with intake of 100 from the academic session 2022-2023 vide order dated 24.11.2021.

Further, it has been noted that the National Council for Teacher Education (Recognition Norms and Procedure) Amendment Regulations, 2021 dated 26.10.2021, Appendix-13 that lays down the norms and standards for B.A.B.Ed./B.Sc.B.Ed. has been omitted. Due to administrative oversight, the institution was granted recognition for B.A.B.Ed./B.Sc. B.Ed. course erroneously by WRC.

*In view of the above, the Committee decided that a Show Cause Notice prior to the withdrawal of recognition be issued to the institution u/s 17 of the NCTE Act. The institution shall submit a reply accompanied by an original affidavit within 30 days from the date of uploading of minutes on the website failing which the WRC will take a decision as deemed fit as per the provisions contained in the NCTE Act and Regulations. A copy of show cause notice be endorsed to the State Government and Affiliating Body.”*

**3. AND WHEREAS**, the institution has not submitted any reply of Show Cause Notice as per decision of WRC 380<sup>th</sup> Meeting. The matter was considered by WRC in its 383<sup>rd</sup> Meeting held on 20<sup>th</sup> -21<sup>st</sup> April 2023 and the Committee decided as under:

"The original file of the institution alongwith other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

**(i) The matter was placed in the 380<sup>th</sup> meeting of WRC held on 10<sup>th</sup> February, 2023 and Committee made following observations:**

- The institution applied on 30.06.2016 seeking grant of recognition for B.A.B.Ed./B.Sc.B.Ed. course and hard copy received on 04.07.2016.
- Inspection was conducted on 29<sup>th</sup>-30<sup>th</sup> July, 2019.
- Letter of Intent prior to grant of recognition under Clause 7(13) of NCTE Regulations, 2014 issued dated 05.12.2020.
- Recognition was granted for B.A.B.Ed./B.Sc.B.Ed. course with intake of 100 from the academic session 2022-2023 vide order dated 24.11.2021.

Further, it has been noted that the National Council for Teacher Education (Recognition Norms and Procedure) Amendment Regulations, 2021 dated 26.10.2021, Appendix-13 that lays down the norms and standards for B.A.B.Ed./B.Sc.B.Ed. has been omitted. Due to administrative oversight, the institution was granted recognition for B.A.B.Ed./B.Sc. B.Ed. course erroneously by WRC.

In view of the above, the Committee decided that a Show Cause Notice prior to the withdrawal of recognition be issued to the institution u/s 17 of the NCTE Act. The institution shall submit a reply accompanied by an original affidavit within 30 days from the date of uploading of minutes on the website failing which the WRC will take a decision as deemed fit as per the provisions contained in the NCTE Act and Regulations. A copy of show cause notice be endorsed to the State Government and Affiliating Body."

**(ii) The period of 30 days from the date of uploading of minutes of 380<sup>th</sup> meeting of WRC has been completed on 22.03.2023, but the institution has not submitted any reply to WRC, NCTE.**


In view of the above, the Committee decided that final show cause notice prior to withdrawal of recognition be issued to the institution u/s 17 of the NCTE Act. The institution shall submit a reply accompanied by an original affidavit within 7 days from the date of uploading of minutes on the website failing which the WRC will take a decision as deemed fit as per the provisions contained in the NCTE Act and Regulations. A copy of show cause notice be endorsed to the State Government and Affiliating Body. The final show cause notice shall be issued to the institution."

4. AND WHEREAS, Final Show Cause Notice u/S 17 of NCTE Act, 1993 was issued to the institution dated 09.05.2023. The institution has not submitted any reply in respect of Final Show Cause Notice.

5. The institution has filed Writ Petition in W.P. (C) 8683/2023 & CM APPL No. 32874/2023 before Hon'ble High Court of Delhi at New Delhi and Hon'ble court passed order dated 03.07.2023, the operative part of order is as under:-

"...4. Learned counsel appearing on behalf of the petitioner states that this court in W.P. (C) 893/2023 and another W.P. (C) 894/2023 stayed the operation of the impugned minutes in those writ petitions. According to him, the issue involved in this writ petition is similar to the aforesaid writ petitions and, therefore, he prays for similar order to be passed in this writ petition also.

5. Having considered the submissions made by learned counsel appearing on behalf of the petitioner, subject to hearing the respondents, there shall be stay of the impugned show-cause notice dated 06.05.2023 so far as it relates to the petitioner.



6. List on 12.09.2023 alongwith W.P. (C) 893/2023 and W.P. (C) 894/2023.

7. In the meantime, the respondents are directed to file the reply."

6. Again, the institution has filed Writ Petition and Hon'ble High Court of Delhi at New Delhi in W.P. (C) 893/2023 and CM APPL. 3464/2023 dated 29.11.2024 has directed the following:

"...5. Learned counsel appearing for the respondents vehemently opposes the submissions and submits that these writ petitions are not maintainable since they have filed only against the decision to issue the show cause notice. She, further submits that the petitions are premature and the petitioners should file their reply once the notices are issued to them. Learned counsel also justified the decision to issue show cause notice on various grounds, as can be seen from their counter affidavit.

6. I have considered the submissions made by learned counsel appearing for the parties and have perused the record.

7. One of the writ petitions i.e. W.P.(C) 893/2023 was taken up for hearing on 24.01.2023 and the Court, while considering the submissions made by the petitioners, issued notices to the respondents and subject to hearing the respondents, the operation of the impugned minutes of the meeting/decision was stayed.

8. It is thus seen, as on date, on the basis of minutes of the meeting dated 27.12.2022, no formal show cause notices have been issued by the respondents. Generally, writ petitions against the decision to issue show cause notice are not entertained unless the decision itself is evidently shown to be without jurisdiction. However, under the facts of the present case, the submissions are not solely rested on the decision being sans jurisdiction but the same is being assailed on the anvil of it being arbitrary as well. In any case, the petitioners shall have full opportunity to submit a detailed reply including challenging the impugned decision on the ground of it being without jurisdiction.

9. The Court, therefore, is of the considered opinion that the petitioners need to submit a detailed reply to the respondents explaining all reasons as to why the show cause notices ought not to have been issued to them and why no action can be taken against the petitioners.

10. Needless to state, if such a reply is submitted by the petitioners, there is no doubt that the same shall be considered appropriately by the respondents. The respondents, however, are directed to deal with the reply proposed to be submitted by the petitioners with utmost objectivity.

11. Since the Court has already passed an interim order dated 24.01.2023 and the matters remain pending for almost two years, the interest of justice would be better served if the interim order is made absolute awaiting the decision to be taken by the respondents, pursuant to the show cause notice and the reply to be submitted by the petitioners.

12. The instant petitions stand disposed of, along with pending applications, with the following directions:

- i. The decision dated 27.12.2022, shall, itself be considered to be the show cause notice.
- ii. The petitioners are directed to submit a detailed reply within a period of three weeks from the date of passing of this order, along with all necessary documents.
- iii. The respondents, thereafter, to consider their reply and to take a final decision with due expedition. If the decision is adverse to the petitioners, the same shall not be given effect for a period of 45 days therefrom.

13. All rights and contentions are left open."

7. **AND WHEREAS**, the institution has not submitted any reply of Final Show Cause Notice in reference to court order dated 29.11.2024 and the matter was considered by WRC in its 413<sup>th</sup> Meeting held on 27<sup>th</sup> -29<sup>th</sup> January 2025 (as reflected in the rectification Minutes of 413th WRC meeting), the Committee decided as under:

*"The application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:*

*Recognition was granted to the institution for B.A.B.Ed./B.Sc.B.Ed. course vide order No. F.WRC/NRCAPP-16497/B.A.B.Ed., B.Sc.B.Ed./345<sup>th</sup> Meeting/2021/218309-218315 and F.No.NCTE=Regl011/80/2018-MS(Regulation)-HQ dated 22.11.2021.*

*Matter was considered by WRC in its 380<sup>th</sup> Meeting held on 10<sup>th</sup> February, 2023, wherein the Committee decided that Show Cause Notice be issued to the institution for submission of its reply within 30 days from the date of Minutes uploaded on NCTE website on 17.02.2023 on the following grounds mentioned therein:*

*The institution has not submitted any reply in response to SCN on the basis of uploaded Minutes of WRC on 17.02.2023. Stipulated time period has already been over.*

*Subsequently, matter was considered by WRC in its 383<sup>rd</sup> meeting held on 20<sup>th</sup> -21<sup>st</sup> April, 2023. As per decision taken by Committee, Final Show Cause Notice dated 09.05.2023 was issued to the institution giving 07 days' time for reply on the following grounds:*

*The period of 30 days from the date of uploading of minutes of 380th meeting of WRC has been completed on 22.03.2023, but the institution has not submitted any reply to WRC, NCTE.*

*Stipulated time period has already been over. No reply to final Show Cause Notice submitted by the institution.*

*The institution filed Writ Petition No. 8683/2023 titled as Dr. B.R. Ambedkar P.G. College versus National Council for Teacher Education and Anr. against the decision of WRC before the Hon'ble High Court of Delhi in which the Hon'ble Court disposed off the case vide order dated 29.11.2024 in connected case W.P. (C) 893/2023 and CM APPL 3464/2023 passed by Hon'ble High Court of Delhi with the following relevant part of the order:*

*The instant petitions stand disposed of, along with pending applications, with the following directions:*

- i. *The decision dated 27.12.2022, shall, itself be considered to be the show cause notice.*
- ii. *The petitioners are directed to submit a detailed reply within a period of three weeks from the date of passing of this order, along with all necessary documents.*
- iii. *The respondents, thereafter, to consider their reply and to take a final decision with due expedition. If the decision is adverse to the petitioners, the same shall not be given effect for a period of 45 days therefrom."*

*In consideration of the above facts, the Committee decided that recognition granted for B.A. B.Ed./B.Sc. B.Ed. course to the institution be withdrawn u/S 17 of the NCTE Act, 1993 from the academic session next following the date of issue of withdrawal order with a copy to State Government, Affiliating Body and all concerned."*

Accordingly, withdrawal Order was issued to the institution dated 26.03.2025.



8. **AND WHEREAS**, a copy of vide letter dated 11.08.2025 was received on 18.08.2025 from the institution alongwith an affidavit enclosing a copy of court order dated 30.07.2025 is filed a W.P (C ) 4229/2025 in the Hon'ble High Court of Delhi at New Delhi, the operative part of Order is as under:

*“...17. Accordingly, the impugned decision taken by the respondent no.2/WRC in its 413<sup>th</sup> meeting held on 27<sup>th</sup> -29<sup>th</sup> January, 2025 and consequential final order of withdrawal of recognition is set aside. Resultantly, the petitioner is granted two weeks' time from today to file its reply to the show cause notice dated 09.05.2023.*

*18. The respondents are directed to take all necessary consequential steps to consider reply of the petitioner and take a final decision expeditiously, preferably within a period of two weeks thereafter.*

*19. Needless to say, that this order has been passed in the peculiar facts and circumstances of the present case.*

*20. The petition stands disposed of in the above terms.*

*21. The next date of hearing i.e. 16.10.2025 stands cancelled.”*

9. **AND WHEREAS**, the matter was considered by WRC in its 433<sup>rd</sup> (Part-1) Meeting held on 18<sup>th</sup> – 20<sup>th</sup> August, 2025 wherein the Committee decided as under:

*“The original file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, order dated 30.07.2025 passed by Hon'ble High Court of Delhi in W.P.(C) 4229/2025 along with representation vide letter dated 11.08.2025 submitted by the institution and the Committee observed as under:*

- i. *In pursuance of Order dated 30.07.2025 passed by the Hon'ble High Court of Delhi W.P (C) 4229/2025, petitioner submitted representation vide letter dated 11.08.2025 received on 18.08.2025.*
- ii. *NCTE vide Notification F.No.NCTE-Regl011/80/2018-MS(Regulation)-HQ dated 22.10.2021 has notified the National Council for Teacher Education (Recognition, Norms and Procedure) Amendment Regulations, 2021. As mentioned at point 5(i) of said Regulations, “**In the Principal Regulations,- Appendix-13 shall be omitted**” and at point 5 (ii) of said Regulations, it is mentioned “**Appendix 14 and 15 shall be renumbered as Appendix-13 and Appendix-14 and after Appendix-13 and Appendix-14 as so renumbered the following Appendix shall be inserted, namely:-***

*Norms and Standards for Integrated Teacher Education Programme (ITEP)- Appendix-15”.*

- iii. *After promulgation of National Council for Teacher Education (Recognition, Norms and Procedure) Amendment Regulations, 2021 dated 22.10.2021 and omission of Norms and Standards for B.A. B.Ed./B.Sc. B.Ed. 4 Year Integrated programme (Appendix-13), the said Norms and Standards for B.A. B.Ed./B.Sc. B.Ed. 4 Year Integrated programme (Appendix-13) is no more in force.*

- iv. *Recognition was granted erroneously for B.A. B.Ed./B.Sc. B.Ed. 4 Year Integrated programme by WRC, NCTE vide Order dated 24.11.2021, even after omission of Appendix-13 published vide NCTE's Notification F.No.NCTE-Regl011/80/2018-MS(Regulation)-HQ dated 22.10.2021, and the recognition for B.A. B.Ed./B.Sc. B.Ed. 4 Year Integrated programme was withdrawn by WRC, NCTE vide Order F.No.WRC/NCTE/CF-58825/NRCAPP-2016-16497-B.A.B.Ed./B.Sc.B.Ed./ 413<sup>th</sup> Meeting/2025/477-484 dated 26.03.2025 after due consideration by the Western Regional Committee.*
- v. *After omission of Appendix-13 (Norms and Standards for 4 year Integrated B.A.B.Ed./B.Sc.B.Ed. programme), the Western Regional Committee is not empowered to consider and take decision in respect of any institution for grant of recognition/ permission to B.A. B.Ed./B.Sc. B.Ed. 4 Year Integrated programme.*

*In view of the above, and in pursuance of order dated 30.07.2025 of Hon'ble High Court of Delhi, the Committee decided to reaffirm its earlier decision of withdrawal of recognition for B.A. B.Ed./B.Sc. B.Ed. 4 Year Integrated programme issued vide Order dated 26.03.2025. The institution and all concerned be informed accordingly."*


8. **NOW THEREFORE**, the institution is hereby informed that earlier decision of withdrawal u/S 17 of NCTE Act, 1993 issued vide order dated 26.03.2025 for B.A. B.Ed./B.Sc. B.Ed. 4 Year Integrated programme still stands and the same shall remain unchanged.

9. इसके अलावा, यदि संस्थान और संबद्ध निकाय को एनसीटीई अधिनियम, 1993 की धारा 17(4) के निम्नलिखित प्रावधानों के बारे में सूचित किया जाता है:-

(4) यदि कोई संस्था (1) के अधीन मान्यता वापस लेने वाले आदेश के प्रवृत्त होने के पश्चात अध्यापक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रस्थापित करती है तो, या जहां अध्यापक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रस्थापित करने वाली कोई संस्था नियत दिन के ठीक पूर्व अधिनियम के अधीन मान्यता या अनुज्ञा प्राप्त करने में असफल हो जाती है या उपेक्षा बरतती है वहां, ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसरण में या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण करने के पश्चात प्राप्त अध्यापक शिक्षा में अहृता को, केन्द्रीय सरकार, किसी राज्य सरकार या विश्वविद्यालय के अधीन या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी विद्यालय, महाविद्यालय या अन्य शिक्षा निकाय में नियोजन के लिए, विधिमान्य अहृता नहीं मानी जाएगी।

10. Further, the institution and affiliating body are hereby informed about the following provision of Section 17(4) of NCTE Act, 1993:-

*"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government."*



11. इसके अलावा, यदि संस्थान इस आदेश से संतुष्ट नहीं है, तो इस आदेश की जारी होने की तिथि से 60 दिनों के भीतर एन.सी.टी.ई अधिनियम, 1993 के धारा 18 के अंतर्गत एक अपील की जा सकती है जो ऑनलाइन होगी तथा एन.सी.टी.ई की वेबसाइट [www.ncte.gov.in](http://www.ncte.gov.in) पर उपलब्ध है।

12. Further, if the institution is not satisfied with the Order, it may prefer an Appeal against the aforesaid order under Section 18 of the NCTE Act, 1993 through “online mode” available on NCTE’s website [www.ncte.gov.in](http://www.ncte.gov.in) within 60 days from the date of issue of this order. The guidelines for filing the appeal may be seen on NCTE website
