RESTORATION ORDER

WHEREAS Recognition was granted to the institution namely: Women Teacher Training College, Veer Durga Das Nagar, Pali, Rajasthan vide Order dt.13.06.2009 for B.Ed. Course with an annual intake of 100 student from the academic session 2006-2007.

2. AND WHEREAS, Corrigendum Order dt 15.06.2009 issued to the institution mentioning that "Women Teacher Training College, Veer Durga Das Nagar, Pali, Rajasthan may be read as "Smt. Rukma Devi Mahila Shikshan Prashikshan Mahavidyalay," Veer Durga Das Nagar, Pali, Rajasthan

3. AND WHEREAS, Revised Recognition vide Order dt. 12.06.2015 was issued to the institution namely Smt. Rukma Devi Mahila Shikshan Prashikshan Mahavidyalay, Veer Durga Das Nagar, Pali, Rajasthan for conducting B.Ed. course with an annual intake of 100 students from the academic session 2015-2016.

4. AND WHEREAS, the matter was placed in the 321<sup>st</sup> meeting of WRC held on 09-11<sup>th</sup> November, 2020 and the Committee decided to issue withdrawal Order to the institution.

5. AND WHEREAS, Withdrawal Order was issued to the institution on 14.12.2020.

6. AND WHEREAS, Institution filed an appeal before the Appellate Authority at NCTE, New Delhi against the aforesaid withdrawal order and the Appellate Authority vide order dated 02.06.2021 decided as follows:

"AND WHEREAS Appeal Committee noted that impugned order of withdrawal dated 14.12.2020 is on the ground that appellant institution has not submitted reply to the Show Cause Notice dated 27.09.2020 which was issued for the reason that institution was granted recognition in rented premises and has not shifted to its own premises. Appellant in its appeal memoranda has stated that institution is running in its own premises since the very beginning and has also replied to the Show Cause Notice dated 27.09.2020. As evidence of having submitted reply to the Show Cause Notice the appellant has furnished copy of the speed post receipt dated 20.11.2020 and track report which indicates delivery of article on 29.10.2020.

7. **AND WHEREAS** Appeal Committee decided to remand back the case to WRC to consider the reply of appellant institution which is required to be sent again by the appellant to WRC within 15 days of the issue of appeal order.

NOW THEREFORE, the Council hereby remands back the case of Smt. Rukma Devi Mahila Shikshak Prashikshan Mahavidyalaya, Veer Durga Das Nagar, Pali, Rajasthan to the WRC, NCTE, for necessary action as indicated above.”

The above decision is being communicated on behalf of Appeal Committee.

8. **AND WHEREAS**, The matter was placed in the 321<sup>st</sup> meeting of WRC held on 09<sup>th</sup>-11<sup>th</sup> November 2020 and the committee decided that the recognition of B.Ed programme of the institution be WITHDRAWN under Clause 7(15) from the next academic session 2021-21.”

9. **AND WHEREAS**, Withdrawal Order was issued to the institution on 14.08.2021.

10. **AND WHEREAS**, The Institution has filed a W.P. No. 10018/2021 in the hon'ble High Court of Delhi at New Delhi Order dt.10.09.2021 operative part of Order is as under:

“As the withdrawal order has been passed only in August 2021, the consequence under the second proviso to Section 17 (1) if the Act is that it would take effect from the end of the academic year next following the academic year in which the order is passed. There is, therefore, no impediment in the petitioned participating in the counselling and admitting students for the academic year 2021-22.

The WRC is directed to correct status of the petitioner on its website and also communicate the same to the affiliating University of the petitioner and the concerned State Government, within one week from today.”

The petition, along with the pending application, is disposed of with these directions.”

11. **AND WHEREAS**, in compliance of the Court Order a Counselling Permission letter on 05.10.2021 and a corrigendum dt.05.10.2021 was issued to the institution.

12. **AND WHEREAS**, Representation dt.16.09.2021 Received from the institution for the Continuation of the recognition.

13. **AND WHEREAS**, Institution filed an appeal before the Appellate Authority at NCTE, New Delhi against the aforesaid withdrawal order and the Appellate Authority vide order dated 31.08.2023 decided as follows:

‘After perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the online hearing, Appeal Committee of the Council concluded to remand back the case to WRC with a direction to constitute Visiting Team as per provisions of the NCTE Act, Rules & Regulations to verify the infrastructural and instructional facilities available with the institution and further

to verify the documents submitted from the concerned issuing authority submitted in appeal which are required to be sent to them by appellant institution and take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time. The Appellant is directed to forward to the WRC the documents submitted in appeal within 15 days from the receipt of order of the Appeal.

14. **AND WHEREAS**, the matter was again considered by the WRC in its 394<sup>th</sup> meeting held on 15<sup>th</sup> September, 2023 and Committee has decided the following:-


"In Compliance of Order dated 31.08.2023 of the Appellate Committee, the WRC decided as follows:

- i) Restoration order for B.Ed. Course be issued subject to further consideration of WRC.
- ii) VT be constituted under section 12 of the NCTE Sct, 1993 for inspection of the institution to check the Infrastructural and instructional facilities available in the institution and facilities and documents etc.
- iii) Institution be directed to submit documents within 15 days in compliance of appeal order dated 31.08.2023.  
Orders/letters be issued accordingly and be uploaded on NCTE website."

15. **NOW THEREFORE**, in compliance of the decision of WRC recognition of the institution viz. Smt. Rukma Devi Mahila Shikshan Prashikshan Mahavidyalay, Veer Durga Das Nagar, Pali, Rajasthan for conducting B.Ed. programme of two years duration with an annual intake of 100 students (Two units) is hereby restored subject to further consideration by WRC.

16. A letter for seeking documents in compliance of appeal order, is being issued separately.
