WITHDRAWAL ORDER

WHEREAS, recognition was granted to the institution namely, “Shri Guru Govind Singh Khalsa Shishan Sansthan Shir Karanpur,” Village- CHAK-13 O, Tehsil/Taluka-46 F Moura, Street/Road- Shri Ganganagar Road, District- Ganganagar-335073, Rajasthan for conducting B.Ed. programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-2016 vide Order No. F.No.NRC/NCTE/NRCAPP-2016-15218/Recognition/B.A. B.Ed./BSc. B.Ed./276th Meeting/183995-4000 dated 03.01.2017.

2. AND WHEREAS, a complaint received from complainer dated 11.04.2023. received in the WRC section on 21.04.2023 and again, complaint received from complainer dated 17.09.2022 received in WRC office dated 19.12.2023.

3. AND WHEREAS, the institution has submitted for application vide letter No. ggsk/285/2024 dated 24.07.2024 receive in WRC office on 29.07.2024 with Demand Draft amount Rs. 1,50,000/- and again submitted application for shifting vide letter No. ggsk/301/2025 dated 12.02.2025, wherein requesting for shifting of the premises from “Village- CHAK-13 O, Tehsil/Taluka-46 F Moura, Street/Road- Shri Ganganagar Road, District- Ganganagar-335073, Rajasthan to CHAK-44 F, Mu. No. 15, Kila No. 11, 12, Tehsil- Shri Karanpur, District- Sri Ganganagar, Rajasthan.

4. AND WHEREAS, a letter was issued to the institution for return of Demand Draft and submitted new Demand Draft of Rs. 1,77,000/- dated 11.04.2025.

5. AND WHEREAS, a verified confirmed complaint has been received from the Complaint Division NCTE vide letter F.No. NCTE-C/PG012/94/2024-ComplaintsSection-HQ/Computer No. 86047/128544 dated 03.03.2025 received WRC dated 08.03.2025.

6. AND WHEREAS, the matter was considered by WRC in its 421st Meeting held on 05th – 07th May 2025, wherein the Committee decided as under:-

“The application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- The institution is required to submit the following documents in respect of its land and building located in its existing premises wherein recognition to B.Ed. course was granted by NCTE and copy of the verified complaint letter shall be sent to the institution for point-wise reply in this regard.

- ii. *The institution is required to upload Building Plan approved by the Competent Authority of State Government indicating the Khasra/Plot/Survey No. and mentioning the total land and built-up area earmarked for each course being run in the premises and the demarcated land and built-up area for the teacher education programmes.*
- iii. *The institution is required to upload the latest list of teaching staff countersigned by the Registrar of affiliating body as per qualification contained in the NCTE Norms and Regulations as amended from time to time.*
- iv. *The institution is required to upload the bank statement of last six months indicating the transaction of the salary / remuneration to its teaching staff appointed for various courses separately.*
- v. *The institution is required to upload the latest list/details of students admitted for all recognized courses.*
- vi. *The institution is required to upload Fire Safety Certificate issued by Fire Safety Department, Government of Rajasthan verifiable on the official portal of the Fire Department, Government of Rajasthan at URL https://lsgonline.rajasthan.gov.in/track_application.aspx*
- vii. *The institution is required to upload latest Non-Encumbrance Certificate issued by Competent Authority of State Government.*
- viii. *The institution is required to upload Mutation Certificate and certified land documents issued by Competent Authority of State Government.*
- ix. *The institution is required to upload Building Safety Certificate in adherence of safety guidelines as prescribed by National/State Disaster Management Authority issued by Competent Government Authority.*
- x. *The institution is required to upload latest Building Completion Certificate in the prescribed format of NCTE (17 points) issued by the Competent Government Authority for all the courses being conducted in the premises.*
- xi. *The institution is required to upload Land Use Certificate mentioning all Khasra Nos. issued by Competent Government Authority.*
- xii. *The website of institution has NOT been updated and maintained in compliance to provisions under Clause 7(14)(i), 8(6), 8(14) and 10(3) of NCTE Regulations, 2014 as amended from time to time.*

Show Cause Notice u/s 17 (1) of NCTE Act 1993, be issued with direction to submit reply supported with an affidavit within 21 days from the date of issue of notice.

2. Further, Committee observed that the application for shifting of premises received vide letter dated 24.07.2024 and 12.02.2025 has been returned vide WRC letter dated 11.04.2025 along with original demand draft. The institution has not deposited the application processing fee for shifting of premises. Hence, Committee decided that shifting application of institution is not considerable at this stage"

Accordingly, Show Cause Notice was issued to the institution dated 24.07.2025 and the letter was issued to the institution dated 23.07.2025.

7. **AND WHEREAS**, again a verified complainer has been received from the Complaint Division NCTE vide letter dated 16.05.2025 received WRC dated 23.05.2025.

8. **AND WHEREAS**, the institution has submitted reply dated 12.08.2025 and In addition this is submitted that a copy of E.mail received by hand received on 21.08.2025 by RD, WRC along with copy of representation submitted by Advocate Dr. Sunita Sharma, Rajasthan High Court, Jaipur Bench addressed to Chairman, WRC with request for closure of forged B.Ed. Institution and stoppage of admissions for Session 2025-26 as intimated by State Government through Commissioner, College Education, which has already cancelled N.O.C. of Composite Institution.

9. **AND WHEREAS**, the matter was considered by WRC in its 434th Meeting held on 28th -30th August 2025 wherein the Committee decided as under:

"The file/related records of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

1. Recognition was granted for B.Ed. course with annual intake of 100 (two basic unit) vide Order dated 03.11.2017.
2. On consideration of verified complaint against the institution, as decided by WRC in its 421st Meeting held on 05th – 07th May, 2025, Show Cause Notice u/S 17(1) dated 24.07.2025 was issued to the institution on the following grounds:
 - i. The institution is required to submit the following documents in respect of its land and building located in its existing premises wherein recognition to B.Ed. course was granted by NCTE and copy of the verified complaint letter shall be sent to the institution for point-wise reply in this regard.
 - ii. The institution is required to upload Building Plan approved by the Competent Authority of State Government indicating the Khasra/Plot/Survey No. and mentioning the total land and built-up area earmarked for each course being run in the premises and the demarcated land and built-up area for the teacher education programmes.
 - iii. The institution is required to upload the latest list of teaching staff countersigned by the Registrar of affiliating body as per qualification contained in the NCTE Norms and Regulations as amended from time to time.
 - iv. The institution is required to upload the bank statement of last six months indicating the transaction of the salary / remuneration to its teaching staff appointed for various courses separately.
 - v. The institution is required to upload the latest list/details of students admitted for all recognized courses.
 - vi. The institution is required to upload Fire Safety Certificate issued by Fire Safety Department, Government of Rajasthan verifiable on the official portal of the Fire Department, Government of Rajasthan at URL https://lsgonline.rajasthan.gov.in/track_application.aspx
 - vii. The institution is required to upload latest Non-Encumbrance Certificate issued by Competent Authority of State Government.
 - viii. The institution is required to upload Mutation Certificate and certified land documents issued by Competent Authority of State Government.
 - ix. The institution is required to upload Building Safety Certificate in adherence of safety guidelines as prescribed by National/State Disaster Management Authority issued by Competent Government Authority.

- x. *The institution is required to upload latest Building Completion Certificate in the prescribed format of NCTE (17 points) issued by the Competent Government Authority for all the courses being conducted in the premises.*
 - xi. *The institution is required to upload Land Use Certificate mentioning all Khasra Nos. issued by Competent Government Authority.*
 - xii. *The website of institution has NOT been updated and maintained in compliance to provisions under Clause 7(14)(i), 8(6), 8(14) and 10(3) of NCTE Regulations, 2014 as amended from time to time.*
3. *Reply submitted vide letter dated 12.08.2025 by the institution. The institution is still deficient on the following grounds:*
- i. *Building plan for Khasra/Plot/Survey No. Killa No. 11/1/0.2050 & 12/2/0.2500 Murba No. 15 Chak 44FF is not approved by the Competent Authority of State Government, wherein not reflected total land area and built-up area earmarked for each course being run in the premises and the demarcated land area and built-up area for the teacher education programmes.*
 - ii. *List of teaching staff is not countersigned by the Registrar of affiliating body.*
 - iii. *Self-issued letter against Fire Safety Certificate dated 24.05.2025 submitted instead of Fire Safety Certificate issued by Fire Safety Department, Government of Rajasthan verifiable on the official portal of the Fire Department, Government of Rajasthan at URL https://lsgonline.rajasthan.gov.in/track_application.aspx*
 - iv. *Self-issued letter for Non-Encumbrance Certificate issued by Principal dated 24.05.2025 submitted instead of latest Non-Encumbrance Certificate issued by Competent Authority of State Government.*
 - v. *Self-issued letter for Building Safety Certificate issued by Principal dated 24.05.2025 submitted instead of Building Safety Certificate in adherence of safety guidelines as prescribed by National/State Disaster Management Authority issued by Competent Government Authority.*
 - vi. *BCC is not approved by the by Competent Authority of State Government. Total built-up area floor wise, information regarding approval of CLU by Competent Authority of State Government is also not reflected in BCC.*
 - vii. *The website of institution has NOT been found operational for cross-checking information in compliance to provisions under Clause 7(14)(i), 8(6), 8(14) and 10(3) of NCTE Regulations, 2014 as amended from time to time.*

Further, the Committee noted that the State Government of Rajasthan has lodged FIR against the institution dated 24.08.2022 and after enquiry by the Competent Authority of State Government of Rajasthan, it was found that the institution has made forgery related to land document shown for B.A. course which was submitted for B.Ed. course. Accordingly, deficiencies communicated vide order dated 22.07.2024 cancelling the NOC by the State Government in respect of institution together with notice issued on 22.07.2024 to the institution with deficiencies for B.Ed. course.

In view of the above, the Committee decided that recognition granted to B.Ed. course be withdrawn u/S - 17 of NCTE Act, 1993 from the academic session next following the date of issue of withdrawal order with a copy to State Government, Affiliating Body and all concerned.

Further, it is stated that since B.Ed. course of the institution has been decided as withdrawn, the documents along with fee for shifting of premises, if any submitted by the institution shall not be considered and returned to the concerned institution."

13. **NOW THEREFORE**, in exercise of the powers conferred under Section 17(1) of the NCTE Act, 1993, recognition granted for **B.Ed. programme** in respect of the institution viz. "**Shri Guru Govind Singh Khalsha Shishan Sansthan Shir Karanpur,**" Village- **CHAK-13 O, Tehsil/Taluka-46 F Moura, Street/Road- Shri Ganganagar Road, District- Ganganagar-335073, Rajasthan** is hereby withdrawn from the end of the academic session next following the date of communication of the said withdrawal order.

14. इसके अलावा, यदि संस्थान और संबद्ध निकाय को एनसीटीई अधिनियम, 1993 की धारा 17(4) के निम्नलिखित प्रावधानों के बारे में सूचित किया जाता है:-

(4) यदि कोई संस्था (1) के अधीन मान्यता वापस लेने वाले आदेश के प्रवृत्त होने के पश्चात अध्यापक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रस्थापित करती है तो, या जहां अध्यापक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रस्थापित करने वाली कोई संस्था नियत दिन के ठीक पूर्व अधिनियम के अधीन मान्यता या अनुज्ञा प्राप्त करने में असफल हो जाती है या उपेक्षा बरतती है वहां, ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसरण में या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण करने के पश्चात प्राप्त अध्यापक शिक्षा में अर्हता को, केन्द्रीय सरकार, किसी राज्य सरकार या विश्वविद्यालय के अधीन या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी विद्यालय, महाविद्यालय या अन्य शिक्षा निकाय में नियोजन के प्रयोजनों के लिए, विधिमान्य अर्हता नहीं मानी जाएगी।

15. Further, the institution and affiliating body are hereby informed about the following provision of Section 17(4) of NCTE Act, 1993:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government."

16. इसके अलावा, यदि संस्थान इस आदेश से संतुष्ट नहीं है, तो इस आदेश की जारी होने की तिथि से 60 दिनों के भीतर एन.सी.टी.ई अधिनियम, 1993 के धारा 18 के अंतर्गत एक अपील की जा सकती है जो ऑनलाइन होगी तथा एन.सी.टी.ई की वेबसाइट www.ncte.gov.in पर उपलब्ध है।

17. Further, if the institution is not satisfied with the Order, it may prefer an Appeal against the aforesaid order under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of issue of this order. The guidelines for filing the appeal may be seen on NCTE website.
