CONTINUATION ORDER

WHEREAS, the institution, namely, Late Shri Bhagwan Singh Sharma Shiksha Prasar Samiti, IITS College, Near Gaushala, Mahaveerpura, A.B. Road, Guna 4, Madhya Pradesh was granted recognition by WRC, NCTE for B.Ed. course of one year duration with an annual intake of 100 vide order No. WRC/2-32/223252/74/2005/4932 & WRC/2-32/223252/74/2005/4931 dated 27.06.2005 followed by corrigendum No.WRC/2-32/2008/30670-30676 dated 14/16.03.2008.

- 2. **AND WHEREAS**, after promulgation of NCTE Regulations, 2014, the revised recognition order was issued to the institution viz. IITS College, Late Shri Bhagwan Singh Sharma Shiksha Prasar Samiti, Near Gaushala, Mahaveerpura, A.B. Road, Guna, Madhya Pradesh vide order No.WRC/APW01565/223252/2015/147857-859 dated 31.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-2016.
- 3. AND WHEREAS, the institution filed W.P. (C) 6286/2019 and Hon'ble High Court of Delhi at New Delhi passed order dated 29.05.2019 granting ad-interim stay of the operation of the impugned decision to withdraw the petitioner's recognition. The Hon'ble Court vide order dated 07.05.2021 decided "the interim order dated 209.05.2019 will continue to bind the parties during the pendency of the writ petition." The court decided the matter vide order dated 27.04.2023 and set aside the impugned order dated 11.04.2019 and directed that restoration order be issued by the WRC. The Court also granted liberty to the NCTE to reinspect the petitioner's institution u/s 13 of the NCTE Act and if necessitated point out the deficiencies and if need arises may take an appropriate action in accordance with law.
- 4. AND WHEREAS, in compliance of direction of Hon'ble Court, recognition of IITS College for B.Ed. Programme of two years duration with an annual intake of 100 (two basic units of 50 each) is hereby restored on 01.06.2023.
- 5. AND WHEREAS, matter was placed in 387th meeting of WRC held on 09th & 10th June, 2023 and Committee decided that issue Show Cause Notice to the institution. Accordingly, Show Cause Notice issued to the institution on 28.06.2023 and institution has submitted reply of Show Cause Notice on 01.08.2023.
- 6. **AND WHEREAS,** matter was again placed in 391st meeting of WRC held on 03rd-04th August, 2023 and Committee decided as under:

"The original file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:-

- In compliance of order passed by the Hon'ble High Court of Delhi, the recognition restoration order has been issued to the institution on dated 01/06/2023.
- As per decision of WRC, the show cause notice dated 28/06/2023 was also issued to the institution.
- The institution has submitted its reply against the show cause notice.
- The reply submitted by the institution was considered by WRC and found satisfactory.

In view of the above, WRC decided that the recognition granted to the institution be continued and no further action is required.

NOW THEREFORE, the recognition granted to IITS College, Late Shri Bhagwan Singh Sharma Shiksha Prasar Samiti, Near Gaushala, Mahaveerpura, A.B. Road, Guna, Madhya Pradesh for conducting B.Ed. Programme of two years duration with an annual intake of 100 students (two basic unit of 50 students each) vide revised recognition order No. WRC/APW01565/ 223252/ 2015/147857-859 dated 31.05.2015 is hereby continue.

The terms and conditions shall remain mentioned in the revised recognition order issued vide order dated 31.05.2015.
