RESTORATION ORDER

WHEREAS, recognition was granted to the institution, namely KAMLA NEHRU MAHILA MAHAVIDYALAYA, PREMNAGAR, SATNA MADHYA PRADESH under section 14 (3)A of NCTE Act, 1993 for conducting B.Ed. course (100 Intake) vide order No. WRC/5-6/2K/376-381 dated 15.01.2001.

- 2. AND WHEREAS, the letter for Affidavit Regarding Acceptance and Compliance of NCTE Regulations, 2014 was issued to the institution the reply was received on 05.02.2015.
- AND WHEREAS, Revised Recognition order was issued to KAMLA NEHRU MAHILA MAHAVIDYALAYA, PREMNAGAR, SATNA MADHYA PRADESH, vide order No. WRC/OAPW0976/213023/2015/152382-389 dated 07.09.2015 for B.Ed. of Two Years Duration with an annual intake of 100 students for two basic units of (50 students each) from the academic session 2015-2016.
- AND WHEREAS, Compliance was not Submitted as per regulations 2014.
- AND WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014.
- 6. AND WHEREAS, a Show Cause notice was issued to the institution on 21.07.2016 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order:
 - Staff Profile for the session 2015-2016 duly approved by the affiliating body.
 - 2) Originally notarized CLU, NEC, Building Plan & Building Completion Certificate.
- AND WHEREAS, the reply of show cause notice was submitted by the institution on 23.08.2016.
- AND WHEREAS, the matter was placed in 304th Meeting held on April 02-04 2019 of WRC and the Committee decided that." The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were

The revised recognition order was issued to the institution on 07/09/2015. The SCN was issued to the institution on 21/07/2016. The institution has submitted reply dated 19/08/2016 received in the office of WRC on

On perusal of the reply of the institution it is observed that the institution has not submitted the following documents:

- •The institution has not submitted a letter granting approval for the selection or appointment of faculty, issued by the affiliating body as per NCTE Regulations 2014
- The institution has not submitted any proof of additional built up area.
- The institution has not submitted any proof of additional infrastructure.
- The institution has not submitted NEC issued by the competent authority.
- The institution has not submitted land use certificate issued by the competent authority.
- •The institution has not submitted building plan approved by competent authority mentioning Plot/khasra Number, total land area and earmarked area for each course being run in the same premises .
- •The institution has not submitted BCC issued by the competent authority.
- The institution has not submitted certified registered land document.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for programme with effect from the end of the academic session next following the date of communication of the sald order. Continue...2

- S. AND WHEREAS, The Withdrawei order was issued to the institution on 11.04.2019.
- AND WHEREAS, the institution filed an Appeal to the Council on 28.05.2019 and the Council vide its order dt.
 06.11.2019 remanded back the case to the WRC, NCTE for necessary action and accordingly the institute submitted related documents in WRO vide letter dt 19.11.2019.
- 11. AND WHEREAS, the matter was placed in 313th Meeting held on 25th -27th, 2020 of WRC and the Committee decided that "The Committee considered the matter keeping in view the directions of the Appellate Authority order dated 06.11.2019 and noted the following:-
 - (i) The faculty appointed at SI. No. 6, 8, 11 are not qualified as they do not have required 55% marks in PG as per NCTE Norms.

Land of the institution is on Private lease.

(iii) Building Completion Certificate (BCC) is not in the name of institution.

(iv) FDR of Rs. 5.00 and Rs. 7.00 lakhs not submitted

In view of the above, the Committee decided that the Withdrawal order dated 11.04.2019 issued by WRC for the institution stands.

- 12. AND WHEREAS, The Withdrawal order was issued to the institution on 23.06.2020.
- 13. AND WHEREAS, the institution has filed W.P no. CONT CAS 415/2020 in the High Court of Delhi at new Delhi pass dated 14.08.2020.
- AND WHEREAS, the matter was placed in Emergent Meeting Notice Meeting held on 20th August 2020 of WRC and the Committee decided that.

The committee considered the matter of Kamla Nehru Mahila mahavidyalal in view of the direction of the Hob'ble Court in CONT CASE @415/2020. Sh Sharvan Shukla representative of the institution presented the matter before the WRC.

The WRC noted the iollowing:-

Sh. Shukla accepted that the institution has not submitted the faculty list, FDRs and B.C.C in original in response to Show Cause Notice.

He assured that will submit all the required desuments in original to WRC on coming Money i.e. by 24th August 2020.

The WRC decided that after receiving the documents, the office of WRC may examine the same and place the matter before WRC for consideration in its next meeting.

 AND WHEREAS, the matter was placed in 315th Meeting held on 27th to 28th August & 03 September 2020 of WRC and the Committee decided that.

The WRC considered the matter keeping in view the directions of the Hon'ble High Court of Delhi in Cont Case No. 415/2020.

The WRC in its Emergent meeting held on 21st August 2020 considered the matter and decided that after receiving the documents as asked for in the meeting, the office of WRC may examine the same and place the matter before WRC for consideration in its next meeting.

The WRC considered the matter keeping in view the Agenda note and other related documents and observed that the application of the institution is deficient in terms of following:-

 From the staff list submitted the faculty at Sr. No. 01, 6, 8 and 11 are not qualified as per NCTE Regulations 2014, as amended vide notification dated 09th June 2017.

In view of the above, the Committee decided that last opportunity u/s 17 of the NCTE Act be given to the institution to submit its to submit representation within 30 days be issued to the institution for B.Ed course.

- AND WHEREAS, Accordingly, a Final Show Cause Notice was issued on 22.09.2020 the institution has submitted reply received on 13.10.2020.
- 17. AND WHEREAS, the matter was placed in 336th Meeting held on 24th to 25th March 2021 of WRC and the Committee decided that.

The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:-

The Committee respectfully considered the direction of the Hon'ble High Court CONT CASE (C) 415/2020 and the reply submitted by the institution on 24.08.2020, the Committee decided that the Recognition be restored and the order be issued to the Institution KAMLA NEHRU MAHILA MAHAVIDYALAYA, PREM NAGAR, SATNA, MADHYA PRADESH for B.Ed programme for 2 basic units of 50 students in unit.

10. NOW THEREFORE, the recognition is restored to KAMLA NEHRU MAHILA MAHAVIDYALAYA, PREM NAGAR, SATNA, MADHYA PRADESH from the date of this order for conducting B.Ed. course with an annual intake of 100 students (two basic units of 50 students each) from the withdrawal order no WRC/OAPWO976/213023/B.ED/313th/2019/208648 to 208654 Dated 23.06.2020.
