Whereas, in exercise of the powers conterted by sub-section(2) of Section 32 of the National Council for Teacher

Whereas, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

- 2. And whereas, the institution District Institute of Education and Training Bijalpur Indore, plot/khasara no. 88, Plot Number: G I, Street Number: AB Road, Village: Bijalpur, Post Office: Rajendra Nagar, Tehsil/Taluka: Indore, Town/ City: Indore, District: Indore 452012, Madhya Pradesh (WRCAPP2497) has by affidavit consented to come under New Regulations and sought permission for an additional unit of 50 students in **D.El.Ed.** programme which require additional facilities.
- 3. And whereas, it has been decided to permit the institution to have one basic unit of 50 students subject to the institution fulfilling following conditions namely,
 - (i). The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
 - (ii). The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan(BP)in the specified Performa available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available; otherwise it can also be given to the Visiting team at the time of inspection.
 - (iii). The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- 4. Now therefore, in the light of the above and in terms of Section 15(3) (a) of NCTE Act and in accordance with the Regulations, 2014, the Western Regional Committee, NCTE hereby grants permission to District Institute of Education and Training Bijalpur Indore, plot/khasara no. 88. Plot Number: G 1, Street Number: AB Road, Village: Bijalpur, Post Office: Rajendra Nagar, Tehsil/Taluka: Indore, Town/ City: Indore, District: Indore 452012, Madhya Pradesh for an additional unit of 50 students (one basic unit) of existing D.El.Ed. programme of 2 years duration thus making total annual intake of institution to 100 students from the academic session 2015-2016 subject to fulfilment of the conditions mentioned herein before 31.10.2015.
- 5. Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
- 6. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 7. The institution shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:
 - a) Sanctioned programmes along with annual intake in the institution:
 - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.

If the institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
