AND WHEREAS, the revised order was issued to the institution namely LAXMIBAI NATIONAL UNIVERSITY OF PHYSICAL EDUCATION, VILLAGE- SHAKTI NAGAR CAMPUS, POST OFFICE.-SHAKTI NAGAR, TEHSIL/TALUKA- GWALIOR, CITY/DIST- GWALIOR- 474002, MADHYA PRADESH vide order no. WRCAPP/1467/APW01160/224091/Revised Order/2015/141895-902 dt. 31.05.2015 for conducting B.P.Ed. (Integrated) programme of four (4) years duration with an annual intake of 200 students (two basic units of 100 students each) from the academic session 2015-16.

AND WHEREAS, the institution has not submitted Compliance of revised recognition order dt. 31.05.2015.

AND WHEREAS, the matter was considered in WRC in its 255th meeting held on June 22-24, 2016 and the Committee decided to issue SCN on the following points:-

- > Original Staff Profile (1-Principal/HOD+15 Faculties) from the session 2016-2017 duly approved by the affiliating body.
- > Originally notarized (not Xerox) CLU, NEC, Building plan and Building Completion Certificate.

AND WHEREAS, the institution has not submitted reply of Show Cause Notice dt. 01.02.2017.

AND WHEREAS, The matter was considered in WRC in its 311^{th} meeting held on September 25-27, 2019 and the Committee decided that:-" The SCN dated 01/02/2017 was issued to the institution on the following grounds:

- The original staff profile (1 Principal/HOD+15 faculties) from the session 2016-2017 duly approved by the affiliating body.
- Originally notarized (Not xerox) CLU, NEC, Building plan and building completion certificate.

The summary of the case reveals that the institution has not submitted reply of the Show cause notice.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.P.Ed. Innovative 4 years programme with effect from the end of the academic session next following the date of communication of the said order"

AND WHEREAS, Withdrawal order was issued to the institution dt. 09.10.2019.

AND WHEREAS, the institution has filed an appeal to NCTE, Hqrs. on 07.12.2019. The Appellate Authority vide its order dated 11.03.2020 remanded back the case to the WRC, NCTE, for necessary action.

AND WHEREAS, the matter was placed in 316th Meeting of WRC held on 27-28 August & 04 September, 2020 and the Committee decided that:-" The WRC examined the documents submitted by the institution in response to the order of the Appellate Authority decided that
