**ORDER**

WHEREAS, Shri Balaji Teachers Training School, Near Old Bus Stand, Sh. Laxman Rajpur Hostel Camus, Dungarpur, Rajasthan, had applied for grant of recognition/permission for STC Course of two -year(s) duration under Section 15(i) of the NCTE Act,1993 to the NRC,NCTE.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS in its 111<sup>th</sup> meeting held on November 30<sup>th</sup> - December 01,2006, the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, decided that fresh inspection of the institution be conducted for verification of infrastructural and instructional facilities and human resources available in the institution to run STC course as per NCTE norms.

4. AND WHEREAS a Visiting Team to visit the institution was again constituted, the report of the Visiting Team as well as other documents and materials submitted by the institution along with videography were again duly considered by the Northern Regional Committee on 114<sup>th</sup> Meeting held on 21<sup>st</sup> & 22<sup>nd</sup> February 2007 which come to the conclusion that recognition/permission to the said institution be refused for the following reasons.

- (i) The institution is running B.Ed and NTT along with Engineering, Pharmacy and other courses in the same campus
- (ii) The institution has proposed to run the proposed STC and existing NTT and B.Ed course in the same building where the school is being run by the management without earmarking space.
- (iii) The number of books added for STC course are not adequate as per NCTE norms.
- (iv) The psychological tests and apparatus and software in the ET lab for STC are inadequate.
- (v) The books available in the library for B.Ed and NTT are also not clearly demarcated.

5. NOW THEREFORE grant of recognition/ permission to Shri Balaji Teachers Training School, Near Old Bus Stand, Sh. Laxman Rajpur Hostel Camus, Dungarpur, Rajasthan for the STC Course in terms of section 15 (3) (b) of the NCTE Act,1993, is hereby refused.

6. If the institution is not satisfied by the above Order they can prefer an appeal to the Council in terms of section 18 of NCTE Act,1993.
