ORDER



Dadhimathi Mahila Shikshak Prashikshan Mahavidyalaya, Chok 6 E, Chhoti Hanumangarh Road, Sriganganagar, Rajasthan submitted an application to the Northern Regional Committee of National Council for Teacher Education for permission of STC Course in terms of section 15 (1) of NCTE Act, 1993.

- The NRC at its 108th meeting held on 25-26 September 2006 at NRC, NCTE Jaipur 2, considered application of the institution included in the agenda for the meeting and after careful examination of relevant documents, visiting team report, Video Recording etc. found the institution fit for grant of permission.
- Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants permission to Dadhimathi Mahila Shikshak Prashikshan Mahavidyalaya, Chok 6 E, Chhoti Hanumangarh Road, Sriganganagar, Rajasthan for an annual Intake of 50 seats (fifty only) (50 seats in the 1st year and the same for the 2nd year) in STC course of two year duration with effect from the session 2006-2007 at the following address :-

Dadhimathi Mahila Shikshak Prashikshan Mahavidyalaya, Chok 6 E. Chhoti Hanumangarh Road, Sriganganagar, Rajasthan

- The institution shall ensure the fulfillment of the following: -
- The institution shall maintain the teaching staff strength of 1+4 for the STC Course. (a)

The institution shall adhere to all the other regulations and guidelines as framed by (b) NCTE from time to time.

The institution shall within one month of the receipt of Recognition order, convert the (5) Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.

That the Reserve Fund for an amount of Rs. Three Lakhs be maintained in the form of (d) FDR in favour of the management/institution.

Further, the recognition is subject to fulfillment of all such other requirements as may (e) be prescribed by other regulatory bodies like UGC and State Government concerned,

etc. The institution shall submit to the Regional Committee a Self-Appraisal Report at the (f) end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.

The institution shall regularly update its website.

(g) The institution if Intending to run the teacher training programme approved above in a (h) rented premises is required to shift to its permanent building. It is required to submit report in compliance of the requirement of NCTE Regulations on the subject.
