RECOGNITION ORDER

Whereas, in terms of Section 15(1) of the NCTE Act, 1993, Gram Meduka Krishi Shikshan Samiti, Plot no.-725, Street Road-Main Road Lohari, Village-Lohari, Post office-Marwahi, Tehsil Taluka-Marwahi, District-Bilaspur, Chhattisgarh-495116 (WRCAPP3059) had submitted on 28.06.2015 the application to the Western Regional Committee of the NCTE for grant of recognition to Ayush College of Education, Plot Khasra no. 725, Village-Lohari, Post office Marwahi, Tehsil Taluka-Marwahi, District-Bilaspur, Chhattisgarh-495116 for D.F.L.d. Rules and relevant Regulations including the Norms and Standards for the D.E.E.E.d. programme, such as, infrastructural and instructional facilities. Iibrary, accommodation, financial resources, laboratory etc. for running the programme and has selected appointed duly qualified teaching staff as per NCTE norms.

Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTL Act. 1993 and in accordance with the Regulations, 2014, the Western Regional Committee, NCTE hereby grants recognition to Ayush College of Education, Plot/Khasra no. 725, Village- Lohari, Post office- Marwahi, Tehsil/Taluka- Marwahi, District- Bilaspur, Chhattisgarh- 495116 for conducting D.El.Ed. programme of 2 (Two) years duration with an annual intake of 100 students (two units of 50 students each unit) from the academic session 2016-2017.

The recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University Body. State Government etc. as applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with annual statement of accounts duly audited by a Chartered Accountant.
