#### RECOGNITION ORDER

Rules and relevant Regulations including the Norms and Standards for the D.E.L.E.d. programme, such as, infrastructural and instructional facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected appointed duly qualified teaching staff as per NCTE norms.
