
Decision of ERC:

- The institution is running B.Ed course vide order No. F.No.ER-250.6.20(Part-

1)/ERCAPP3524/B.Ed./ 2018/56387 dated 03.03.2018 for 50 students in the name of Dashin Dinajpur B.Ed. College, Khasra No. 408, Plot No.75, 78, Vill- Shihur, PO- Tapan, Tehsil/Taluka - Shihur, Town/City- Tapan, Dist.- Dakshin Dinajpur, West Bengal- 733127.

- Withdrawal Order Vide Order No. F.No. ER-332.28/NCTE/ERCAPP3524/B.Ed./WB/2023/68758 Dated 18.09.2023 was issued to the Institution on certain grounds.
- The institution preferred appeal before NCTE Appellate Authority against the Order No. 332.28/NCTE/ERCAPP3524/B.Ed./WB/2023/68758 Dated 18.09.2023 and the NCTE Appellate Authority decided to remand back the case to ERC with a direction to verify the submitted documents filed by the Appellant institution with Appellate Authority, NCTE from the records available with ERC and if it feels necessary and appropriate then documents may also be verified from the concerned competent authority.
- Restoration Order vide Order No. F.No.ER-339.11/NCTE/B.Ed./ERCAPP3524/B.Ed./WB/2024 Dated 15.02.2024 was issued to the institution.
- The Committee further decided that the documents submitted by the institution in compliance of the appeal order be verified by the concerned competent authority and a copy of these communications may also be endorsed to the State Government.
- The Institution has filed a Writ Petition No. W.P. (C) 18043/2025, with request to change of the name of the college from Dakshin Dinajpur B.Ed. College to **Dakshin Dinajpur D.Ed. College**.
- The Hon'ble High court has passed an order dated 28.11.2025 that "*Without entering into the merits of the case, this writ petition is disposed of with the direction to Respondents to treat this writ petition as a representation and pass a decision thereon within two weeks from today. Decision will be communicated to the Petitioner within a week thereafter. It will be open to the Petitioner to take recourse to legal remedies in the event of any surviving grievance.*"
- The institution has applied in the name of Dakshin Dinajpur B.Ed College, accordingly the recognition was granted in this name.


After carefully observing the court order in W.P. (C) No. 18043/2025 passed by the Hon'ble High court of the Delhi along with other related documents submitted while applying for the B.Ed course, the Committee decided to permit the change of the name of institution **from Dakshin Dinajpur B.Ed. College to Dakshin Dinajpur D.Ed. College**.

The Committee further decided that the documents submitted by the institution in compliance of the appeal order be verified by the concerned competent authority and a copy of these communications may also be endorsed to the State Government. In this regard, reminder letter be issued on top priority.

Decision of ERC:

The original file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, requested dated 06.07.2024 followed by other reminders, guidelines issued from time to time were placed before the Eastern Regional Committee and **the Committee observed the following:**

- The institutions are running B.Ed (2 units), D.El.Ed programme (1 unit), M.Ed (1 unit), and B.P.Ed (1 unit) respectively.
- For the all three courses viz B.Ed, M.Ed and B.P.Ed affiliating body has already been changed to Radha Govind University.
- The institution has submitted an application alongwith relevant documents with request to grant status to its Department of Education, Radha Govind University and change in the affiliating body in r/o D.El.Ed course.

After carefully observing the request of the institution along with other related documents, the ERC decided to permit change of the status of the institutions **as Department of Education, Radha Govind University. Further the examination body for D.El.Ed programme is changed from Jharkhand Academic Council to Radha Govind University.**
