Notification to these effects has been issued and portal to invite online application from interested and eligible candidates has been made opened on 14.11.2025 with closing date on 04.12.2025.*

*The essential qualification mentioned in the said advertisement (Copy enclosed), it appears that it has violated the NCTE guidelines for physical education (TGT). For example, in NCTE guidelines 45% marks is essential to get admission in B.P.Ed. course and that physical education is not an essential subject in the graduate level. Unfortunately, the said advertisement mentioned that 50% is required and physical education must be a subject in graduation level. There are anomalies also in the KVS & NVS qualifications required. In this regard a letter from the Deputy Commissioner NVS, is enclosed for your perusal which may reveal the anomalies mentioned above.*

*My humble request to you all to protect the interest of many candidates who have passed from the NCTE recognised physical education institutes in West Bengal or other states, by drawing the attention of the CBSE Board with a request to follow the NCTI guidelines in this regard on the subject mentioned above.*

**In view of the above and the fact that the matter is related to Regulation Division of NCTE, the Committee concluded that the representation is self-explanatory and the notification issued by the CBSE needs modification to certain extent and decided that the said representation be forwarded to Regulation Division for further necessary action on top priority.**

The online file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee and **the Committee observed the following:**


1. As per decision of ERC, Show Cause Notice post preliminary scrutiny was sent on 15.11.2025. The institution has not submitted reply to the SCN.

**After carefully observing the online application form, along with other related documents, the ERC found deficient on the following grounds:**

1. The guidelines for "Transforming NCTE Recognized Stand-Alone Teacher Education Institution into Multidisciplinary Higher Education Institutions" issued by the NCTE in May, 2025 is applicable to the instant matter as the institution is not multidisciplinary as defined under NCTE regulations amended from time to time.
2. The institution has now submitted a Memorandum of Collaboration between **SHAHEED PRAMOD B.ED. COLLEGE** and **RAM DAYALU SINGH COLLEGE** executed on 10.06.2025. Both the institutions are affiliated to the same university. The institution is


- required to submit a proof to the effect that both the institutions are within a distance of 10 km.
3. The institution is required to produce a certificate from the concerned State Government justifying the need for teacher education programme in that area/region.
  4. The institution is required to submit a proof to the effect that the affiliating university, through its statutory body, approved the collaboration.
  5. The institution is required to submit a proof to the effect that **RAM DAYALU SINGH COLLEGE** are offering at least two undergraduate degree programmes in accordance with the requirements of ITEP and it has no Education Department of its own.
  6. The institution is required to submit a proof to the effect that **RAM DAYALU SINGH COLLEGE** has collaborated only with **SHAHEED PRAMOD B.ED. COLLEGE** for making the latter as a multidisciplinary institution.
  7. The institution did not submit copy of Not-for-Profit Certificate from the competent authority.
  8. The institution did not submit authorization letter on the stamp paper as per admissible government rate
  9. The institution has not submitted details of student admitted
  10. The institution is running three units of B.Ed programme and two units of D.El.Ed Programme. The institution has submitted transit application for two units of ITEP programme. The institution has only 4249.30 sqmtrs land which is less than NCTE regulation for running two units of B.Ed programme , two units of D.El.Ed and two units of ITEP programme as per para 6.1 (b) notified dated 26.10.2021.
  11. The institution has not submitted NEC.
  12. The institution has submitted Building plan but it is not readable. Hence the institution is required to submit readable copy of Building Plan with earmarked area of Existing course and proposed course as per NCTE Regulation.
  13. The institution has submitted BCC but not mentioned earmarked area. Hence the institution is required to submit BCC with earmarked area for proposed course and existing course.
  14. The institution has not submitted fire safety Certificate and Building safety certificate issued from Govt. Authority.
  15. The institution not submitted a certificate issued by the competent authority stating that the institution's campus, building, furniture etc is barrier free/Accessible for all.

**Hence, the committee decided that the final show cause notice be issued to the institution to submit the reply through the portal on the deficiencies mentioned above within 07 days from the date of issue of the final show cause notice.**
