Decision of ERC

The online file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, VT report, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following: -

1. The land area is 3857 sq. meters mentioned in the application form, which is lesser than what is required under NCTE regulations as the institution is also running B.ED course (two units).
2. Accordingly, the institution is required to submit the Building Completion Certificate (BCC) and land documents.

Hence, the committee decided that the show cause notice post inspection be issued to the institution to submit the reply through the portal on the deficiencies mentioned above within 07 days from the date of issue of the show cause notice.

Decision of ERC

The original file of the institution, other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC and the Committee had decided to seek certain documents from the institution:

Accordingly, a communication/show cause notice dated 10.12.2025 was issued to the institution with a direction to submit the reply within 15 days and accordingly, the institution has submitted reply on 23.12.2025.

After carefully observing the reply dated 23.12.2025 along with other related documents, the ERC found deficient on the following grounds:

1. The institution has submitted a Memorandum of Collaboration between **AL Hilal Mission Teachers Training Institute** and Kandi Raj College executed on 04.09.2025. Both the institutions are affiliated with different Universities which is not as per guidelines issued by NCTE.
2. The distance between both of the institutions is 11.6 km which is not as per NCTE guidelines.
3. The institution is required to produce a certificate from the concerned State Government justifying the need for teacher education programme in that area/region.
4. The institution is required to submit a proof to the effect that the affiliating university, through its statutory body, approved the collaboration.
5. The institution is required to submit a proof to the effect that **KANDI RAJ COLLEGE** are offering at least two undergraduate degree programmes in accordance with the requirements of ITEP and it has no Education Department of its own.
6. The institution is required to submit a proof to the effect that **KANDI RAJ COLLEGE** has collaborated only with **AL HILAL MISSION TEACHERS TRAINING INSTITUTE** for making the latter as a multidisciplinary institution.

In view of above, the Committee also decided that Final Show Cause Notice be issued to the institution to submit reply on the deficiencies mentioned above within 07 days from the date of issue of show cause notice.

The online file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee. In addition, the VT shall also verify the infrastructure and instructional facilities created by the institution so as to assess its preparedness for running the course as per NCTE Regulations 2014.
