The decision taken by ERC-NCTE at Sl..No. 28 in 384th meeting (volume-III) held on 09th to 10th December, 2025 regarding grant of recognition by ERC of NCTE violating the provision of NET/Ph.D qualification notified by the NCTE dated 09.06.2017 in respect of Bankim Behari Teachers Training Institute, Vill - Markandachak, P.O. - Bishnupur Bazar, Taluka/Mandal - Sabong, Town/ City - Markandachak, Dist - Medinipur, West Bengal - 721144, for B.Ed.Add.programme is hereby deleted as the decision in respect of this institution was already taken in the same meeting (at Sl. No. 6, volume- III). Inadvertently, the matter was placed again in the same meeting at sl. 28. Hence, the decision taken at Sl. 28 in respect of the aforesaid institution stands deleted.


Decision of ERC:

The original file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, Delhi High Court's Order dated 24.09.2025, VT report, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following:

- The recognition of the institution was granted for B.Ed. Course with 100 seats (i.e. two basic units). Subsequently, vide order dated 08.06.2023, the recognition was withdrawn on account of not having adequate number of faculties. The appeal preferred by institution against the said order was also dismissed by the Appellate Committee vide order dated 27.02.2024.
- The institute filed a WP(C) no. 9840/2024 challenging the withdrawal order dated 08.06.2023 and appeal order 27.02.2024. Accordingly, the Hon'ble High Court of Delhi passed a Judgement dated 24.09.2025.
- The matter was placed before 379th meeting and decided to restore one unit of 50 seats and copy of the restoration order also be endorsed to affiliating university as well as the State

Authority. IT Division be also requested to update the website accordingly. Insofar as the remaining 50 seats are concerned, NCTE-HQ be requested to carry out the inspection in terms of Section 13 of the NCTE act as directed by the Hon'ble High Court. After receipt of the inspection report, the Committee will follow the instructions as ordered by the Hon'ble High Court of Delhi.

- The office of the NCTE had issued restoration order dated 03.10.2025 to the institution for one unit.
- In compliance of the court order, the inspection was conducted on 11.12.2025. The VT members has given observation in the VT report that "**For the virtual inspection of the institution (SCHEDULED ID-250725) all three Visiting Team Members and the NCTE inspection division representative joined on 10.30 AM. The quorum was complete. But since the institute did not join the virtual meeting, so we were unable to conduct the online inspection. Finally, we closed the inspection meeting at 11.47 AM and the inspection was not conducted for the college ". Therefore, this report is submitted for further action.**

Hence, the committee decided that Re- VT be constituted honouring the order of the Hon'ble Court, in order to ascertain and scrutinize all the essential documents such as land documents, building plan, CLU, BCC, Non-Encumbrance Certificate along with other required documents in original and verify its authenticity with reference to NCTE Regulations 2014 and mention the status/position of these documents along with deficiencies, if any.

In addition, the VT shall also verify the infrastructure and instructional facilities created by the institution so as to assess its preparedness for running the course as per NCTE Regulations 2014.

The original file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, order of the Hon'ble High Court at Calcutta, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following:-

1. The institution was recognized for two units of B.Ed course on 30.10.2006 for conducting B.Ed course of one year duration with annual intake of 100 from the academic session 2006-2007.
2. Revised recognition order was issued to the institution on 23.05.2015 for conducting B.Ed course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014.
3. The recognition of the institution for B.Ed course was withdrawn on 18.04.2017 from the

4. The college had challenged the said order in W.P. No. 14507(W) of 2017. The learned Single Judge of this Court, by an order dated February 01, 2018, had set aside the said order.
5. ERC, in terms of the said order of the learned Single Judge, in its 260th meeting held on August 31, 2018 and September 01, 2018 had decided to withdraw the said decision to derecognize the said college for the said two academic sessions and accordingly had directed uploading of the status of the said college in its website in the following manner:
"The status of recognition mentioned as "withdrawn" on E.R.C. website may be updated as "withdrawn" set aside by Hon'ble High Court".
6. The petitioners via WPA 29135/2025 are alleging that the ERC has not yet updated the said status of the college in its website. In the meantime, the petitioners have qualified in the written examination of State Level Selection Test, 2025 for recruitment in the post of teachers in Government-aided/sponsored schools and they have been directed to appear for verification of their credentials on December 26, 2025. The petitioners are apprehending that in the said verification process, their B.Ed. degree may not be treated as valid unless the recognition status of the said college is updated in the website of the respondent no. 1.
7. In the backdrop of such facts and circumstances, the respondent no.1 has been directed by the hon'ble High Court of Calcutta vide order dated 23.12.2025 to update the recognition status of the said college in its website immediately, if there is no other embargo in doing so. The college authority shall pursue the issue with the said respondent.
8. The respondent no. 1 has also been directed to file a status report in this regard on the next date of hearing. Matter be included in the combined Monthly List of January, 2026.
9. The Committee browsed the website of the ERC and found that withdrawal order and restoration/continuation orders have been attached therewith against 'Order Type' - Withdrawal and Restoration/Continuation respectively.

In view of the above, the ERC directed O/o ERC to update the website in respect of the above institution as below:

The word appeared as 'Withdrawal' under the title 'Order Type' on the website may be written as "Withdrawn" set aside by Hon'ble High Court".



"After perusal of the Appeal Report, documents on record and oral arguments advanced during the online hearing, Appeal Committee of the Council concluded to set aside the impugned order dated 03.07.2025 and remand back the case to ERC with a direction to carefully re-examine the matter, verify the authenticity and relevance of all documents submitted, and pass a reasoned order strictly in accordance with the provisions of the NCTE Act, Rules, and Regulations. The Appellant institution is directed to forward to the ERC the documents submitted in appeal within 15 days from the receipt of order of the Appeal and after receipt of the same the ERC to take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time as per direction given herein above.

3. The institution has submitted reply dated 03.01.2026 received in the office of ERC on 13.01.2026.

In view of the above, the committee decided that the recognition of the institution granted vide order no. ERC/7-69.6.1/2006/3508 dated 04.10.2006 be restored. Concerned Affiliating Body be informed accordingly.

It should be supported with documents like photocopy of passbooks of each of faculty, showing the disbursement of salary through bank account to individual faculty members for last six months.
3. The institution is required to submit the PAN card details of Teaching Faculty.





4. Non encumbrance certificate is not issued by the competent authority.
5. The fire safety certificate issuing date is not matched with issuing date mentioned by the institution in their application itself.
6. The institution does not have building completion certificate.
7. Barrier free environment for physically challenged Persons is not available with the institution. No Ramps/lift for the upper floors and toilets railing not available.

Hence, the Committee decided that the show cause notice be issued to the institution to submit the reply through the portal on deficiencies mentioned above within 07 days from the date of issue of the show cause notice.

7. Common Room, Availability of Adequate Furniture, safe drinking water facilities and facilities for Co-Curricular activities are not available.

Hence, the committee decided that the show cause notice be issued to the institution to submit the reply through the portal on deficiencies mentioned above within 07 days from the date of issue of the show cause notice.



Womens College comes under Department of Education, Jamshedpur Womens University.

(ii) The request of the institution to convert Jamshedpur Women's College to Deptt. of Education, Jamshedpur Women's University is permitted.

- Accordingly, a letter was issued to the institution conveying the above decision vide order date 12.12.2024.
- Now, the institution has submitted a request to update the recognition on your website, as issued in your order No. F.No. 352-66/NCTE/B.Ed/APE00410&ERCAPP1021/JH/2024/NCTE/M.Ed/APE00509/JH/2024/NCTE/B.P.Ed/ERCAP201645128(ID-9625)/JH/2024/70080-70087) Dated 12/12/2014 reflecting the name of Jamshedpur Women's University with effect from the session 2021-2022.

After carefully observing the request of the institution along with other related documents, the ERC permitted to update the status of the institution as Jamshedpur Women's University from the session 2021-2022. Accordingly, corrigendum order be issued to the institution.



Decision of ERC:

The original file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee had decided the following in its 384th meeting held on 09th to 10th Dec., 2025.

1. O/o ERC has received OM no. NCTE-C/PG011/5/2022-complaint Section-HQ/32836 dated 22.09.2025 (computer no. 70072) to examine the complaints filed by Shri Rohit Arora regarding grant of recognition by ERC, WRC and SRC of NCTE violating the provisions contained in the NCTE notification dated 09.06.2017.
2. NCTE Hqrs. Vide its notification dt. 09.06.2017 made it mandatory for institution that all the faculties must have Ph.D or NET as eligibility criteria for obtaining recognition. ERC subsequent to this notification, without emphasizing on Notification dt. 09.06.2017 granted recognition to 97 institutions. Later, on ERC issued notices to all TEIs for appointing faculties with NET/Ph.D qualification. Out of these 97 institutions, cases of 41 institutions could not be processed. The reply to ERC's Final SCNs were received in the year 2022 in respect of these 41 institutions. These cases needed to be placed before ERC for ERC's consideration. As this is year 2025, there is a gap of a period of 3 years, the staff status of these TEIs could vary/have changed during these years.

After carefully observing the reply to final SCNs along with other related documents, the ERC concluded the following:-

1. It will be appropriate to seek fresh Staff Profile from these 41 TEIs to take a final view in the matter. This would save the office from unnecessary litigation and avoid legal complications in the courts.
2. Once these staff profiles are considered by ERC and decision is taken in this regard, the status could be apprised to the NCTE Hqrs against their OM dated 22.09.2025 (supra).

Hence, Committee decided that a communication is required to be made to these institutions to seek the latest faculty profile in the prescribed proforma, duly approved by the Affiliating Body concerned within 21 days from the date of issue of such communications.

The minutes of the 384th meeting were uploaded on the website and accordingly, the institution has submitted the reply on 12.01.2026 on the basis of minutes uploaded on the website.

After carefully observing the reply of the institution, the ERC concluded that the reply is satisfactory and decided that no further action is required. A letter be issued to the institution accordingly.
