<p><b>Decision of WRC:</b></p> <p>On careful perusal of the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents uploaded by the institution were carefully considered by the WRC, NCTE and the Committee noted the following :-</p> <ol style="list-style-type: none"> <li>1. The institution is recognised by NCTE for B.Ed course with an annual intake of 100 students and D.El.Ed course with an annual intake of 50 students.</li> <li>2. The institution has submitted an application for shifting of premises to RSC College, Plot No. 117, Khasra No. 117, Village/Twon/City- Sikroda (Badori), Jhansi Road, District-Gwalior, Madhya Pradesh.</li> <li>3. The institution has approached the Hon'ble High Court of Delhi and the Hon'ble Court vide order dated dated 29.01.2026 in W.P.(C) 1207/2026 has directed as under :-             <ol style="list-style-type: none"> <li>1. <i>This is a writ petition filed under Article 226 of the Constitution of India seeking directions to the respondent No.2 to consider and decide the pending application of the petitioner institution regarding shifting of its premises.</i></li> <li>2. <i>Mr. Srivastava, learned counsel for the petitioner, states that the case the address of the petitioner college is Basant Parisar, Mayur Market, Gandhi Road, Gwalior, Madhya Pradesh- 474011 and the petitioner wishes to change the address to Village Sirkoda (Badori), Jhansi Road, Gwalior, Madhya Pradesh- 475001. The application of the petitioner is pending for the last many years.</i></li> <li>3. <i>For the said reasons, issue notice.</i></li> <li>4. <i>Ms. Malhotra, learned counsel accepts notice on behalf of the respondents.</i></li> <li>5. <i>It is directed that the respondent shall consider the application of the petitioner for change of its address as mentioned above expeditiously and in any case, within 6 weeks from today.</i></li> <li>6. <i>Needless to say, in case the petitioner is aggrieved, the petitioner will be at liberty to avail of its legal rights in accordance with law.</i></li> <li>7. <i>The petition is disposed of in the aforesaid terms.</i></li> </ol> </li> <li>4. The institution is required to submit the processing fee of Rs. 1.50 lacs + GST towards processing fee for shifting of premises.</li> <li>5. As per the decision of WRC, the Show Cause Notice dated 30.07.2015 was issued to the institution to submit certain documents regarding shifting of premises. No reply has been submitted by the institution till date.</li> <li>6. On perusal of the file of the institution, the WRC noted that the institution vide its letter sent to WRC in November 2006 alongwith affidavit has intimated that it has shifted to the new premises i.e. RSC College, Plot No. 117, Khasra No. 117, Village/Town/City- Sikroda (Badori), Jhansi Road, District-Gwalior, Madhya Pradesh.</li> </ol>		

<p>7. As per the provisions of NCTE Regulations, the institutions desirous for shifting of premises has to make an application alongwith the essential documents to the concerned Regional Committee and only after approval of the Regional Committee, the institution can shift to the new premises.</p> <p>8. The institution has shifted to the new premises without approval from NCTE. This act of the institution is violation of the provisions of NCTE Regulations.</p> <p>9. The application submitted by the institution is deficient with regard the following documents : -</p> <ol style="list-style-type: none"><li>i. Certified copy of land documents not submitted.</li><li>ii. Change of land use issued by the Competent Revenue Authority not submitted.</li><li>iii. Non-Encumbrance Certificate issued by the Competent Revenue Authority not submitted.</li><li>iv. Proof towards maintenance of FDRs for Rs. 5.00 lacs and 7.00 lacs towards Endowment and Reserve Fund not submitted.</li><li>v. Building plan duly approved by the Competent Authority of the State Government not submitted.</li><li>vi. Building Completion Certificate duly approved by the Competent Authority of the State Government not submitted.</li><li>vii. Fire Safety Certificate issued by the Fire department of the State not submitted.</li><li>viii. Building Safety Certificate issued by the Competent Authority not submitted.</li><li>ix. The institution is required to upload the list of teaching staff of all Education Faculty Programmes duly approved and countersigned by its affiliating body. The institution is required to upload the bank statement of last six months indicating the transaction of the salary / remuneration to its teaching staff.</li><li>x. The website is required to be functional and updated in compliance to provisions under Clause 7(14)(i), 8(6), 8(14) and 10(3) of NCTE Regulations 2014 as amended from time to time.</li><li>xi. The institution is required to upload Affidavit on Rs.100/- stamp paper in prescribed format regarding land documents.</li><li>xii. The institution is required to upload Mutation Certificate/Jamabandi issued by Competent Authority of State Government.</li><li>xiii. The institution is required to submit the NOC from the affiliating body for shifting of premises.</li></ol> <p><b>Accordingly, the WRC decided that Show Cause Notice u/s 17 of the NCTE Act, 1993 be issued to the institution to submit reply / representation within 21 days of the issue of Show Cause Notice.</b></p>
