Decision of WRC:

In pursuance of Order dated 17.12.2025 passed by Hon'ble High Court of Delhi in W.P.(C) 19116/2025 titled Shri Sharda College of Education & Anr. vs. National Council for Teacher Education & Anr. and filing of Contempt Petition (C) No.476/2026 in W.P. (C) No.19116/2025 titled as Shri Sharda College of Education & Anr. Vs. Ms. Rashmi Shukla, Regional Director, Western Regional Committee (NCTE) & Anr. in the Hon'ble High Court of Delhi, the application dated 20.12.2025 for shifting of premises along with its related documents submitted by the institution was considered by WRC in its 455th (Part-I) Meeting of WRC held on 23rd-25th March, 2026 and as per decision taken by Committee, the institution was asked vide WRC letter No.9038-9043 dated 02.04.2026 to submit requisite documents as mentioned therein. In response to WRC Notice, the institution submitted reply vide their letter Ref. No.107 / SET / 2025-26. dated 11.04.2026 enclosing documents, received in the office of WRC, NCTE on 15.04.2026.

Above matter is considered by WRC in its 457th Meeting held on 20th – 22nd April, 2026, wherein the Committee observed that the following essential documents related to shifting to its new premises in light of NCTE Act, Rules, Regulations, Instructions and Guidelines issued from time to time by NCTE have not been submitted in its reply to notice dated 02.04.2026 by the institution.

- i. NOC from the State Examination Board for shifting of premises.

- ii. The provision of shifting the institution from one district to another district as per laws of the Land, Govt. of Gujarat.
- iii. NOC from the Govt. of Gujarat to shift the institution from one district to another district.
- iv. The institution is required to submit clarification on the enclosed copy of Resolution passed by the Management Committee/ parent body for shifting TEI duly notarized, wherein mentioned the date of issue of Resolution No.:1 dated 02.02.2025 and the date of meeting on 11.04.2025, which is after the date of Resolution passed by the management.
