The recognition of the institution was withdrawal by WRC vide order No. NCTE/2025/PAR/ORDER/APW02103/324064/6200-6205 dated 24.05.2025 regarding institution has not submitted any reply against the show cause notice within 15 days from issue of notice. 2. Thereafter, institution filed an appeal before the Appellate Authority at NCTE, New Delhi and the Appellate Authority vide order dated 13.01.2026 has remanded back the case to WRC <i>for fresh consideration strictly in accordance with the directions contained hereinabove, the applicable law, and the binding decision of the General Body of the Council.</i> 3. The institution again submitted letter dated 09.04.2026 and 10.04.2026 enclosing the document showing that the institution has already filled the PAR bearing no. P-2122020844 for the session 2021-2022 on 04.12.2024 and P-2223033415 for the session 2022-2023 online through PAR portal dated 09.12.2024 for the academic session 2022-23 i.e. well before the last date. <p>In view of the above, the WRC decided that restoration order for B.P.Ed course with an annual intake of 100 students be issued to the institution.</p>

Recognition was granted to Late Shri Nathaji Patil Mhaske Education Society, At Babhaleshwar, Tal.Rahata, Dt. Ahmednagar, Maharashtra vide order No. WRC/5-6/92nd(2nd Sitting)/2007/C-20447 dated 25.07.2007(27.07.2007) for an intake of 50(fifty)(Elementary) for offering of D.Ed.(Marathi)(Co-Ed) course of two years duration under clause 7(10) of Regulation dated 13.1.2006 subject to fulfillment of certain conditions. 2. The institution vide letter dated 28.03.2019 has informed that the General Committee Members of institution has decided not to continue the DTEd. College from the academic year 2019-2020 and hence the institution has requested for refund of the amount of Rs.5,00,000/- (Five lakh rupees) which was kept towards Endowment Fund. <p>The WRC considered the entire matter in detail and decided that the institution be directed to submit the following documents for closure of the course and NOC for encashment of FDRs towards Endowment and Reserve Fund:-</p> <ol style="list-style-type: none"> 1. Affidavit from the institution / society that they are willing to close the course and they will not approach any court / appeal against the decision of closure of WRC.

The WRC noted that the Hon'ble High Court of Delhi in W.P. (C) No. 5161/2026 has disposed of the petition directing the NCTE to consider the pending applications of the petitioners in accordance with the 55th GBM Meeting and either return the same (if found not in accordance with the parameters) and in the alternative if found fulfilling the parameters, the same may be processed in accordance with their extant rules within 4 months from today". 		

2. The General Body of NCTE in its 55th meeting has decided that The applications pending before the RCs for the said Diploma level course(s) shall not be processed further. Hence, all such pending applications before RCs at any stage of processing be returned along with the processing fee to the concerned institution(s).”

Hence, keeping in view the decision of the General Body of NCTE in its 55th General Body meeting, the WRC decided that the application submitted by the institution for D.El.Ed course be returned alongwith the processing fee.
