2. The above institutions approached the Hon'ble High Court of Maharashtra at Aurangabad in the Writ Petitions mentioned against each, wherein the Hon'ble Court vide its order dated 29.06.2026 pronounced the following decision :-

"a. It is open for the petitioners to upload PAR for the academic year 2021-22 and 2022-23 and documents on the web portal of the respondents/NCTE within 15 days from today.

b. For the said purpose, the portal shall be made accessible to the petitioners till 15.07.2026 and the Petitioners shall upload the requisite data/PAR till 15.07.2026. Thereafter till 31.07.2026, the respondent to take decision/pass fresh orders.

c. Same time frame shall be considered in Writ Petition Nos.9685 of 2025 and 9291 of 2025. d. If the petitioners are aggrieved by any adverse order, they shall approach the Appellate forum under Section 18 of the Act.

e. If any adverse order is passed, same shall be given effect after 15 days of order to enable the concerned Petitioner to approach the Appellate Authority u/s 18 of the Act.

f. In view of the above, the impugned orders of withdrawal/de-recognition which are already stayed by this Court, stand quashed and set aside.

g. All Writ Petitions stand disposed of."

3. In this regard, the legal opinion from the Counsel for NCTE at Aurangabad has been obtained.

4. The entire matter was thoroughly considered by WRC-NCTE and WRC observed the following :-

- The Hon'ble High Court in its order dated 29th June 2026 has quashed and set aside the withdrawal orders of WRC.
- The PAR Portal was opened by NCTE on the basis of decision taken in the 61st General Body Meeting (held on 05.08.2024) and the 67th General Body Meeting (held on 28.07.2025), wherein the Council had resolved to implement the PAR for the Academic Sessions 2021-2022 and 2022-2023 and subsequently addressed the issue of non-submission.
- The observations of the Hon'ble High Court of Delhi in its order dated 01.07.2025 in WP(C) 8569/2025 was considered by the General Body of NCTE in its 68th GB held on 25th November 2025 wherein the Council approved the reopening of the online PAR portal for a final, one-time opportunity for all TEIs to submit PAR for the Academic Sessions 2021-22 and 2022-23.
- The applications for one time submission of PAR was opened from 07.05.2026 to 17.06.2026 (till 11:59 pm) for submission of PAR for the Academic Session(s) 2021-2022 and 2022-2023 to certain category of TEIs

Keeping in view the directions of the Hon'ble Court, Legal Opinion of the Standing Counsel for NCTE at Maharashtra (Aurangabad Bench), the WRC decided the following:-

- **Since the Hon'ble High Court in its order dated 29th June 2026 has quashed and set aside the withdrawal orders of WRC, the recognition status of the institutions be RESTORED until a fresh Withdrawal order is passed by WRC.**

- **NCTE-HQrs may be requested for making the online portal for submission of PAR accessible to the institutions mentioned in the Writ Petitions till 15.07.2026 in compliance with the directions of the Hon'ble High Court to petition institution only**
