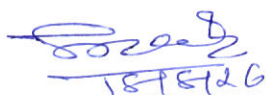
Decision of WRC:

The file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, along with Order dated 17.06.2026 passed by Hon'ble High Court of Delhi in W.P. (C) 8211/2026 titled R.L. PATEL PRIMARY TRAINING COLLEGE VS NATIONAL COUNCIL FOR TEACHER EDUCATION & ANR., the Committee observed as under:

- In the first paragraph of show cause notice issued by WRC, NCTE vide Ref. No.NCTE/2025/WRC/PAR/322368/548 dated 28.03.2025, "...recognition order No. No.WRC/5-6/88/2006/ dated 15.09.2006 with annual intake of 50 students" is mentioned.
- In the first paragraph of withdrawal order issued by WRC,NCTE vide No. NCTE/2025/WRC/PAR/ORDER/322368/6969-73 dated 16.05.2025 "...Recognition/Permission order No.WRC/5-6/88/2006/ dated 15.09.2006, D.El.Ed. programme, approved annual intake of 50 students" is mentioned.
- In the first paragraph of Restoration Order issued by WRC,NCTE vide File No. NCTE/2026/WRC/PAR/REST/APW03200/322368/(8343-4346) dated 14/17.01.2026 "...for conducting D.El.Ed. course with an intake of 50 seats vide Order No. No.WRC/5-6/88/2006 dated 15.09.2006." is mentioned; in the concluding paragraph of said restoration order "...for conducting D.El.Ed. with an intake of 50 seats" is mentioned.

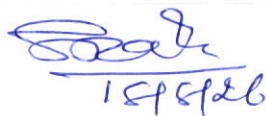
