- (i) The online application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:
- (ii) As per land details filled in the portal, khasra no.974. As per deficiency point 2, institution has uploaded photocopies/certified copies of digital jamabandi in respect of khasra nos.972/1 (0.86 hectare), 973/1/2 (1.1300 hectare), 974 (2.3300 hectare), 976 (0.9100 hectare), 992 (1.9000 hectare), 977 (2.0100 hectare), 990 (1.4000 hectare), 991 (2.3800 hectare), which may be perused by WRC. Till this stage of scrutiny, the institution has not uploaded duly filled in land related affidavit in the NCTE prescribed proforma as filled on the portal showing total land area, total built up area, mode of possession, location of land, land use certificate issued by govt. authority for educational purpose etc.
- (iii) The institution has uploaded Fire Safety Certificate issued by Fire Safety Department, Government of Rajasthan verifiable on the official portal of the Fire Department, Government of Rajasthan at URL https://lsgonline.rajasthan.gov.in/track_application.aspx The Plot area mentioned on this fire safety portal is 6725 sq.mts. whereas the land area mentioned by the institution on the ITEP portal is 23300 sq.mts. the land area/plot area is mismatched.
- (iv) The institution is required to upload Not-for-Profit Certificate issued by Competent Authority of State Government.
- (v) The copies of statements land use summary and allocated areas for different department(courses) certified by Registrar of Mody University of Science and Technology dated 29.10.2025 including building plans pertaining to different khasra nos. 973/1, 972/1, 978/1, 976, 990, 974 approved by Assistant Engineer, Laxmangarh Division, Sikar dated 25.09.2025 are uploaded. The name of multidisciplinary programme(s) filled in the application portal is not found reflected in the Registrar's land use summary statement showing name of courses being run by the university. As per given information in the certified statement of Registrar, out of total land area 31.925 acres, 3434.88 sq.mts. built up area is allocated to ITEP programme.

In view of the above, the application for ITEP is rejected.

Authority. and institution uploaded list stating that the Raj High court has issued stay on election from 2005.</p> <p>(x) The institution has uploaded Building Safety Certificate issued on 01/09/2022 by the Executive Engineer, Public Works Department, City Jaipur with a validity of 3 years. The validity of Building Safety Certificate is expired. The institution is required to upload the building safety certificate.</p> <p>(xi) The institution has uploaded Not-for-Profit Certificate issued by its Society and CA Firm. The certificate has not been issued by any Government Authority / Registrar of Societies.</p> <p>(xii) The institution has uploaded Non-Encumbrance Certificate (NEC) issued on 26/10/2023. However, it is required to upload the latest NEC issued by the Competent Government Authority.</p> <p>(xiii) The institution has uploaded land documents in the name of <i>Subadh Science College, Jaipur</i>, instead of in the name of the applicant/institution. The Committee noted that the institution was issued first show cause dated 12.09.2025 followed by final show cause noticed dated 27.10.2025. The institution has not uploaded reply of final show cause notice and the following deficiencies are still persisting:

- (i) The institution did not upload any reply of first Show Cause Notice dated 12.09.2025 followed by final SCN dated 27.10.2025 and following deficiencies are still persisting.
- (ii) The institution is required to upload letter of recommendation of the State Government / UT Administration.
- (iii) The institution is required to upload details of Affiliating Body and letter of NOC.
- (iv) The institution is required to upload the complete details of all Society/Trust/Member.
- (v) The institution is required to upload initial and latest affiliation orders issued by the Affiliating University for all multi-disciplinary programmes.
- (vi) The institution is required to upload the details of admitted students for all running programmes along with supporting documents.
- (vii) The institution is required to upload certified registered land documents clearly mentioning all the Khasra Nos. issued by Competent Authority of State Government showing that the building is situated on a single plot.
- (viii) The institution is required to upload Mutation Certificate mentioning Khasra/Plot/Survey No. issued by Competent Authority of State Government.

The institution is required to upload NAAC Certificate in the name of applicant institution. (ii) In uploaded NIRF Ranking document, the name of institution mentioned as ‘Central Sanskrit University, Delhi’ whereas the name of applicant institution is ‘Central Sanskrit University, Nashik Campus’. The institution is required to upload NIRF Ranking Certificate in the name of applicant institution. (iii) Building Safety Certificate uploaded is not in the name of institution/University/Society/Trust. (iv) Land Use Certificate uploaded is not in the name of institution/University/Society/Trust. (vii) Building Plan in the name of the institution/University/Society/Trust is not uploaded by the institution. (viii) The institution is required to upload Building Plan approved by the Competent Authority of State Government mentioning the name of institution, Khasra/Plot/Survey No. and mentioning the total land area and total built-up area earmarked for each course being run in the premises and the demarcated land area and built-up area for the teacher education programmes including multi-disciplinary programmes.

- (xi) Non -Encumbrance Certificate issued by the competent authority in the name of the institution/University/Society/Trust is not uploaded by the institution.

The institution is required to upload <u>LATEST</u> Non-Encumbrance Certificate (NEC) issued by Competent Authority of State Government indicating that the land is free from all encumbrances issued by Competent Government Authority.</p> <p>(v) The institution has uploaded the list of admitted students, but it has not uploaded the year-wise details of admitted students for all ongoing programmes approved by the affiliating body/university</p> <p>(vi) The institution has stated that it has applied for the Fire NOC at the Fire Department, Banipark, Jaipur, and that the department will issue the certificate soon, after which it will be submitted on the portal.</p> <p>(vii) The institution is conducting degree courses i.e. B.A. with 540x3=1620, B.Sc. 420x3=1260, B.Com. 180x3=540, M.A. 60x2=120, M.Sc. 50x2=100, M.Com 60x2=120 total combined intake of 3760. However, it cannot be ascertained from the uploaded bank statement as to whether the institution is paying each of its staff as per the pay scale prescribed the the Central/State Government in accordance to NCTE Norms & Standards.</p> <p>(x) The institution has uploaded Building Plan approved by the Assistant Engineer, PWD but not demarcated land area and built-up area for the teacher education programmes including multi-disciplinary programmes.</p> <p>Therefore, the Committee decided that Final Show Cause Notice be issued to the institution thereby providing an opportunity for making written representation through online ITEP application portal of NCTE, within 07 days along with all relevant supporting documents from the date of issue of Final Show Cause Notice.</p>

The Committee noted that the institution has not uploaded reply of Show Cause Notice dated 04.12.2025 post inspection and the following deficiencies mentioned in SCN are still persisting:

- (i) The institution is running so many courses and the approved intake of institution is i.e. B.A. 240x3=720, B.Com. 240x3=720, B..Sc. 420x3=1260, BCA 150x3=450, BBA 150x3=450, M.Sc. Physics 40x2=80, M.Sc. Chemistry 45x3=135, M.Sc. (Zoology) 40x2=80, M.Sc. Botany 40x2=80, M.Sc. Mathematics 40x2=80, M.A. (Political Science) 40x2=80, M.A. (English) 40x2=80, M.Com. (EAFM) 40x2=80, MA (Geography) 40x2=80 total approved intake is 4375. The sufficiency of land and built-up area for 4375 of approved intake of multidisciplinary courses intake for B.A.B.Ed Secondary (2 unit), Middle (2 unit), Foundational (2 unit), Preparatory (2 unit) B.Sc. B.Ed. Secondary (2 unit), Middle (2 unit), Foundational (2 unit), Preparatory (2 unit) B.Com. B.Ed. Secondary (2 unit), Middle (2 unit), Foundational (2 unit), Preparatory (2 unit) course cannot be ascertained.
- (ii) The institution has uploaded an affidavit and requested Committee to consider the effective intake capacity of 1300 students only in place of 4330 while assessing the sufficiency of land and built-up area and approve a total intake of 500 seats under ITEP in place of 1200 seats. This affidavit also cannot be ascertained.
- (iii) The institution has uploaded FORM NO. 10A issued by Income Tax Department and registration date is 04.04.2022. This is not the "Not for Profit" certificate.
- (iv) The link of website: - <https://podarcollege.com/ncteitep/> provided by the institution checked and found that is not functional.
