#### Decision of WRC

The matter of the institution and related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- (i) Recognition was granted for B.Ed course of one year duration with an annual intake of 100 (SEC) vide Order dated 31.03.2008.
- (ii) The institution has not submitted affidavit giving consent for conducting B.Ed. course of two years duration in consonance with NCTE regulation 2014.
- (iii) Revised order for B.Ed. two year duration was not issued to the institution.

The institution filed W.P.(C) 5765/2025 & C M APPL. 26338/2025 titled M K COLLEGE OF EDUCATION & ANR vs. NATIONAL COUNCIL FOR TEACHER EDUCATION & ANR. and Hon'ble High Court of Delhi vide its Order dated 16.05.2025 passed the following direction, the operative part of Court order is as under:

*“...6. Mr. Akhilesh K. Srivastava, learned Standing Counsel appearing on behalf of respondents states that the affidavit submitted by petitioner institution has not been received.*

*7. Accordingly, the petitioners are directed to submit fresh affidavit for acceptance and compliance of NCTE Regulation, 2014.*

*8. In the meantime, let respondents decide the request of petitioner institution for issuance of revised recognition order of petitioner institution for 100 seats expeditiously, preferably within six weeks from today.*

*9. In view of the above, the petition stands disposed of. Consequently, the pending application also stands disposed of.”*

Again, institution filed a contempt case CONT.CAS(C) 1905/2025 titled M K COLLEGE OF EDUCATION & ANR vs. MS RASHMI SHUKLA REGIONAL DIRECTOR WESTERN REGIONAL COMMITTEE NCTE & ANR. The Hon'ble High Court of Delhi vide its Order dated 12.12.2025 passed the following direction, the operative part of Court order is as under:

*“...5. Learned counsel appearing on behalf of the respondents accepts notice and submits that the original affidavit in terms of order dated 16.05.2025 has not been submitted by the petitioners; however they have received an e-mail regarding the same.*

*6. Learned counsel appearing on behalf of the petitioners submits that original affidavit will be handed over to the learned counsel for the respondents by 15.12.2025.*

*7. Learned counsel appearing on behalf of the respondents seeks one week's time to file a compliance report. Let a compliance affidavit be filed before the next date of hearing.*

8. *In case of non-compliance the concerned Officer shall remain present in the Court on the next date of hearing.*

9. *At request, re-notify on 23.12.2025.”*

The original affidavit dated 12.12.2025 received on 18.12.2025 from the institution in the office of WRC, NCTE regarding issuance of revised recognition order for B.Ed. course of two years duration with annual intake of 100 (two units of 50 students each) as per NCTE Regulations, 2014.

**In consideration of Court Order dated 12.12.2025, the Committee decided as under:**

**As per the direction of the Court, upon receiving the Original Affidavit dated 12.12.2025 received on 18.12.2025 from the institution in the office of WRC, NCTE, Revised Recognition Order for B.Ed. course of two years duration with annual intake of 100 (two basic units of 50 students each) be issued to the institution subject to fulfillment of conditions mentioned in the revised order with a copy endorsed to concerned State Government and Affiliating Body and all others concerned.**

**Further, the Committee observed that as a part of compliance report regarding fulfillment of conditions in pursuance of revised recognition order for B.Ed. course of two years duration, the institution is required to submit following certified documents along with an affidavit by the management of institution:**

- (i) The certified registered land document/title in the name of institution supported with original affidavit related with land in NCTE proforma.
- (ii) Mutation certificate issued by competent Govt. authority.
- (iii) Conversion of land from agriculture to educational purpose (CLU) issued by concerned Govt. Revenue Authority of State.
- (iv) Blueprint of approved Building plan certified by the Competent Govt. Authority indicating the name of the course, name of the institution, Khasra No./Plot No., total land area, total built-up area with the measurements of the Multipurpose Hall as well as other infrastructural facilities such as classrooms and other amenities etc.
- (v) Latest Non-Encumbrance Certificate (NEC) issued by Competent Authority of State Government indicating that the land is free from all encumbrances.
- (vi) Certified copy of site plan with demarcated land area for running different courses.
- (vii) Certificate to the effect that the building is differently abled friendly from the Competent Government Authority.
- (viii) Latest Building Completion Certificate (BCC) in the prescribed format of NCTE (17 points) issued by the Competent Government Authority for all the courses being conducted in the premises.
- (ix) Latest/current approved faculty list in original in NCTE prescribed proforma signed on each page by the respective Affiliating Body(ies) with date.
- (x) Six months bank statement in respect of each faculty member showing bank account no. duly attested by concerned Bank.
- (xi) Renewal copies of valid Fixed Deposit Receipts Nationalized/ Scheduled Bank towards Endowment & Reserve Fund in the joint operation mode with Regional Director, WRC, NCTE & Management along with duly filled Bank Form “A” in original, verified/ signed by the Manager of the Bank as per NCTE Regulations, 2014.
- (xii) Information related to creation and maintaining of institutional website updated in compliance to provisions under Clause 7(14)(i), 8(6), 8(14) and 10(3) of NCTE Regulations, 2014 as amended from time to time.

In addition to above, the institution is directed to submit the following:

- (i) Certified document regarding status of affiliation granted by the respective affiliating bodies from time to time since start of recognition for B.Ed. course till date of revised recognition order.
- (ii) Certified documents regarding permission (if any) granted by concerned State Govt./Affiliating Body in connection with shifting of institution to new premises without prior approval of NCTE, WRC.

**In view of the above, Committee decided as under:**

**Show Cause Notice u/S 17(1) be issued to the institution with the direction to submit above certified documents supported with an affidavit within 30 days from the date of issue of show cause notice.**

**Further, the concerned University/Affiliating Body be requested to intimate the detailed status of affiliation granted to B.Ed. course of this institution within 30 days from the date of issue of the letter.**

### **Decision of WRC**

The matter of the institution and related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- (i) Recognition was granted for M.Ed. course of one year duration with an annual intake of 25 (PG) vide Order dated 15.03.2008.
- (ii) The institution has not submitted affidavit giving consent for conducting M.Ed. course of two years duration in consonance with NCTE regulation 2014.
- (iii) Revised order for M.Ed. two year duration was not issued to the institution.

The institution filed W.P.(C) 5799/2025 & C M APPI.26410/2025 titled M K INSTITUTE OF EDUCATION AND RESEARCH & ANR. vs. NATIONAL COUNCIL FOR TEACHER EDUCATION & ANR. and Hon'ble High Court of Delhi vide its Order dated 16.05.2025 passed the following direction, the operative part of Court order is as under:

*“...6. Mr. Akhilesh K. Srivastava, learned Standing Counsel appearing on behalf of the respondents states that the affidavit submitted by petitioner institution has not been received.*

*7. Accordingly, the petitioners are directed to submit fresh affidavit for acceptance and compliance of NCTE Regulation, 2014.*

*8. In the meantime, let respondents decide the request of petitioner institution for issuance of revised recognition order of petitioner institution for 50 seats expeditiously, preferably within six weeks from today.*

9. *In view of the above, the petition stands disposed of. Consequently, the pending application also stands disposed of."*

Again, institution filed a contempt case CONT.CAS(C) 1901/2025 titled M K INSTITUTE OF EDUCATION AND RESEARCH & ANR. vs. MS RASHMI SHUKLA REGIONAL DIRECTOR WESTERN REGIONAL COMMITTEE NCTE & ANR. The Hon'ble High Court of Delhi vide its Order dated 12.12.2025 passed the following direction, the operative part of Court order is as under:

*"...5. Learned counsel appearing on behalf of the respondents accepts notice and submits that the original affidavit in terms of order dated 16.05.2025 has not been submitted by the petitioners; however they have received an e-mail regarding the same.*

*6. Learned counsel appearing on behalf of the petitioners submits that original affidavit will be handed over to the learned counsel for the respondents by 15.12.2025.*

*7. Learned counsel appearing on behalf of the respondents seeks one week's time to file a compliance report. Let a compliance affidavit be filed before the next date of hearing.*

*8. In case of non-compliance the concerned Officer shall remain present in the Court on the next date of hearing.*

*9. At request, re-notify on 23.12.2025."*

The original affidavit dated 12.12.2025 received on 18.12.2025 from the institution in the office of WRC, NCTE regarding issuance of revised recognition order for M.Ed. course of two years duration with annual intake of 50 (one basic unit) as per NCTE Regulations, 2014.

**In consideration of Court Order dated 12.12.2025, the Committee decided as under:**

**As per the direction of the Court, upon receiving the Original Affidavit dated 12.12.2025 received on 18.12.2025 from the institution in the office of WRC, NCTE, Revised Recognition Order for M.Ed. course of two years duration with annual intake of 50 (one basic unit) be issued to the institution with a copy endorsed to concerned State Government and Affiliating Body and all others concerned.**

**Further, the Committee observed that as a part of compliance report regarding fulfillment of conditions in pursuance of revised recognition order for M.Ed. course of two years duration, the institution is required to submit following certified documents along with an affidavit by the management of institution:**

- (i) The certified registered land document/title in the name of institution supported with original affidavit related with land in NCTE proforma.
- (ii) Mutation certificate issued by competent Govt. authority.
- (iii) Conversion of land from agriculture to educational purpose (CLU) issued by concerned Govt. Revenue Authority of State.
- (iv) Blueprint of approved Building plan certified by the Competent Govt. Authority indicating the name of the course, name of the institution, Khasra No./Plot No., total land area, total built-up area with the measurements of the Multipurpose Hall as well as other infrastructural facilities such as classrooms and other amenities etc.
- (v) Latest Non-Encumbrance Certificate (NEC) issued by Competent Authority of State Government indicating that the land is free from all encumbrances.

(vi)	Certified copy of site plan with demarcated land area for running different courses.
(vii)	Certificate to the effect that the building is differently abled friendly from the Competent Government Authority.
(viii)	Latest Building Completion Certificate (BCC) in the prescribed format of NCTE (17 points) issued by the Competent Government Authority for all the courses being conducted in the premises.
(ix)	Latest/current approved faculty list in original in NCTE prescribed proforma signed on each page by the respective Affiliating Body(ies) with date.
(x)	Six months bank statement in respect of each faculty member showing bank account no. duly attested by concerned Bank.
(xi)	Renewal copies of valid Fixed Deposit Receipts Nationalized/ Scheduled Bank towards Endowment & Reserve Fund in the joint operation mode with Regional Director, WRC, NCTE & Management along with duly filled Bank Form “A” in original, verified/ signed by the Manager of the Bank as per NCTE Regulations, 2014.
(xii)	Information related to creation and maintaining of institutional website updated in compliance to provisions under Clause 7(14)(i), 8(6), 8(14) and 10(3) of NCTE Regulations, 2014 as amended from time to time.

In addition to above, the institution is directed to submit the following:

- (i) Certified document regarding status of affiliation granted by the respective affiliating bodies from time to time since start of recognition for M.Ed. course till date of revised recognition order.
- (ii) Certified documents regarding permission (if any) granted by concerned State Govt./Affiliating Body in connection with shifting of institution to new premises without prior approval of NCTE, WRC.

**In view of the above, Committee decided as under:**

**Show Cause Notice u/S 17(1) be issued to the institution with the direction to submit above certified documents supported with an affidavit within 30 days from the date of issue of show cause notice.**

**Further, the concerned University/Affiliating Body be requested to intimate the detailed status of affiliation granted to M.Ed. course of this institution within 30 days from the date of issue of the letter.**
