<p>Decision of WRC:</p> <p>The file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:</p> <p>A copy of Complaint dated 20.03.2023 against the institution namely Siddhi Vinayak College, Plot No. 1445, Charthar Manpura Lahar Road, Village & Post Charthar, Tehsil & District-Bhind- 477001, Madhya Pradesh. was received from Complaint Division, NCTE Hqrs. through Email received in</p>			

WRC on 07.11.2025, wherein the complainant has mentioned regarding irregularities in respect of the availability of faculty and staff infrastructure and instructional facilities and documents submitted by the alleged institution. The Committee noted the complaint and decided that following documents may be sought from the institution:

- (i) The institution is required to submit the following documents in respect of its land and building located in its existing premises wherein recognition was granted by NCTE for B.Ed. courses.
- (ii) The institution is required to submit Building Plan approved by the Competent Authority of State Government indicating the Khasra/Plot/Survey No. and mentioning the total land area and built-up area earmarked for each course being run in the premises and the demarcated land and built-up area for the teacher education programmes
- (iii) The institution is required to submit Site Plan approved by the Competent Authority of State Government indicating the Khasra/Plot/Survey No. and mentioning the total land and built-up area earmarked for each course being run in the premises and the demarcated land area and built-up area for the teacher education programmes.
- (iv) The institution is required to submit the latest list of teaching staff for session 2024- 2025 and 2025-2026 for all the teacher education courses countersigned by the Registrar of affiliating body/Examining Body as per qualification contained in the NCTE Norms and Regulations as amended from time to time.
- (v) The institution is required to submit the bank statement of last six months for session 2024-2025 and 2025-2026 for all the teacher education courses indicating the transaction of the salary / remuneration to its teaching staff appointed for various courses separately.
- (vi) The institution is required to submit the list/details of students admitted for session 2024-2025 and 2025-2026 for all the teacher education courses.
- (vii) The institution is required to submit Fire Safety Certificate issued by Fire Safety Department, Government of Madhya Pradesh verifiable on the official portal of the Fire Department, Government of Madhya Pradesh.
- (viii) The institution is required to submit Building Safety Certificate in adherence of safety guidelines as prescribed by National/State Disaster Management Authority issued by Competent Government Authority.
- (ix) The institution is required to submit latest Non-Encumbrance Certificate issued by Competent Authority of State Government.
- (x) The institution is required to submit Mutation Certificate and certified land documents issued by Competent Authority of State Government.
- (xi) The institution is required to submit latest Building Completion Certificate in the prescribed format of NCTE (17 points) issued by the Competent Government Authority for all the courses being conducted in the premises.
- (xii) The institution is required to submit Land Use Certificate mentioning all Khasra Nos. issued by Competent Government Authority.
- (xiii) The institution is required to submit Form 'A' in original issued by Bank Manager of the concerned bank along with copies of valid FDRs towards Endowment and Reserve Fund in joint operation mode in reference to Clause 10 (1) of NCTE Regulations, 2014.
- (xiv) The website of institution has NOT been updated and maintained in compliance to provisions under Clause 7(14)(i), 8(6), 8(14) and 10(3) of NCTE Regulations, 2014 as amended from time to time.

In view of the above, the Committee decided as under:

- 1. Letter be issued to the institution with directions to submit reply along with requisite documents supported with an affidavit within 21 days from the date of issue of letter.**
- 2. The complaint to be forwarded to the Secretary, Department of Higher Education, Government of Madhya Pradesh, District Magistrate (DM), Bhind, Madhya Pradesh and the Registrar of the Affiliating University for taking necessary action by means of initiating investigation and submission of report on the allegations made in the complaint within 30 days from the date of issue of letter.**

The online application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time along with Visiting Team Report and the Committee observed as under:

- (i) The Principal of the college was absent during the inspection. The institution is required to clarify the same and upload the evidence regarding the same.
- (ii) The details of affiliating body and documents related to have not been presented to visiting team during inspection, the institution is required to clarify the same .
- (iii) The uploaded building plans are not of good resolution; the dimensions of the space cannot be read; therefore, they cannot be verified the institution is required to clarify the same. and upload the

- evidence regarding the same
- (iv) The uploaded building plans are not of good resolution; the dimensions of the space cannot be read; therefore, they cannot be verified the institution is required to clarify the same and upload the evidence regarding the same.
 - (v) There is not no provision of Lift or ramp for upper floors. Fire Safety certificate is not in the name of Institute the institution is required to clarify the same. and upload the evidence regarding the same
 - (vi) The details of multipurpose hall could not be verified as the uploaded building plan is not in good resolution to read by the VT Experts, the institution is required to clarify the same and upload the evidence regarding the same
 - (vii) The sitting capacity of the multipurpose hall is inadequate; the institution is required to clarify the same upload the evidence regarding the same
 - (viii) This College runs B.Ed. (2 Units), D.El.Ed. (2 Units), and B.A. B.Ed. (1 Unit) courses. However, as per NCTE Norms, a Multipurpose Hall must have a seating capacity of 200, yet this college only has seating arrangements for 100 students. This is below the required NCTE norms for the Teacher Education Institution. the institution is required to clarify the same.
 - (ix) The chairs in the Multipurpose Hall appear to be a temporary arrangement, as none of the chairs have the college name or chair number inscribed on them. The institution is required to clarify the same.
 - (x) The Fire Safety Certificate should be in the name of the college, but the current certificate is in the name of the society. This is not acceptable. the institution is required to clarify the same and upload the evidence regarding the same
 - (xi) The college does not have a Play Ground that meets the required standards for a college. the institution is required to clarify the same.
 - (xii) This College runs B.Ed. (2 Units), D.El.Ed. (2 Units), and B.A. B.Ed. (1 Unit) courses. However, the library's seating capacity is very low in proportion to the number of courses and units offered. The institution is required to clarify the same.
 - (xiii) This College runs B.Ed. (2 Units), D.El.Ed. (2 Units), and B.A. B.Ed. (1 Unit) courses. However, the library has only 4,207 books and 1,334 book titles, which is also very low given the number of courses and units. the institution is required to clarify the same.
 - (xiv) The building plans submitted are of insufficient quality (low resolution). Since the dimensions cannot be clearly read, we are unable to verify the spaces. The institution is required to clarify the same.
 - (xv) There is no lift or ramp available in this college for accessing the 1st floor and 2nd floor. the institution is required to clarify the same upload the evidence regarding the same.
 - (xvi) There is not no provision of Lift or ramp for upper floors. Fire Safety certificate is not in the name of Institute. the institution is required to clarify the same.
 - (xvii) The uploaded building plans are not of good resolution; the dimensions of the space cannot be read; therefore, they cannot be verified. the institution is required to clarify the same upload the evidence regarding the same

- (iv) The name and address of Institution is not mentioned in the Building Safety Certificate. There is no provision of Lift or Ramp for the upper floors. the institution is required to clarify the same.
- (v) The Building Completion Certificate shown to VT Expert does not have this salutation of issuing authority and the construction area is mismatch. the institution is required to clarify the same.
- (vi) Land Use Certificate is not in proper format. the institution is required to clarify the same.
- (vii) No of Books are in library are not verified and Institution fails to confirm the No. of books the institution is required to clarify the same.
- (viii) Academic facilities are available. Classroom, Lab, furniture are available and shown during the visit. Some books and journals needs to be added. Because land related details are not satisfactory so it may not be accepted. the institution is required to clarify the same.
- (ix) Land Use Certificate is not in proper format. the institution is required to clarify the same.

The online application of the University along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

The Committee noted that the University was issued first show cause dated 07.08.2025 followed by final show cause noticed dated 30.09.2025. The institution has uploaded reply of final show cause notice and the following deficiencies are still persisting:

- (i) The University did not upload any reply of first Show Cause Notice dated 06.08.2025 and following deficiencies are still persisting.
- (ii) The University has uploaded NIRF Ranking Certificate indicating the ranking 59 in pharmacy category. The University is required to upload NIRF Ranking Certificate in education category since the applicant is its Department of Education.
- (iii) The University has left the column of 'parent organization' as blank. It is required to fill the details of parent organization along with supporting documents.
- (iv) The University is required to upload initial and latest affiliation orders issued by the Affiliating University for all multi-disciplinary programmes.
- (v) Address of the Department of Education mentioned in the online application does not match with uploaded recognition order issued by NCTE for B.Ed./ M.Ed. Programmes & 4-Year Integrated programme leading to B.A. B.Ed./ B.Sc. B.Ed degree.
- (vi) Details of admitted students of the department of education of the university are mentioned without supporting documents. The University is required to upload the details of students admitted by it along with supporting documents.
- (vii) The University is required to upload certified land documents clearly mentioning all the Khasra Nos. issued by the Competent Government Authority and the building is situated on a single plot.
- (viii) The University is required to upload Mutation Certificate issued by Competent Authority of State Government.

- (ii) ‘Yaduvanshi College Of Education, Sohali, Buhana Road Sohali, Buhana, Buhana, Jhunjhunu, Rajasthan-333515’ is not running multi-disciplinary courses in the field of liberal arts, humanities, social sciences, commerce or mathematics as per Regulation No.NCTE-Regl011/80/2018-MS(Regulation)-HQ dated 26.10.2021 as amended from time to time and NCTE Public Notice No.NCTE-Regl012/7/2025-Reg. Sec-HQ dated 12.09.2025 related with extension of timeline to existing recognized teacher education institutions for transition from B.A.B.Ed./ B.Sc. B.Ed. Programme to ITEP before the start of academic session 2026-27. The institution does not fall in the category of multi-disciplinary institution.
- (iii) In the online application in the column of Multi Disciplinary Programme(s). Answer of Institution is YES, And the institute uploaded wrong information and wrong documents it multidisciplinary column. Institue uploaded the B.ED., and D.EL.ED. courses documents. The papers of this syllabus are uploaded. It is mandatory to institution that, they should upload the affiliation order of Multidisciplinary Programme(s) i.e. liberal arts, Science and Commerce. (i.e. B.A., B.Com, B.SC.). This institute does not run any multidisciplinary programme. The institution must fulfill the basic requirement of run a multidisciplinary program i.e. liberal arts, Science and Commerce.. If an institution does not fulfill the basic requirement of a multidisciplinary program, then that institution is not eligible to run the ITEP program. Hence, institution should prove that they are running the Multidisciplinary course i.e. liberal arts, Science and Commerce.
