Decision of WRC:

The file of the institution and related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

1. Latest Compliance Report with all relevant supporting documents certified by the management of the institution alongwith affidavit in connection with Revised Recognition Order dated 18.05.2015 for B.Ed. course of two years duration covering all points metioned therein is required to submit by the institution.
2. Comments on the irregularities communicated vide letter dated 13.11.2025 by the Commissionerate, College Education, Govt. of Rajasthan constituted Investigation Team regarding alleged complaint against the institution on the following issues:
 - (i) Charging of excess illegal fee from the students in addition to prescribed tuition fee by the institution.
 - (ii) Non-availability of clean drinking water in the institution campus for use by all concerned.
 - (iii) Non-furnishing of information to investigation team regarding scholarship of students admitted to the institution.
 - (iv) Non-furnishing of information to investigation team related with approved staff list by the concerned Affiliating Body.
 - (v) Non-operational of laboratories activities/classes in respect of B.Sc.B.Ed. course.
 - (vi) Charging of excess illegal fee in the name of kit, forwarding of form, final lesson by the institution.

In view of the above, the Committee decided as under:

Show Cause Notice u/S 17(1) of NCTE Act, 1993 be issued to the institution on the above points giving 15 days time to submit suitable reply along with certified document supported with affidavit by the management of institution. After submission of reply by the institution, matter be placed in WRC meeting.

Decision of WRC:

The file of the institution and related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:-

Following documents in notarized translated English version are required to submit by the institution under Clause 8(9) of NCTE Regulations, 2014 within 15 days from the date of issue of letter:

- (i) The certified registered land document/title in the name of institution supported with original affidavit related with land in NCTE proforma.
- (ii) Duly filled in application in NCTE proforma for shifting of premises.
- (iii) Notarised copy of Resolution passed by the Managing Body/Society/Trust along with affidavit regarding decision of the management for shifting of premises.
- (iv) NOC issued by State Govt. of Gujarat regarding proposed shifting of premises.
- (v) Mutation certificate issued by competent Govt. authority.
- (vi) Conversion of land from agriculture to educational purpose (CLU) issued by concerned Govt. Revenue Authority of State.
- (vii) Blueprint of approved Building plan certified by the Competent Govt. Authority indicating the name of the course, name of the institution, Khasra No./Plot No., total land area, total built-up area with the measurements of the Multipurpose Hall as well as other infrastructural facilities such as classrooms and other amenities etc.
- (viii) Latest Non-Encumbrance Certificate (NEC) issued by Competent Authority of State Government indicating that the land is free from all encumbrances.
- (ix) Certified copy of site plan with demarcated land area for running different courses.
- (x) Certificate to the effect that the building is differently abled friendly from the Competent Government Authority.
- (xi) Latest Building Completion Certificate (BCC) in the prescribed format of NCTE (17 points) issued by the Competent Government Authority for all the courses being conducted in the premises.
- (xii) Latest/current approved faculty list in original in NCTE prescribed proforma signed on each page by the Affiliating Body with date.
- (xiii) Six months bank statement in respect of each faculty member showing bank account no. duly attested by concerned Bank.
- (xiv) Renewal copies of valid Fixed Deposit Receipts Nationalized/ Scheduled Bank towards Endowment & Reserve Fund in the joint operation mode with Regional Director, WRC, NCTE & Management along with duly filled Bank Form “A” in original, verified/ signed by the Manager of the Bank as per NCTE Regulations, 2014.
- (xv) Information related to creation and maintaining of institutional website updated in compliance to provisions under Clause 7(14)(i), 8(6), 8(14) and 10(3) of NCTE Regulations, 2014 as amended from time to time.
- (xvi) Document certified by the management related with present status of affiliation together with copies all orders granting affiliation for P.T.C. course issued by the concerned Affiliating Body in respect of institution from time to time after grant of recognition by WRC, NCTE.
