- The MoU for merger has been signed by Asst. Registrar, Raj Rishi Bhartribari Matsya University, Alwar. However, approval of the University for the proposal for 'merger' between the institutions has not been approved by their affiliating university, as required under Clause 4.2.2 of the NCTE Guidelines for transforming into multidisciplinary higher education institutions. The institution is required to upload the same.

- The institution is conducting degree courses i.e. Bachelor of Education (B.Ed) degree. 2 Units, 4-Year Integrated programme leading to B.A. B.Ed./ B.Sc. B.Ed degree 2 Units. The sufficiency of land and built-up area for the above courses cannot be ascertained.
- In the column of Society/Trust/Company members information, the institution has filled information of Chairman/president/Secretary and treasurer with PAN & Aadhar no. only. It is required to mention all Society members with PAN & Aadhar No.
- The institution is required to upload the admitted students list countersigned by Affiliating University.
- The institution website WWW.SBAVPTTC.COM is not operational. The website of the institution has not been updated and maintained in compliance to provisions under Clause 7(14)(i), 8(6), 8(14) and 10(3) of NCTE Regulations as amended from time to time.

- Khasra No. 416/379 and 748/603 mentioned as per portal in the address whereas uploaded land documents in respect of only khasra no. 416/379 bearing land area 2496.22 sqm. Total land area as per portal 11813.06 sqm which is not reflecting in the land documents. Land affidavit in NCTE prescribed Proforma duly filled in is not uploaded. The institution is required to clarify the same and upload all Land documents as per NCTE Norms.
- Against exemption certificate, the institution has uploaded order of registration u/s 12AA (1)(b) dated 20.03.2015.
- The institution is required to upload Mutation Certificate (Jamabandi) mentioning all Khasra/Plot/Survey No. issued by Competent Authority of State Government.
- CLU dated 25.02.2013 in the respect of only khasra no 416/369 bearing total land area mentioned is 2496.22 sqm wherein another Khasra no.748/603 is not mentioned. Total land area filled on the portal towards converted / diverted land area under the CLU for only khasra no.416/379 is 11813.06 sq.mts. whereas same total land area 11813.06 sq.mts. filled on the portal in Land details for both khasra no.416/379 & 748/603 which is contradictory. The institution is required to clarify the same
- The institution is required to upload Land Use Certificate (CLU) as per Rajasthan Urban Areas (Permission for use of Agricultural Land for Non-Agricultural Purposes and Allotment) Rules, 2012 in Form-11 of Rule 7(1) while mentioning all Khasra/Plot/Survey No. issued by Competent Government Authority.
- The institution is required to upload latest Non-Encumbrance Certificate (NEC) issued by Competent Authority of State Government indicating that the land is free from all encumbrances issued by Competent Government Authority
- As per given geographic location, the name of institution is not shown on google map, it shows "Kuber Resort (Best Hotel & Restaurant/Marriage...)". The institution is required to clarify the same
- The institution is required to provide proof that all khasra number i.e. 416/379 & 748/603 are a single plot.
- The institution is required to upload Building Plan approved by the Competent Authority of State Government mentioning the name of institution, Khasra/Plot/Survey No. and mentioning the total land area and total built-up area. But earmarked for each course being run in the premises and the demarcated land area and built-up area for the teacher education programmes including multi-disciplinary programmes.
- The institution is required to upload the list of teaching staff of all Education Faculty Programmes duly approved and countersigned by its affiliating body. The institution is required to upload the bank statement of last six months indicating the transaction of the salary / remuneration to its teaching staff
- The institution is required to upload geotag photos with different angles of Lift, Ramp, Electricity, Safe Drinking Water and Accessible Toilet indicating the longitude and latitude with date of photograph.
- The institution is required to upload Fire Safety Certificate issued by Fire Safety Department, Government of Rajasthan verifiable on the official portal of the Fire Department, Government of Rajasthan at URL https://lsgonline.rajasthan.gov.in/track_application.aspx.
- The institution is required to upload Building Safety Certificate in adherence of safety guidelines as prescribed by National/State Disaster Management Authority issued by Competent Government Authority.
- The institution is required to upload geotag photos with different angles of front view, rear view, multipurpose hall, library, lab 1, lab 2, lab 3 and playground indicating the longitude and latitude with date of photograph
- The institution is required to upload the Building Disabled Friendly Certificate issued by the Competent Authority of the State Government.

- Uploaded Building Completion Certificate shows that location of institution having two plots with khasra no.416/379 & 748/603 in a distance of 500 mts. for B.A.B.Ed. & B.Sc.B.Ed. Integrated Course. The earmarked land area and built up area showing break up of all teacher education courses in the campus is not reflected in the BCC. The BCC is certified by Sahayak Abhiyanta, Nagar Parishad (without date). Date of CLU pertaining to one Khasra no.416/379 as per portal and uploaded document is 25.02.2013, whereas mentioned in the BCC as 02.03.2016, both dates do not match. The institution is required to clarify the same.

Therefore, the Committee decided that Final Show Cause Notice be issued to the institution u/s 14 (3) (b) / 15 (3) (b) of the NCTE Act, 1993 thereby providing an opportunity for making representation through online transition application portal of NCTE, within 07 days along with all relevant supporting documents from the date of issue of Show Cause Notice.
