**Decision of WRC:**

In terms of Section 14 (1)/15 (1) of the NCTE Act, 1993, the online application of institution for 4-Year Integrated Teacher Education Programme (ITEP) along with NCTE Act, 1993, Reply of the institution, Regulations, Guidelines issued by NCTE from time to time and documents uploaded by the institution were carefully considered by the WRC, NCTE and the Committee observed as under:

- i. The institution is conducting degree courses i.e. B.A. (240x3) =720, B.Sc. (240x3)720, B.Com. (240x3) 720, BBA 60x3=180, B.C.A.60x3=180, M.A.40x2=80, M.Sc.CS-20x2=40, M.Sc.20x2=40, as per college website they are running the B.A. Hons. (Four Year Degree Program), B.Sc. Hons. (Four Year Degree Program) B.Com. with Hons. (Four Year Degree Programme), the sufficiency of land and built-up area for the above courses with combined intake of multidisciplinary courses and B.A./B.Ed. (Secondary-2 Units) B.Com. B.Ed. (Secondary 1 Unit) course cannot be ascertained. According to the land details, the built-up area of the institute is 11957.61 square meters. The mode of land acquisition is by lease method. The available construction area of 11957.61 square meters is not enough to run all the courses.
- ii. In the No Objection Certificate for Introducing New Course of ITEP vide letter No.AIL/13/VOL/IV Defence Estates Officer, Jodhpur Circle, Jodhpur, Raksha Sampada Bhawan Military Hospital Road, Jodhpur dated 30/4/2025, it is mentioned in point 5 that “However, this NOC does not entitle any change in name in GLR/Lease deed and it does not entitle or condone any deviating from lease or breach of lease conditions. Further it does not entitle or permit any erection/construction work.
- iii. The institution has not submitted the mutation certificate of land. But they give this reply “The College is situated on Defence Lease Land owned by the Government of India, so the Defence Estates Officer, Jodhpur has stated that the Mutation of Land cannot be done and is not required by the College.”
- iv. The Fire Safety Certificate uploaded by the institution is expired on 26th August, 2025.
- v. The institution has not uploaded Land Use Certificate (CLU) as per Rajasthan Urban Areas (Permission for use of Agricultural Land for Non-Agricultural Purposes and Allotment) Rules, 2012 in Form-11 of Rule 7(1) while mentioning all Khasra/Plot/Survey No. issued by Competent Government Authority.
- vi. Uploaded Building Plans main pages are not readable. The institution in his answer accepted that, “Some of the Buildings are very old completed in 1962, & 1967.” Here the question of building safety arises. The institution has not uploaded readable Building Plans.

**Therefore, the Committee decided that application submitted by the institution for ITEP Course be refused u/s 14 (3) (b)/15 (3) (b) of the NCTE Act, 1993.**

**Decision of WRC:**

In terms of Section 14 (1)/15 (1) of the NCTE Act, 1993, the online application of institution for 4-Year Integrated Teacher Education Programme (ITEP) along with NCTE Act, 1993, Reply of the institution, Regulations, Guidelines issued by NCTE from time to time and documents uploaded by the institution were carefully considered by the WRC, NCTE and the Committee observed as under:

- (i) The institution has not uploaded latest Building Completion Certificate (BCC) in the prescribed format of NCTE (17 points) issued by the Competent Government Authority for all the courses being conducted in the premises. Further, the institution has mentioned the Total Built-up area 10186 sq.mts. in the BCC whereas it has indicated the built-up area 9969.32 sq.mts. in the column of land details of the ITEP portal; both the areas mismatched. The institution has earmarked 1914.49 sq.mts. for teacher education programmes. The earmarked area is inadequate as per NCTE norms.
- (ii) Uploaded Building Plans main pages are not readable. The institution has not uploaded Building Plan approved by the Competent Authority of State Government indicating the Khasra/Plot/Survey No. and mentioning the total land area and built-up area earmarked for each course being run in the premises and the demarcated land area and built-up area for the teacher education programmes including multi-disciplinary programmes.
- (iii) The institution is conducting degree courses i.e. B.A. intake (100), B.Sc. intake (100), B.Sc.(computer science) intake(48) B.Com. intake (100), B.Com. (A&F) intake (60), BMS intake (60), and M.Com. intake (60), Course with combined annual intake of 528. The sufficiency of land and built-up area for 528 intake of multidisciplinary courses and 50 intake for B.Ed. and 100 intake for proposed ITEP course cannot be ascertained. According to the land details, the built-up area of the institute is 9969.32 square meters. The available construction area of 9969.32 square meters is not enough to run all the courses.
- (iv) The institution website is still not updated as per NCTE norms and Regulations.
- (v) The Institution has not uploaded the Fire Safety Certificate issued by competent authority. (The institution has uploaded No Objection Certificate for Fire Fighting arrangements purpose only valid up to 31.12.2025)
- (vi) The website of institution has NOT been found operational at the time of verification. The institution has not created, maintained and updated its website in compliance to provisions under Clause 7(14)(i), 8(6), 8(14) & 10(3) of NCTE Regulations, 2014 as amended from time to time.
- (vii) The institution has not uploaded the Land Use Certificate mentioning all Khasra Nos. issued by Competent Government Authority.
- (viii) The institution has not uploaded latest Non-Encumbrance Certificate (NEC) issued by Competent Authority of State Government.
- (ix) The institution has not uploaded Building Safety Certificate in adherence of safety guidelines as prescribed by National/State Disaster Management Authority issued by Competent Government Authority.
- (x) The institution has uploaded permanent affiliation order dated 25.03.1997 in the name of Royal Higher Education Society's, College of Arts, Science and Commerce and uploaded certificate dated 05.06.2025 for affiliation from the academic session 2025-2026 in the name of Royal College of Education and Research for Women. Both the names mismatch.

**Therefore, the Committee decided that application submitted by the institution for ITEP Course be refused u/s 14 (3) (b) / 15 (3) (b) of the NCTE Act, 1993.**

**Decision of WRC:**

In terms of Section 14 (1)/15 (1) of the NCTE Act, 1993, the online application of institution for 4-Year Integrated Teacher Education Programme (ITEP) along with NCTE Act, 1993, Reply of the institution, Regulations, Guidelines issued by NCTE from time to time and documents uploaded by the institution were carefully considered by the WRC, NCTE and the Committee observed as under:

- (i) The institution has uploaded Fire Safety Certificate vide No.LSG/JAIPUR GREATER/FIRENOC/2025-26/53620 issued by Fire Safety Department, Government of Rajasthan which has been verified on the official portal of the Fire Department, Government of Rajasthan at URL [https://lsgonline.rajasthan.gov.in/track\\_application.aspx](https://lsgonline.rajasthan.gov.in/track_application.aspx) it is valid up to 07.08.2027 and the Plot area mentioned on the fire safety portal is 1720 sq.mts, whereas the institution has claimed land area on the ITEP portal is 40666 sq.mts. The land area/plot area is mismatched.
- (ii) The Institution has not uploaded the proper readable building plan approved and issued by government competent authority. The institution has uploaded Building Plan approved by the Assistant Engineer of PWD. However, the total land area and total built-up area earmarked for each course being run in the premises and the demarcated land area and built-up area for the teacher education programmes including multi-disciplinary programmes is not clearly legible. The institution is required to upload the proper approved building plan.
- (iii) The institution has uploaded Building Plan approved by the Competent Authority of State Government indicating the Khasra No.462. However, the total land area and built-up area earmarked for each course being run in the premises and the demarcated land area and built-up area for the teacher education programmes including multi-disciplinary programmes is not mentioned.
- (iv) The institution has not uploaded the legible Mutation Certificate mentioning Khasra/Plot/Survey No. issued by Competent Authority of State Government.
- (v) The Institution has not uploaded the legible documents of Bye-laws of Society/Trust.
- (vi) The institution is required to upload Land Use Certificate (CLU) as per Rajasthan Urban Areas (Permission for use of Agricultural Land for Non-Agricultural Purposes and Allotment) Rules, 2012 in Form-11 of Rule 7(1) while mentioning all Khasra/Plot/Survey No. issued by Competent Government Authority.
- (vii) The institution website is still not updated as per NCTE norms and regulations.
- (viii) The institution has not uploaded Land Use Certificate (CLU) as per Rajasthan Urban Areas (Permission for use of Agricultural Land for Non-Agricultural Purposes and Allotment) Rules, 2012 in Form-11 of Rule 7(1) while mentioning all Khasra/Plot/Survey No. issued by Competent Government Authority.
- (ix) The institution is conducting degree courses i.e. B.A.  $600 \times 3 = 1800$ , B.Com.  $780 \times 3 = 2340$ , B.Sc.  $780 \times 3 = 2340$ , M.A.  $40 \times 2 = 80$ , M.Com.  $40 \times 2 = 80$  M.Sc.  $40 \times 2 = 80$ . The sufficiency of land and built-up area for the above courses with 6720 intake of multidisciplinary courses and B.A.B.Ed. Secondary (1 unit), Middle (1 unit), Foundational (1 unit), Preparatory (1 unit), B.Sc. B.Ed. Secondary (1 unit), Middle (1 unit), Foundational (1 unit), Preparatory (1 unit) and B.Com.B.Ed. Secondary (1 unit)course cannot be ascertained.
- (x) The institution has uploaded photocopy of all details of Society/ Trust/ Company Members with partially legible stamp of certifying authority. The Registration number of Society is not mentioned on it. However, it has not issued/approved by Competent Govt. Authority. and institution uploaded list stating that the Rajasthan High Court has vacated the stay on election.
- (xi) The institution has not uploaded Not-for-Profit Certificate issued by any Government Authority/ Registrar of Societies.
- (xii) The institution has not uploaded the latest Non-Encumbrance Certificate (NEC) issued by the Competent Government Authority.
- (xiii) The institution has uploaded land documents in the name of *Subadh Science College, Jaipur*, instead of in the name of the applicant/institution. The institution has also uploaded an affidavit and a land authorization letter on stamp paper dated 04.09.2025, as per the admissible government rate, mentioning Khasra No.462 with a total land area of 10 acres. However, the institution has

not uploaded certified land documents issued by the Revenue Department, clearly mentioning the name of the institution/society and the relevant Khasra number(s). In addition, the institution has not clarified the specific portion of land allotted for the Teacher Education Programme, and same has not been clearly indicated in the submitted documents.

**Therefore, the Committee decided that application submitted by the institution for ITEP Course be refused u/s 14 (3) (b)/ 15 (3) (b) of the NCTE Act, 1993.**

#### Decision of WRC:

In terms of Section 14 (1)/15 (1) of the NCTE Act, 1993, the online application of institution for transition from B.A.B.Ed./ B.Sc. B.Ed. Programme to 4-Year Integrated Teacher Education Programme (ITEP) for the session 2026-27 along with NCTE Act, 1993, Regulations, Reply submitted by the institution, Guidelines issued by NCTE from time to time and documents uploaded by the institution were carefully considered by the WRC, NCTE and the Committee observed as under:

- i. The institution has expressed its intention to become a multidisciplinary institution through collaboration, as stipulated in the NCTE Guidelines for transforming NCTE recognized stand-alone teacher education institutions into multidisciplinary higher education institutions.
- ii. The institution is required to upload the certificate issued by the Government of Rajasthan justifying the requirement for a teacher education programme in the area, as required under Clause 4.3(i) of the NCTE Guidelines for transforming into Multidisciplinary Institutions.
- iii. The proposal for collaboration between the institutions has not been approved by their affiliating university, as required under Clause 4.3(a) of the NCTE Guidelines for transforming into Multidisciplinary Institutions. The institution is required to upload the same.
- iv. The name of the institution to be collaborated with as mentioned in the Memorandum of Collaboration uploaded by the institution is 'Jeevan Mahavidyalaya', whereas in the affiliation letter dated 03.09.2024 issued by Pandit Deendayal Upadhyaya Shekhawati University, the name of institution mentioned as 'Shri Jeevan Mahavidyalaya'. The institution is required to clarify the same and upload the evidence regarding the same.
- v. The institution is required to upload the documentary evidence that both institutions proposed for collaboration are affiliated with the same university.
- vi. The website of institution has NOT been updated and maintained in compliance to provisions under Clause 7(14)(i), 8(6), 8(14) and 10(3) of NCTE Regulations, 2014 as amended from time to time. The institution is required to upload the same.
- vii. The institution is required to upload the category of Institution in the institution details.
- viii. The institution is required to upload the NOC of affiliating body vide letter No.2023-24/18787 dated 18/06/2024 as mentioned in the portal. The institution is required to clarify the same why they uploaded the old NOC.
- ix. The institution is required to upload the Authorization letter on the stamp paper as per admissible government rate
- x. The institution is required to upload the Not for Profit Certificate issued by the Competent Government Authority.
- xi. The institution is required to upload the Exemption Certificate (Form 12A) issued by the Income Tax Department or issued by government competent authority
- xii. The institution is required to upload the revised order for B.Ed course.

xiii. In the column of Society/Trust/Company members information, the institution has filled information of Chairman/president/Secretary and treasurer with PAN & Aadhar no. only. It is required to mention all Society members with PAN & Aadhar No.

xiv. For confirming the institution's eligible for transition into ITEP course as it is Collaboration, institution is required to upload the affiliation order of liberal arts, science and commerce all programmes run by them with intake capacity as a Multi-Disciplinary Institution

xv. The Institution is required to upload information of all programme/courses run by institution in the campus.

xvi. The institution is required to upload year-wise the admitted students list in respect of all running programme(s) countersigned by Affiliating University.

xvii. The institution is conducting the teacher education Bachelor of Education (B.Ed) degree. 2 units B.A. B.Ed. Secondary (1 unit), B.Sc. B.Ed. Secondary (1 unit). The sufficiency of land area and built-up area for the above courses and intake for above course cannot be ascertained.

xviii. The institution is required to provide proof that all khasra numbers i.e. 342,344, 345, 346, 236,237,238, are in a single plot, upload a proof issued by government competent authority.

xix. The institution has mentioned the total land area as 4000 sqm and built up area as 4000 sq, which is less than required as per NCTE norms and regulations. The institution is required to clarify the same.

xx. The institution is required to upload the Land related affidavit in NCTE prescribed proforma as per details filled in the online application portal.

xxi. The institution is required to upload Mutation (Jamabandi) Certificate mentioning all Khasra/Plot/Survey No. issued by Competent Authority of State Government.

xxii. The institution is required to upload Land Use Certificate (CLU) as per Rajasthan Urban Areas (Permission for use of Agricultural Land for Non-Agricultural Purposes and Allotment) Rules, 2012 in Form-11 of Rule 7(1) while mentioning all Khasra/Plot/Survey No. issued by Competent Government Authority.

xxiii. The institution has uploaded the NEC issued in the year 2017. The institution is required to upload latest Non-Encumbrance Certificate (NEC) issued by Competent Authority of State Government indicating that the land is free from all encumbrances issued by Competent Government Authority.

xxiv. The institution is required to upload Building Plan approved by the Competent Authority of State Government mentioning the name of institution, Khasra/Plot/Survey No. and mentioning the total land area and total built-up area. But earmarked for each course being run in the premises and the demarcated land area and built-up area for the teacher education programmes including multi-disciplinary programmes.

xxv. The institution is required to upload geotag photos with different angles of Lift, Ramp, Electricity, Safe Drinking Water and Accessible Toilet indicating the longitude and latitude with date of photograph.

xxvi. The institution is required to upload Fire Safety Certificate issued by Fire Safety Department, Government of Rajasthan verifiable on the official portal of the Fire Department, Government of Rajasthan at URL [https://lsgonline.rajasthan.gov.in/track\\_application.aspx](https://lsgonline.rajasthan.gov.in/track_application.aspx).

xxvii. The institution is required to upload Building Safety Certificate in adherence of safety guidelines as prescribed by National/State Disaster Management Authority issued by Competent Government Authority.

xxviii. The institution is required to upload geotag photos with different angles of front view, rear view, multipurpose hall, library, lab 1, lab 2, lab 3 and playground indicating the longitude and latitude with date of photograph.

xxix. As per the building plan and BCC uploaded, the institution has mentioned the total land area as 3000 sq.m. whereas in the application form, the institution has mentioned the land area as 4000 sq.m. The institution is required to clarify this discrepancy.

xxx. The Building completion certificate uploaded by the institution is not completely filled in. The institution is required to upload the completed BCC duly approved by the Competent Authority of the State Government.

**Therefore, the Committee decided that Final Show Cause Notice be issued to the institution u/s 14 (3) (b)/ 15 (3) (b) of the NCTE Act, 1993, thereby providing an opportunity for making representation**

**through online transition application portal of NCTE, within 7 days along with all relevant supporting documents from the date of issue of Show Cause Notice.**

**Decision of WRC:**

In terms of Section 14 (1)/15 (1) of the NCTE Act, 1993, the online application of institution for transition from B.A.B.Ed./ B.Sc. B.Ed. Programme to 4-Year Integrated Teacher Education Programme (ITEP) for the session 2026-27 along with NCTE Act, 1993, Regulations, Reply submitted by the institution, Guidelines issued by NCTE from time to time and documents uploaded by the institution were carefully considered by the WRC, NCTE and the Committee observed as under:

- i. TEI is required to upload copy of Not-for-Profit Certificate issued by the concerned govt. competent authority.
- ii. The institution is required to upload the list of teaching staff duly approved and countersigned by its affiliating body as per NCTE norms and standards for all teacher Education Programme run by institution. Uploaded teaching staff list is not as per NCTE norms. The institute is required to upload the list of teaching staff for all teacher education programmes run by the institute as per NCTE norms.
- iii. TEI is required to upload the latest Teaching Staff in NCTE prescribed format for the latest Academic Year (i.e. 2025-26) duly approved by the Registrar of the affiliating University with requisite documents.
- iv. Salary of employees should be as per NCTE norms/ State Govt norms. Payroll of employees should match with approved list of employees and uploaded website list. Committee cannot determine 6 months' salary from uploaded bank documents. The institution is required to upload institution's bank salary documents to prove that the institution is disbursing the salary to approved staff as per NCTE norms / State Govt norms.
- v. The institution is conducting degree courses i.e. B.A.  $60 \times 3 = 180$ , B.Sc.  $60 \times 3 = 180$ . The sufficiency of land area and built-up area for the above courses with of multidisciplinary courses and intake for B.A. B.Ed. (Secondary 1 Unit) B.Sc. B.Ed. (Secondary 1 Unit) course cannot be ascertained. Institution has not uploaded any proof and replied that "THE INSTITUTION AFTER APPLYING FOR TRANSITION TO ITEP HAS BUILD ONE MORE FLOOR TO THE EXISTING BUILDING. THUS, MAKING THE INFRASTRUCTURE SUFFICIENT FOR UG COURSE AND ITEP." The institution is required to upload evidence of the same.
- vi. TEI is required to upload documents in respect to extension of infrastructure; i.e. building permission for the extension of building with approved building plan duly approved by Govt. authority and Building Completion Certificate issued by competent authority along with all such documents issued prior to extension of building. geotag photos of new constructed building and others.
- vii. The institution has mentioned to become Multi disciplinary institution by itself. In support of same, it has submitted that the society is also running an undergraduate course with name 'Sadguru College' whereas the name of institution recognized by NCTE is 'Sadguru Institute of Education'. This is not acceptable for Committee. If the institution desire to apply in "collaboration" category they should submit the all documents for "Collaboration" category.
- viii. Committee checked the website of institution i.e. <http://www.sadguruinstitute.org>. The website of institution <http://www.sadguruinstitute.org> has NOT been updated and maintained in compliance to provisions under Clause 7(14)(i), 8(6), 8(14) and 10(3) of NCTE Regulations, 2014 as amended from time to time still this date. The institution is required to upload the same as per NCTE norms and regulations.

- xiv. The institution is required to upload Mutation (Jamabandi) Certificate mentioning all Khasra/Plot/Survey No. issued by Competent Authority of State Government.
- xv. The institution is required to upload Land Use Certificate (CLU) as per Rajasthan Urban Areas (Permission for use of Agricultural Land for Non-Agricultural Purposes and Allotment) Rules, 2012 in Form-11 of Rule 7(1) while mentioning all Khasra/Plot/Survey No. issued by Competent Government Authority.
- xvi. The institution is required to upload latest Non-Encumbrance Certificate (NEC) issued by Competent Authority of State Government indicating that the land is free from all encumbrances issued by Competent Government Authority.
- xvii. The institution is required to upload Building Plan approved by the Competent Authority of State Government mentioning the name of institution, Khasra/Plot/Survey No. and mentioning the total land area and total built-up area earmarked for each course being run in the premises and the demarcated land area and built-up area for the teacher education programmes including multi-disciplinary programmes.
- xviii. The institution is required to upload the list of teaching staff of all Education Faculty Programmes duly approved and countersigned by its affiliating body. The institution is required to upload the bank statement of last six months indicating the transaction of the salary / remuneration to its teaching staff.
- xix. The institution is required to upload geotag photos with different angles of Lift, Ramp, Electricity, Safe Drinking Water and Accessible Toilets indicating the longitude and latitude with date of photograph.
- xx. The institution is required to upload Fire Safety Certificate issued by Fire Safety Department, Government of Rajasthan verifiable on the official portal of the Fire Department, Government of Rajasthan at URL [https://lsgonline.rajasthan.gov.in/track\\_application.aspx](https://lsgonline.rajasthan.gov.in/track_application.aspx).
- xxi. The institution is required to upload Building Safety Certificate in adherence of safety guidelines as prescribed by National/State Disaster Management Authority issued by Competent Government Authority.
- xxii. The institution is required to upload geotag photos with different angles of front view, rear view, multipurpose hall, library, lab 1, lab 2, lab 3 and playground indicating the longitude and latitude with date of photograph.
- xxiii. The institution is required to submit the demarcated site plan duly approved by the competent authority of the state government earmarking the land & built-up area for ITEP course and other courses/ school being run in the premises.

**Therefore, the Committee decided that Final Show Cause Notice be issued to the institution u/s 14 (3) (b)/ 15 (3) (b) of the NCTE Act, 1993, thereby providing an opportunity for making representation through online transition application portal of NCTE, within 7 days along with all relevant supporting documents from the date of issue of Show Cause Notice.**
