- The institution website <https://mgkss.in> is not operational at the time of scrutiny. The institution is required to update and maintain the website in compliance to provisions under Clause 7(14)(i), 8(6), 8(14) and 10(3) of NCTE Regulations, 2014 as amended from time to time.
- The Institution is required to upload the category of Institution in the institution details.
- The Institution is required to upload the Authorization letter on the stamp paper as per admissible government rate.
- The institution is required to upload the NOC of affiliating body 7487 dated 23/06/2018 as mentioned in the portal. The institution is required to clarify the same why they uploaded the old NOC.
- The institution is required to upload the Not-for-Profit Certificate issued by government competent authority
- The institution is required to upload the Exemption Certificate (Form 12A) issued by the Income Tax Department or issued by government competent authority.
- In the column of Society/Trust/Company members information, the institution has filled information of Chairman/president/Secretary and treasurer with PAN & Aadhar No. only. It

Decision of WRC:

The file of the institution and related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

1. At the first instance, Conditional Recognition under Clause 7(11) of NCTE Regulations, 2005 was granted to institution viz. Sarve Manglam Education Trust; Sanskar P.T.C. Coll, at the address: Dhanpura, C/o Patel Babubhai Mangalbhair, 38/ Maheshwar Society, Manipur Road, At & Post Vijapur, Mehsana 382870 Gujarat for P.T.C. course with intake of 50 vide order dated 03.05.2007 with information to appoint requisite faculty members/ staff as per NCTE norms and standards and related affidavits may be submitted / uploaded on their website. It is mentioned therein that institution shall make admission only after it obtains unconditional letter of recognition from the WRC and affiliation from the examining body which are conditions precedent as per Regulation 8(10) of the Regulation, 2005.
2. Show Cause Notice dated 14.06.2007 was issued pointing out deficiencies (i) N.A. is not found in the name of trust; (ii) No land of its own – the location of college at Dhanpura, Dist. Mehsana in the application location shown at Kanbha, Dist. Mehsana; (iii) Affidavit not found in the website.

3. Formal recognition for P.T.C. course with intake of 50 was issued vide order dated 08.02.2008.
4. Original FDR of Rs.5.00 lakh bearing No.3412028 and original FDR of Rs.3.00 lakh bearing No.3412029 towards Endowment and Reserve Fund were returned to the institution vide WRC's letter dated 08.04.2008.
5. Application dated 11.05.2011 regarding shifting of premises as per provisions under Section 8(11) of NCTE Regulations, 2007 was considered by WRC and as per decision of WRC, Show Cause Notice dated 05.08.2011 was issued u/S 17(1) to submit (i) Certified copy of the land documents (ii) Notarized CLU from competent authority.
6. Reply received from the institution was considered by WRC in its 154th meeting held on 11th-12th September, 2011. The Committee decided that change of premises be refused on the grounds (i) Certified copy of the land documents not submitted; (ii) Notarized copy of CLU from the competent authority not submitted. Accordingly, refusal order for shifting application was issued vide order dated 12.11.2011.
7. Further, the Committee in its 154th meeting decided that inspection of the old site be caused under Section 17 of NCTE Act, 1993. Accordingly, Visiting Team submitted inspection report dated 26.11.2011 stating that visiting team refused to undergo inspection under Section 17 at Kanbha, Ta. Vijapur, Dist. Mehsana attaching original letter dated 26.11.2011 of society/trust/institution addressed to RD, WRC along with copy of resolution of trust dated 24.11.2011 signed by Sanchalak, Sarva Mangalam Education Trust to close P.T.C. Course in the academic year 2012-13.
8. The VT report and related documents was considered by WRC in its 157th meeting held on 8th-9th December, 2011 and accordingly, Show Cause Notice dated 13.03.2012 was issued on the ground *"The Committee considered the matter and decided that the show cause notice be issued informing the Trust that the Committee is in receipt of the decision of the Trust to close down the institution from the academic session 2012-12 and thus recognition granted to the institution will discontinue after the current academic session 2011-2012 is over."*
9. Reply of SCN submitted vide letter dated 09.04.2012 by the institution enclosing another copy of resolution dated 17.03.2012 along with previous resolution dated 24.11.2011 of the trust regarding the decision taken by their management for closing down the institution from the academic session 2012-13.
10. Matter was considered by Committee in its 172nd meeting held on 13-15 October, 2012 as recorded in the minutes of 172nd Meeting of WRC, the P.T.C. course of institution is closed and FDRs were already returned.
11. On the RTI application, incorrect information was inadvertently issued vide PIO, WRC letter dated 06.08.2025 followed by modified letter dated 31.10.2025 conveying the appropriate information to RTI applicant by PIO, WRC.
12. The order dated 23.09.2025 passed in R/Special Civil Application No. 13282 of 2025 by Hon'ble High Court of Gujarat at Ahmedabad was considered by Committee in its 445th meeting along with copy of representation dated 16.09.2025 received dated 25.09.2025 submitted by the institution along with letters dated 10.09.2025, 27.08.2025 together with enclosures with request to restore the recognition of P.T.C. course with permission for shifting of premises and upload the name of Sanskar P.T.C (D.El.Ed.) College NCTE Code WRC/APP02140/322237 on the web portal of WRC, NCTE.

The Committee noted that WRC had already refused permission for shifting of premises vide order dated 12.11.2011 due to deficiencies mentioned therein and on the basis of denial of inspection at old premises in pursuance of resolution passed by the trust to close down the P.T.C. course conveyed to RD, WRC and subsequently considered by WRC and taken decision recorded in the minutes that P.T.C. course be closed and their FDRs be returned, the Committee in this meeting decided that no further action is required on the part of WRC.

Bhavnagar (Guj.)- 364515”. Hence, decision taken by the Committee has not been communicated to the institution concerned.
2. Further, the Committee noted that as per submission of application and recognition orders issued by WRC from time to time, the address of the institution is “Mahila Adhyapan Mandir, Savarkundla-364515, Dist. Bhavnagar (Guj.)- 364515”, whereas the institution has requested vide letter dated 08.09.2025 stating that due to the district division in Gujarat in 1998-99, Savarkundla was included in Amreli district from Bhavnagar district and requested to update its address “Shri Mahila Adhyapan Mandir, Nadi Kanthe, Mahuva Road, Vill. Savarkundla, Dist. Amreli, Pin code- 364515 and to update status showing in the list of recognized institutions NCTE website.
