


❖ The Visiting Team Report of the institution has been considered by the Committee and accordingly, the institution has been found deficient on the following grounds: -

- The land area earmarked for the Itep was not presented to the VT members.
- The floor-wise built-up plan of building for Itep was not presented to the VT members.
- Parking and Handicap toilet were not shown to the VT members during virtual inspection in the block concerned of the institution.
- The building is accessible for the differently abled persons only at ground floor and not at upper floors due to lack of lift or ramp connectivity.
- The total built-up area of all blocks for all courses run by society was mentioned as 31264 sq.m., however, the drawings of the institution do not reveal the floor-wise break-up of the earmarked area for Itep.
- The land use certificate does not reveal the purpose of land use.
- The institution does not have the renewal certificate of the Society/Trust.
- The institution does not have the educational resources as per norms & standards of the proposed course.
- The institution does not have the educational resources as per norms & standards to offer the proposed course.

Hence, the Committee decided that Show Cause Notice be issued to the institution to submit reply on the deficiencies mentioned above within 7 days from the date of issue of this Show Cause Notice failing which the application of the institution seeking grant of recognition for the proposed programme shall be liable for refusal without providing any further opportunity to the institution.

❖ The Visiting Team Report of the institution has been considered by the Committee and accordingly, the institution has been found deficient on the following grounds: -

- The institution does not have the books & encyclopaedias related to the proposed course.
- The certificates shown were majorly not correct or are different from the information provided in the online application form.
- The building of the institution is not appropriate to offer the proposed course.
- The institution has not presented the affidavit mentioning the land area and built-up area (in sq. mtrs.) for verification by the VT members.
- Land use certificate issued by the Respective District Town Planner, Town and Country Planning is not presented to the VT members.
- For the state of Punjab, building plan has to be approved by the Chief Town Planner, Punjab for an area of the building above 5000 sq.mtr.
- For the state of Punjab, Completion / Occupation Certificate (for urban areas), for an area of the building above 5000 sq.mtr., has to be issued by the Municipal corporation / Municipal Committee Development.
- The pictures of the building of the institution were already uploaded before the start of VT.
- The principal of the institution informed the VT members that the institution has so far not purchased the books for the ITEP and they will purchase the same if the institution gets recognition from NCTE.
- The institution failed to produce the latest certificate for registration of the Society sponsoring the institution during virtual inspection.

**Hence, the Committee decided that Show Cause Notice be issued to the institution to submit reply on the deficiencies mentioned above within 7 days from the date of issue of this Show Cause Notice failing which the application of the institution seeking grant of recognition for the proposed programme shall be liable for refusal without providing any further opportunity to the institution.**

- Building Completion Certificate / Occupation Certificate issued by the Municipal Corporation / Development Authority Concerned is not shown to the VT members.

**Hence, the Committee decided that Show Cause Notice be issued to the institution to submit reply on the deficiencies mentioned above within 7 days from the date of issue of this Final Show Cause Notice failing which the application of the institution seeking grant of recognition for the proposed programme shall be liable for refusal without providing any further opportunity to the institution.**
