- ❖ The recognition was granted to the aforesaid institution for offering B.Ed. course of one-year duration with an annual intake of 100 students vide order **F.NRC/NCTE/F-3/HP-178/2006/7609-7618 dated 06.09.2006** followed by revised recognition order for B.Ed. course of two-year duration with an annual intake of 100 students vide order **F.NRC/NCTE/ HP -178/2015/99634-638 dated 15.05.2015.**
- ❖ As per the decision of NRC taken in its **403rd Meeting Held on 13th and 14th July 2023**, Final Show Cause Notice was issued to the institution on 07.08.2023 The institution has not submitted the reply of Final Show Cause Notice on 07.08.2023 issued on the following grounds:

- The institution is not a multi-Disciplinary institution as defined under clause 2(b) of NCTE Regulation, 2014.
- Certified copy of land documents in the name of society / institution is not submitted. The institution is required to submit the Certified copy of all land documents issued by the Competent Revenue Authority.
- The initial recognition was granted by NRC at Khata No. 698, 699 on the land which was on lease for a period of 30 years. In reply, the institution has submitted the permission under Rule 118 for Khasra No. 49, 50 and 1054/51, which is different from the Plot / Khasra where the initial recognition was granted. The institution is required to clarify this discrepancy.
- Non-encumbrance certificate issued by the Competent Revenue authority is not submitted.
- The Plot / Khasra / Khata No is not mentioned in the Building plan submitted. The institution is required to submit Blue print of the Building Plan duly approved by Government Engineer and countersigned by the Competent Authority of the State Government mentioning the name and location (Sy.No./ Plot No./Khasra No.) of the institution, total land area, built up area, earmarked area for each course, date of approval and approving authority.
- The Building Completion Certificate submitted mentions the Khatoni No 67, Khata No. 86, Khasra No. 409/162, which is different from the Plot / Khasra where the initial recognition was granted. The institution is required to clarify this discrepancy.
- The institution is required to submit Building Completion Certificate duly approved by Government Engineer and countersigned by the Competent Authority of the State Government mentioning the name and location (Sy.No./ Plot No./Khasra No.) of the institution, total land area, built up area, earmarked area for each course, date of approval and approving authority, on the specified format of NRC.
- From the complaint received and also the other related documents submitted by the institution, it is evident that the institution has shifted to the new premises without approval from NCTE. It has not even applied to NRC for shifting of premises.
- Photocopy of certificate to the effect that the institution's campus, building, facility etc is disabled friendly, issued by the Competent Authority of the State Government is not submitted.
- The institution is required to submit the proper Change of Land Use Certificate issued by the Competent Revenue Authority under the relevant laws of the Government.


