

- ❖ The Visiting Team Report of the institution has been considered by the Committee and accordingly, the institution has been found deficient on the following grounds: -
 - There are no dedicated laboratories for the B.Sc. B.Ed. course. The course is entirely dependent on the laboratories of the general degree college.
 - The library currently holds 689 book titles only related to Teacher Education. This is significantly less than mandatory minimum prescribed by NCTE for teacher training institutions.
 - Seating capacity in the reading room of library is inadequate and does not meet the ratio required for the total student intake, hindering the academic environment for aspiring teachers.
 - Multipurpose Hall must have a seating capacity of 200, yet this institution has seating arrangements for 80 students only. Which is inadequate as per the Norms & Standards for ITEP.
 - The official college website lists only four (4) teachers, which is grossly inadequate the required faculty-student ratio as per NCTE's Norms & Standards for ITEP.
 - During the official inspection, the institution authorities failed to produce a Teaching Faculty List approved by the Affiliating University.
 - Recognition Order issued by NCTE mentions the name of the institution as 'BAM Khalsa College' whereas the official name on the board of institution is 'Babbar Akali Memorial Khalsa College'.

- Toilet for differently abled persons were not available in the institution.
- Site plan shown by the institution to the VT members does not reflect the width of internal and external road.

Hence, the Committee decided that Show Cause Notice be issued to the institution to submit reply on the deficiencies mentioned above within 7 days from the date of issue of this Show Cause Notice failing which the application of the institution seeking grant of recognition for the proposed programme shall be liable for refusal without providing any further opportunity to the institution.

The Northern Regional Committee considered the Order dated 15.12.2025 passed by the Hon'ble High Court in the batch of writ petitions challenging withdrawal of recognition of Teacher Education Institutions (TEIs) due to non-submission of Performance Appraisal Reports (PAR) along with other related documents, NCTE Act 1993, NCTE Rules 1997, NCTE Regulations 2014, Standards Operating Procedure (SoP) & Guidelines issued by NCTE (HQ) from time to time and the Committee observed the following:

- The meeting on the said subject commenced with a reference to the judgment passed by the Hon'ble High Court dated 15.12.2025 allowing the batch of writ petitions wherein the withdrawal orders issued under Section 17 of the NCTE Act, 1993 were set aside.
- It was apprised to the members that during the pendency of the said petitions, the NCTE, in its 68th (Emergent) General Body Meeting held on 25.11.2025, had resolved to grant a final, one-time opportunity to TEIs for submission of mandatory PARs for the academic sessions 2021-22 and 2022-23, and that the Hon'ble Court has taken note of and relied upon the said decision.
- The Court has further accepted the statement made on behalf of the NCTE regarding:
 - Appointment of four dedicated Nodal Officers, one for each Regional Committee, to assist TEIs in updating contact details and resolving technical issues.
 - Issuance of a Public notice granting three weeks' time for updating mobile numbers and e-mail IDs, followed by six weeks' time for opening of the PAR portal for submission.

The Admission Committee of SCERT, Delhi in its meeting held on 24/12/2025 has considered the referred suggestion of NCTE, NRC, Govt. of India and recommended to retaining the name of the course as NTT/D.E.C.Ed. or similar courses recognized by NCTE instead of "Early Child Childhood Care & Education (ECCE) from a retrospective date on which it had affiliated the institution(s) for offering courses for duration 2007 onwards in the public interest for resolving grievances. Since, the course objectives/contents, outline, duration and eligibility are similar for these courses i.e. NTT before 2007; ECCE onwards 2007 and DPSE 2014 onwards, the concerned institutes will be affiliated at par with their NCTE recognition order (as issued by NCTE) from retrospective date for the purpose of issuance of OTPRMS certificate only.

1. Nayab Abbasi Girls Degree College, Amroha, Uttar Pradesh is managed by Abbasi Charitable Educational Society and is affiliated with Mahatma Jyotiba Phule Rohilkhand University, Bareilly.
2. The institution was initially granted recognition by NCTE on 13.12.2002 to conduct the B.Ed. course of one-year duration with an annual intake of 100 students w.e.f academic session 2002–2003. Subsequently, after the promulgation of the NCTE Regulations, 2014, the institution submitted its consent and affidavit, pursuant to which a revised recognition order for the B.Ed. course of two-year duration was issued on 23.05.2015. However, the institution has not submitted compliance with the revised recognition order.
3. The institution was also granted recognition for the BTC (D.El.Ed.) course of two-year duration w.e.f academic session 2004–2005 vide order dated 28.08.2004. In the year 2025, the institution submitted requests seeking change of its name from “Nayab Abbasi Girls Degree College” to “Nayab Abbasi Degree College, Amroha” and also sought change of status from Girls to Co-Educational. In support of its request, certain recognition and affiliation documents were uploaded. However, the institution failed to submit mandatory No Objection Certificates from the affiliating University for the B.Ed. course and from SCERT, Lucknow for the BTC course.
4. As per NCTE records, the land documents submitted at the time of grant of recognition stands in the name of “Nayab Abbasi Girls Degree College”. In the absence of any change in land title, the change of name of the institution is not permissible under the NCTE Regulations, 2014.

The Committee noted that the institution approached the Hon’ble High Court of Delhi by filing W.P.(C) No. 19095/2025. The Hon’ble Court, vide order dated 19.12.2025, permitted the institution to withdraw the writ petition with liberty to submit a fresh request for change of name and directed NCTE to take a decision on such request within the stipulated time. The operative part of the court order is stated as below :

“5. In light of the aforesaid, this writ petition is disposed off granting liberty to the petitioner to send the request letter to the within two working days from today and considering that the counselling round commences from 23.12.2025, the respondent no.2 shall take a decision within 10 days from the communication, in accordance with law. The decision will be communicated to the petitioner within two days from the date of decision and in case of any grievance, petitioner will be at liberty to take recourse to legal remedies.”

The matter was considered by the NRC in its 454th Meeting held on 29th and 30th December 2025. The Committee noted that the institution had not submitted NOCs from the affiliating bodies, had not changed the land title in its name, and had also not complied with the revised recognition order dated 23.05.2015. The Committee, therefore, decided that the representation of the institution may be examined and placed before the ensuing meeting for consideration.

Subsequently, the institution submitted a fresh representation dated 08.01.2026 requesting change of name in the recognition orders for B.Ed. and D.El.Ed. courses. Upon scrutiny, it was found that the institution had not submitted certified land documents reflecting change of name, had not furnished NOCs from the affiliating University and SCERT, had not submitted a valid society resolution signed by all members, and had still not complied with the revised recognition order. Accordingly, the proposal for change of name has been placed before the NRC for consideration in accordance with Clause 7(12) of the NCTE Regulations, 2014 and applicable SOPs.

In view of the above, the Committee noted the Court Order and decided that the office of NRC may examine and scrutinize the representation received from the institution and may be submitted in the ensuing meeting of NRC, accordingly.

The Institution has submitted a representation through e-mail dated 08.01.2026 with request to fresh application for change of name of the institution from Nayab Abbasi Girls Degree College to Nayab Abbasi Degree College in recognition order for B.Ed. and D.El.Ed. course.

1. In this regard the institution has not submitted certified copy of registered land document regarding the change of name of institution.
2. At a time recognition of recognition, the institution has submitted the land documents in favour of Nayab Abbasi Girls Degree College.
3. The institution has not uploaded no-objection certificate issued by affiliating body for change the name of institution for B.Ed. course.
4. The Institution has not uploaded no-objection certificate issued by affiliating body that is SCERT, Lucknow Uttar Pradesh to change the name of the institution for D.El.Ed. course.
5. The Institution also not submitted resolution of the society signed by all society member to change the name of institution for B.Ed. and D.El.Ed. programme.
6. The institution also not submitted compliance of revised recognition order dated 23.05.2015.

The Committee observed that the said institution has not submitted certified land documents reflecting the change of name, has not furnished NOC required from the affiliating University and SCERT, Lucknow, has not submitted a valid resolution of the Society duly signed by all its members, and has also not complied with the revised recognition order. Also the Institute has been running the CO-ED degree college w.e.f 2023-2024 session onwards in gross violation of the NCTE regulations -Act.

In view of the above deficiencies and non-compliance with the provisions of the NCTE Regulations, 2014 and the applicable SOPs, the Committee decided that the request for change of name cannot be considered at this stage. Hence, the Committee decided that FirstShow Cause Notice be issued to the institution to submit reply on the deficiencies mentioned above within 15 days from the date of issue of First Show Cause Notice along with providing explanation about why appropriate action should not be taken in accordance with law.

The aforesaid institute has filed a W.P.C 19623/2025 before Hon'ble High Court of Delhi raising grievance that the statutory appeal against the Withdrawal Order dated 14.08.2023 that is admittedly pending consideration before the Appellate Authority of NCTE, and the principal grievance raised by the Petitioners pertains to the non-disposal of the said appeal,

9. The Hon'ble High Court of Delhi vide order dated 24.12.2025 has disposed of the writ petition with the directions that The Respondents /NRC shall inform the Petitioner about the documents required, which the Petitioner will submit thereafter. The Respondents/NRC shall then reconsider the appeal dated 12.10.2023 after giving the Petitioner a personal hearing and pass a reasoned order within six weeks. If aggrieved, the Petitioner may take appropriate legal remedies as per law.

The operative part of the Court order is mentioned as below:

"6. Accordingly, this writ petition is disposed of taking on record the assurance of the Petitioner that all necessary documents will be furnished after a communication is received from the Respondents indicating the documents required. Respondents shall send a communication to the Petitioner indicating the documents required and on receipt of the same, Petitioner will furnish the requisite documents. Thereafter, Respondents shall take a fresh decision on the pending statutory appeal dated 12.10.2023, after granting opportunity of personal hearing to the Petitioner. Reasoned and speaking order shall be passed by the Appellate Committee and communicated to the Petitioner. The entire exercise will be completed within six weeks from today."

In compliance of the order dated 24.12.2025 passed by the Hon'ble High Court of Delhi in W.P.C 19623/2025, the order passed by the Hon'ble High Court was perused and in consonance of the same, the Committee decided to give the institution an opportunity of personal hearing in the upcoming NRC Meeting. - 2) The institution is not a multi-Disciplinary institution as defined under clause 2(b) of NCTE Regulation, 2014.

3) Certified copy of land documents in the name of society / institution not submitted. The institution is required to submit the Certified copy of all land documents issued by the Competent Revenue Authority.

4) In case the land documents are in Regional Language, duly notarised translated version of the same is required to be submitted.

5) The institution is required to submit a Certificate of Land issued by the District Magistrate / Registering Authority with Designation on the specified format of NRC. (Format uploaded on the website of NRC)

6) The institution has submitted the photocopy of a private lease deed executed on 07.02.2000 for a period of 30 years in the name of society with Shri Kuldeep Kumar Shastri, which is not acceptable as per clause 8(4)(i) of NCTE Regulations, 2014.

7) The other documents viz NEC, CLU, Mutation, Building Plan, Building Safety Certificate, Fire Safety Certificate, Building Completion Certificate etc are not acceptable in view of the fact that the land is on private lease basis, which is not acceptable as per NCTE Regulations.

The institution has not uploaded the reply to First SCN. The matter was placed before NRC in its 429th meeting held on 25/10/2024 and the Committee decided that all 140 institutions of J&K and Ladakh be given a final opportunity to update their applications/ documents already submitted by them online on portal, pertaining to the development and preparedness done by them in terms of NCTE (Recognition, Norms and Procedure) Regulations, 2014 as amended from time to time. Accordingly, the portal was opened from 05th Nov 2024 to 17th Nov 2024, for the institutions giving them the final opportunity regarding updation of reply/ representation, already submitted in respect of the TEI.

- The other documents viz NEC, CLU, Mutation, Building Plan, Building Safety Certificate, Fire Safety Certificate, Building Completion Certificate etc are not acceptable in view of the fact that the land is on private lease basis, which is not acceptable as per NCTE Regulations.
- **The Northern Regional Committee (NRC) in its 431st Meeting (Volume-I) held on 09.12.2024 considered the matter and decided the following: -**

The online file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee and the Committee observed the following: -

• *First Show Cause Notice was issued to the institution vide email dated 30/01/2023. The institution had not uploaded the reply of first show cause notice. Accordingly, final show cause notice was issued to the institution on 14/02/2023.*

• ***The institution again did not upload the reply to First SCN. Accordingly, the matter was placed before NRC in its 429th meeting held on 25/10/2024 and the Committee, in pursuance of the decision taken by General Body of the Council in its 61st meeting held on 15/08/2024, decided that all 140 institutions of J&K and Ladakh be given a final opportunity to update their applications/ documents already submitted by them online on portal, pertaining to the development and preparedness done by them in terms of NCTE (Recognition, Norms and Procedure) Regulations, 2014 as amended from time to time. Subsequently, the portal was opened from 05th to 17th November 2024 for the institutions giving them final opportunity regarding updation of reply/ representation, already submitted in respect of the TEI.***

• ***The institution has uploaded the reply on 11.11.2024. In view of the above, the Committee concluded that the application of the institution is still deficient on the following grounds: -***

• *As per eligibility to apply for the B.Ed. (ODL) as envisaged in the Norms & Standards for B.Ed. (ODL), the institutions or academic units specially established for offering ODL programmes like the National Open University, State Open Universities and the Directorates / School of Open and Distance Learning in UGC-recognized Universities shall be eligible to offer this teacher education programme. As such, the applicant institution is not eligible to apply for this course.*

In support of land document, the institution has submitted the private lease deed for a period of 30 years in favour of the management society, which is not acceptable as per clause 8 (4) (i) of NCTE Regulations 2014.

- The institution has submitted the photocopy of Affidavit on Non-Judicial Stamp Paper of Rs.100/-, attested by Notary Public. Original Affidavit is not submitted.
- The other documents viz NEC, CLU, Mutation, Building Plan, Building Completion Certificate etc. are not acceptable in view of the fact that the land is on private lease basis, which is not acceptable as per NCTE Regulations. **Hence, the Committee decided to reject/refuse the application for B.Ed. ODL programme of the institution on the grounds mentioned above under Section 14 of the NCTE Act 1993.**

Accordingly, Rejection/Refusal order was issued to the institution on 08.01.2025.

- **The applicant institution filed an appeal before appellate authority. The appeal Committee vide appeal order dated 24.06.2025 had confirmed the NRC Refusal Order dated 08.01.2025.**

Decision of the appeal committee is as follows:-

After perusal of the Appeal Report, documents on record and oral arguments advanced during the online hearing, Appeal Committee of the Council concludes that the instant appeal lacks merit and accordingly rejects the appeal. The impugned order dated 08.01.2025 issued by NRC is hereby confirmed.

- The institution filed Writ Petition no. W.P.(C)3370/2025 C M no. 7679/2025 titled " Divya College of Education vs UT of J&K and others" before the Hon'ble High Court of Jammu and Kashmir and Ladakh at Jammu and the Hon'ble Court passed order dated 01.12.2025 , the operative part of the Order reads as under:

"26. Lack of reasons in the two impugned orders and also non-application of mind to the full facts and circumstances of the case are being pleaded by Mr. M.K. Raina, learned counsel for the petitioner to submit that the petitioner has a good case to succeed in the final analysis.

27. Prima facie case made out.

28. Issue notice to the respondents in the main petition as well as in all connected CM.

29. In the meantime, the operation of the impugned order F.No. NCTE/NRC/FR-2122-NRC-41855842/JAMMU AND KASHMIR/2020/REJC/38 dated 08.01.2025 passed by the Northern Regional Committee of NCTE read with appellate order dated 24.06.2025 are hereby stayed and consequently the petitioner's educational institution be allowed to run the B.Ed. Courses subject to outcome of the writ petition. This order is, however, subject to objections from the other side."

The file of the institution along with other related documents, NCTE Act 1993, NCTE Rules 1997, NCTE Regulations 2014, Standard Operating Procedure (SoP) & Guidelines issued by NCTE (HQ) from time to time along with Court Order dated 01.12.2025 passed in W.P.(C) 3370/2025 were placed before the Northern Regional Committee and the Committee observed the following: -

- **The interest of NCTE be defended by filing Counter-affidavit along with an application to vacate the stay imposed by order dated 01.12.2025.**
- **Further, the Committee was apprised of the fact that in the High Court of Jammu and Kashmir and Ladakh at Jammu, multiple *ex-parte* orders have been passed against NCTE due to which filing of caveat in the said High Court has become necessary. The purpose of filing Caveat petitions was explained to the Committee at length and the Committee decided that Caveat Petitions be filed in the High Court of Jammu and Kashmir and Ladakh at Jammu against total 140 TEIs in order to defend the interest of NCTE.**
