At the outset **Sh. Mukesh Kumar, Regional Director**, and Convener, SRC welcomed the Chairperson and all other members, apprised about the work done by the SRC along with the directions received from NCTE Hqrs. from time to time.

The Committee has taken up the following agenda item of 502nd Emergent Meeting.

1.	Srinivasa College of Elementary Education SY.No.180 ,Koildinne Street , Shanti Nagar Taluk and City, Mahabubnagar District-509144, Telangana File No.: - SRCAPP1666, Programme: - D.El.Ed. The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: - The institution filed contempt petition bearing no. Cont. Cas(C)1049/2026 titled "Srinivasa College of Elementary Education Vs Ms. Sukhgeet Kaur (IOFS), member Secretary, NCTE and Anr." before Hon'ble High Court of Delhi seeking restoration order for the academic session 2026-27 instead of 2025-26. The matter was heard and the Hon'ble Court passed its order dated 12.06.2026, the operative part of which reads as follows: <i>"4. Learned counsel for the Petitioner submits that though the restoration order has been passed, the same pertains to the Academic Session 2025-26 and not to the Academic Session 2026-27.</i> <i>5. In view of the above, the Respondents are directed to issue a revised restoration order in respect of each of the Petitioner-Institutes, specifically permitting them to participate in the counselling process for the Academic Session 2026-27 instead of 2025-26. The said order shall also be communicated to the concerned University.</i> <i>6. Let the needful be done before 14.06.2026.</i>

7. The petition is disposed of in the above terms with liberty to the Petitioners to seek revival of the present petition in case the aforesaid directions are not complied with."

Keeping in view the above, the SRC decided as follows:

In compliance of the directions passed by Hon'ble High Court of Delhi vide order dated 12.06.2026 in Cont. Cas(C) 1049/2026, Revised Restoration Order be issued to the institution permitting to participate in the counselling for the Academic Session 2026-27 instead of 2025-26 for D.El.Ed. programme with annual intake of 50 students (One basic unit). The same shall be communicated to the university as well.

The meeting ended with the vote of thanks to the Chair.
