F.No. SRCAPP802/D.El.Ed/AP/2012/46230 dated 18.09.2012 for conducting D.El.Ed. programme for two years duration with an annual intake of 50 students.</li> <li>• A letter no. RC. No.ESE02-22025/43/2020-(SCERT) TRG-DSE dated 25.03.2021 was received from Sri V. Chinaveerabhadru, I.A.S. Director, School Education, Andhra Pradesh, Amaravati <i>inter-alia</i> recommending the de-recognition of various private D.El.Ed. college on the ground of violation of admission rules stipulated by the state Government.</li> <li>• And, the aforesaid letter was place before SRC in its 402<sup>nd</sup> meeting held on 13<sup>th</sup> – 14<sup>th</sup> September, 2021 and the matter of the institution regarding D.El.Ed.-Addl. Programme was considered by SRC and the committee decided to withdraw the recognition of the institution for the D.El.Ed.-Addl. Programme.</li> <li>• Accordingly, the recognition was withdrawn by SRC vide its common withdrawal order No. F. No. NCTE/Regl018/119/2021-Regulation Section-</li> </ul> |

|  | <p>SRC/AP/128711 dated 05.10.2021 for D.El.Ed.-Addl programme for intake of 50 students.</p> <ul style="list-style-type: none"> <li>• Further, the recognition of the institution was withdrawn by SRC vide withdrawal order No. NCTE/2025/SRC/PAR/ORDER/SRCAPP802/ dated 19.05.2025 on the grounds of non-submission of PAR for the academic session 2021-22 and 2022-23 for Initial D.El.Ed. programme for intake of 50 students.</li> <li>• A Public Notice was issued on 01.10.2025, whereby Stay on withdrawal order was implemented.</li> <li>• The institution filed a Writ Petition W.P.(C)15027 of 2026 before the Hon'ble High Court of Delhi thereby challenging the PAR withdrawal order. The Writ Petition was disposed of vide a common order dtd. 15.12.2025, the operated part of which is reproduced hereunder:</li> </ul> <p><i>"12. In light of the above, and having regard to the decision taken by the NCTE in its 68th (General) Body Meeting as noted above, as well as, the statement made by Mr. Kapoor, the present petitions are allowed and the impugned orders are set aside.</i></p> <p><i>13. Resultantly, the respondent NCTE will pass an "order of restoration" of recognition in each case and the names of the petitioners shall be included in the list of recognized institutions maintained on the website of the respondents.</i></p> <p><i>14. Simultaneously, status of the petitioners as "recognized institution" shall also be communicated to the concerned State Government and Affiliating Body or University.</i></p> <p><i>15. The above exercise of passing an order of restoration of recognition as well as communicating the State Government and Affiliating Body/University shall be completed before the issuance of public notice as mentioned in para 8 (ii) above.</i></p> <p><i>16. In the meanwhile, petitioner institutes are permitted to participate in the counselling for academic session 2025-26 and admit students for the said academic session.</i></p> <p><i>17. Pending applications stand disposed of."</i></p> <ul style="list-style-type: none"> <li>• Further, the institution has filed CONTEMPT PETITION (CIVIL) NO. Nil OF 2026.</li> <li>• The contempt petition has not been listed till date.</li> </ul> <p><b>Keeping in view, the above, the SRC decided as under:</b></p> <ul style="list-style-type: none"> <li>• <b>The recognition granted to the Saraswathi College of Teacher Training, Plot/Khasra No. 989/2, Giddalur Village and Post, Giddalur City and Taluk, Prakasam District – 523357, Andhra Pradesh vide order No. F.No. SRCAPP802/D.El.Ed/AP/2012/46230 dated 18.09.2012 for D.El.Ed. programme for 50 students be restored.</b></li> </ul> |
