The 484<sup>th</sup> Meeting of the Southern Regional Committee (SRC), National Council for Teacher Education held on 23<sup>rd</sup> January 2026 through (On-line Mode) at the Conference Hall, SRC, NCTE, New Delhi.

At the outset **Sh. Mukesh Kumar, Regional Director**, and Convener, SRC welcomed the Chairperson and all other members, apprised about the work done by the SRC along with the directions received from NCTE Hqrs. from time to time.

**The Committee has taken up the following agenda items of 484<sup>th</sup> Meeting.**

1.	Al-Meezan Educational Association's B.Ed. College, Highlands, Anandnagar Road, Old Hubli, Dharwad District, Karnataka-580024.  <b>File No:- APS03724 Programme:- B.Ed.</b> The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations:-  The Hon'ble High Court of Delhi vide its order dated 23.12.2025 passed in W.P.(C) 14579/2025 titled "AL-MEEZAN Educational Associations B.ED. College Vs National Council for Teacher Education & ANR" inter-alia directed the SRC to pass the order of restoration in favour of the petitioner institution. The operative part of the order reads as under:-  <i>"5. Having heard learned Senior Counsel for the Petitioner and counsel for the Respondents and looking to the fact that as of today the deficiencies that remain to be cured, even according to the Respondents are: (a) approved list of faculties; and (b) BCC. Petitioner is willing to furnish the documents within three weeks from today and on furnishing the documents, Respondents have no objection in reconsidering the withdrawal order. Petitioner is right in submitting that the withdrawal order was not communicated by the Respondents and despite best efforts, Mr. Rupal is unable to establish that communication was sent. It is trite that no order can be enforced until it is communicated to the effected party. This Court also finds merit in the contention of the Petitioner that there are serious discrepancies in the deficiencies/shortcomings pointed out in the show cause notices</i>

	<p><i>and the withdrawal/appellate orders and thus, the withdrawal order and consequently the appellate order are unsustainable in law.</i></p> <p><i>6. Accordingly, this writ petition is allowed to the extent of quashing the withdrawal order dated 30.12.2021 as also appellate order dated 20.08.2025. As undertaken, Petitioner will furnish the approved list of the faculty as also the BCC within three weeks from today. On receipt of the documents, Respondents shall take a fresh decision on withdrawal of recognition within two weeks from the date of receipt of the documents and communicate the same to the Petitioner, who is at liberty to take recourse to legal proceedings in case of any surviving grievance.</i></p> <p><i>7. Writ petition is disposed of along with the pending application."</i></p> <p><b>In light of the above, SRC observed as under:</b></p> <ol style="list-style-type: none"><li>1. The institution is required to submit latest faculty list duly approved by the Registrar of the affiliating body as per the prescribed format developed by NCTE.</li><li>2. The institution is also required to submit an affidavit from the Management of the institution on Rs. 100/- judicial stamp paper as well as from individual affidavits from each faculty member on Rupees 10/- Non-Judicial stamp paper consenting there in to come under NCTE Regulation 2014 as amended from time to time and adherence of the same.</li></ol> <p><b>Keeping in view of the above, the SRC decided that Show Cause Notice be issued to the institution thereby providing an opportunity to the institution for making its representation within 21 days along with all relevant documents from the date of issue this notice.</b></p> <p><b>2.</b> Raja Foundation College of Education, Kona Road, Mylavaram, Kadapa-516439, Andhra Pradesh</p> <p><b>File No:- APSO7201 Programme:- B.Ed.</b></p> <p>The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -</p> <p>The Hon'ble High Court of Delhi vide its order dated 09.01.2026 passed in W.P.(C) 19507/2025 titled "Raja Foundation College of Education Vs National Council for Teacher Education &amp; ANR" inter-alia directed the SRC to pass the order of restoration in favour of the petitioner institution. The operative part of the order reads as under:-</p> <p><b><i>"3. Mr. Rupal, learned Standing Counsel appearing on behalf of the respondent No.1 submits that he has no objection in case a similar order is passed in the present petition.</i></b></p> <p><b><i>4. In view of the above, it is clarified that the remand order dated 10.09.2020 would also be treated as quashing the withdrawal order dated 17.01.2020.</i></b></p> <p><b><i>5. Accordingly, the Southern Regional Committee ("SRC") is directed</i></b></p>

*to pass the order of restoration in favour of the petitioner institution for recognition of the concerned course in accordance with law within a period of two weeks from today. The said order shall remain subject to further decision to be taken by the SRC.*

*6. A copy of the order of restoration of recognition of the petitioner institution for the concerned course will have to be communicated to all concerned. Once the order of restoration is passed, the petitioner institution would be entitled to participate in counselling and admission process for the Academic Year 2025-26 and subsequent years.*

*7. The application is disposed of in aforesaid terms. W.P.(C) 19507/2025*

*8. In view of the order in the above application, the present writ petition is disposed of."*

In light of the above, SRC decided as under:

In compliance of the Order dated 09.01.2026 passed by Hon'ble High Court of Delhi in 19507/2025 titled "Raja Foundation College of Education" vs NCTE and *anr*" the recognition of the institution for B.Ed. course with annual intake of 100 is hereby restored. A restoration order be issued by SRC. Further, the name of the institution be maintained on the NCTE website. State Government and Affiliating Body or University also be informed of the said restoration.

The meeting ended with the vote of thanks to the Chair.
