Decision of WRC:

The file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

In view of the above, the Committee decided as under:

The file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

A copy of Complaint dated 20.11.2019 against the institution namely Pandit Badri Prasad Shikshak Prashikshar Mahavidyalaya, E-1, Ricco Industrial Area, Kolana, Bandikui, District-Dausa, Rajasthan was received from Complaint Division, NCTE Hqrs. through Email received in WRC on 24.09.2025, wherein the complainant has mentioned regarding irregularities in respect of the infrastructure facilities and documents submitted by the alleged institution. The Committee noted the complaint and decided that following documents may be sought from the institution:

- (i) The institution is required to submit the following documents in respect of its land and building located in its existing premises wherein recognition was granted by NCTE for B.Ed. and D.El.Ed. courses.
- (ii) The institution is required to submit Building Plan approved by the Competent Authority of State Government indicating the Khasra/Plot/Survey No. and mentioning

the total land area and built-up area earmarked for each course being run in the premises and the demarcated land and built-up area for the teacher education programmes.

(iii) The institution is required to submit Site Plan approved by the Competent Authority of State Government indicating the Khasra/Plot/Survey No. and mentioning the total land and built-up area earmarked for each course being run in the premises and the demarcated land area and built-up area for the teacher education programmes.

(iv) The institution is required to submit the latest list of teaching staff for session 2019-2020 and 2025-2026 for both courses countersigned by the Registrar of affiliating body/Examining Body as per qualification contained in the NCTE Norms and Regulations as amended from time to time.

(v) The institution is required to submit the bank statement of last six months for session 2019-2020 and 2025-2026 for both courses indicating the transaction of the salary / remuneration to its teaching staff appointed for various courses separately.

(vi) The institution is required to submit the list/details of students admitted for session 2019-2020 and 2025-2026 for both courses.

(vii) The institution is required to submit Fire Safety Certificate issued by Fire Safety Department, Government of Rajasthan verifiable on the official portal of the Fire Department, Government of Rajasthan at URL https://lsgonline.rajasthan.gov.in/track_application.aspx

The file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- i. As decided by WRC in its 402nd meeting held on 27th march 2024, the complainants were asked vide letter dated 08.04.2024 to confirm whether they have withdrawn the complaint as per stand of the institution and intimate within 15 days from the date of issuance of communication by WRC, NCTE.
- ii. In response to WRC letters dated 08.04.2024, the complainants submitted copy of Court Order dated 17.01.2024 of High Court of Rajasthan judicature at Jaipur stating that the respective complaints have been withdrawn. Further, the institution has submitted that the writ has been withdrawn on account of settlement between the complainant and the institution. The Complainants have also submitted letters written by them withdrawing their complaints made to NCTE, the Registrar, University of Rajasthan, Jaipur, Rajasthan and the Commissionerate, College Education, Govt. of Rajasthan, Jaipur, Registrar of Societies, Jaipur. The complainants have also submitted copy of Notarized Affidavit for withdrawal of their complaints.

The file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

As decided by WRC in its 410th meeting held on 30th -31st December, 2024 and 426th meeting held on 03rd to 05th June 2025, letter dated 24.01.2025 followed by reminder dated 24.07.2025 were issued to District Magistrate, Bhilwara as well as affiliating body (Maharishi Dayanand Saraswati University). Reply is awaited from all concerned.

Show Cause Notice u/S 17(1) was issued to the institution dated 26.07.2024 on the grounds mentioned therein. Reply submitted by the institution was considered by Committee and observed that following deficiencies are persisting:

- (i) Latest Building Completion Certificate (BCC) is not submitted in the prescribed format of NCTE (17 points) issued by the Competent Government Authority.
- (ii) Submitted Building Safety Certificate issued by Executive Engineer, PWD Dn Asind dated 14.06.2024, which was valid up to 12.06.2025. The adherence of safety guidelines as prescribed by National/State Disaster Management Authority is not mentioned therein.

(iii) Building Plan approved by Sahayak Abhiyanta PWD, Sub Division, Gulabpura dated 12.08.2025. Building plan is not certified by local Govt. Building plan do not reflect Khasra/Plot/Survey No. and total land area and total built-up area.

(iv) Scanned Fire safety certificate submitted vide letter dated 06.10.2024 issued by private agency (Smoke Fire). However, online Fire Safety Certificate issued by Fire Safety Department, Government of Rajasthan verifiable on the official portal of the Fire Department, Government of Rajasthan at URL https://lsgonline.rajasthan.gov.in/track_application.aspx is not submitted.

(v) Photocopy of list of teaching staff for the academic session 2020-21, 2021-22, 2022-23, 2023-24 and 2024-25 submitted is not countersigned by the Registrar of affiliating body.

(vi) Bank statement of last six months indicating the transaction of the salary / remuneration to its teaching staff for academic session 2020-21, 2021-22, 2022-23, 2023-24 and 2024-25 needs to be certified by Bank manager of concerned bank.

In view of the above, the Committee decided as under:

- Final Show Cause Notice u/s 17 (1) of NCTE Act 1993 be issued to the institution with direction to submit reply along with requisite documents certified by the management supported with an affidavit within 15 days from the date of issue of notice.**

Decision of WRC:

The Committee noted that a complaint received vide letter F.No.NCTE-C/PG011/54/2025-Complaint Section-HQrs./130276 Comp. No.86740 dated 02.06.2025 from Complaint Division, NCTE Hqrs. regarding the racket of fake B.Ed. colleges in the Gwalior-Chambal Division of Madhya Pradesh. Out of 206 B.Ed. colleges, 190 colleges (in Gwalior, Morena, Bhind, Guna, Sheopur, Shivpuri, Datia, and Ashoknagar) are running without their own buildings, and have dummy principals and assistant professors.

The Committee also noted that the State Government of Madhya Pradesh has not informed about specific details of the B.Ed. institutions against whom action is to be initiated.

In view of the above the Committee decided as under:

The Commissioner, Higher Education Department, Govt. of Madhya Pradesh be communicated the copy of complaint letter with request to furnish the complete details of the institutions mentioning their name, address, code no., along with the Recognition Order to WRC within 30 days from the date of issue of the letter for further course of action.

The Committee noted that a letter vide No.राशिके/शि.शि./2025/1721 dated 07.08.2025 was received in the office of WRC, NCTE from Rajya Shiksha Kendra, Bhopal, Madhya Pradesh enclosing a photocopy of complaint letter dated 15.04.2025 addressed to CBI Delhi in connection with filing of FIR and taking strict action against the operators of D.El.Ed. colleges in the Gwalior-Chambal region, the facts stated in its forwarding letter is as under:-

“A verification report regarding the above-mentioned application has been received from the Higher Education Department, Madhya Pradesh, with registration number 2853329/20-1, dated 24.04.25. The original application is about the colleges affiliated with the D.El.Ed. course. The letter requests the cancellation of affiliation for the 327 D.El.Ed. colleges operating in 08 districts under the Gwalior division. According to the investigation, these colleges have no physical existence. The Higher Education Department is getting these colleges operated by the mafia.

It is noteworthy that the colleges receiving D.El.Ed. affiliation and recognition in the state of Madhya Pradesh are given based on recognition from the National Council for Teacher Education (NCTE). The Secondary Education Board grants affiliation.

Therefore, on the basis of the above complaint, it is necessary to conduct an investigation of these colleges. For this, it is requested that you take necessary action to stop new admissions in the D.El.Ed. course at the Gwalior division center and forward the letter to the concerned department for online action.”

Reply of final SCN submitted by the institution was considered and Committee decided that following deficiencies are still persisting:

- (i) Submitted Building plan is not legible and approving authority reflected therein is not clear. The institution is required to submit Building plan with earmarked and demarcated land area and built-up area for all recognized teacher education programmes and other courses being run in the campus as per NCTE Regulations, 2014.
- (ii) Date of approval of Govt. authority is not reflected in the submitted copy of site plan. The institution is required to submit site plan showing contiguity of all plots used for various Teacher Education courses got recognition from NCTE and other courses, if any approved by competent Govt. authority.
- (iii) Date of approval of Govt. authority is not reflected in the submitted copy of Building Completion Certificate. The institution is required to submit building plan in NCTE prescribed proforma indicating details of total land area, total built up area in respect of all recognized teacher education programmes vis-à-vis other courses running in the same campus certified by the competent Government Authority.
- (iv) Submitted list of faculty is not approved by the Registrar of the affiliating body as per the prescribed format of NCTE.
- (v) The institution has not submitted faculty list for recognized M.Ed. and STC (D.El.Ed.) course duly approved/ countersigned by the concerned Affiliating Body in the NCTE prescribed proforma. The institution is required to submit faculties list of all courses approved by concerned affiliating body.
- (vi) As per information on the website, Staff approval is under process vide letter dated 30.05.2024 sent to Registrar, University of Rajasthan.
- (vii) Complete information as per Clause 7(14)(i), 8(14) and 10(3) is not uploaded on institutional website.
- (viii) Reply of SCN dated 07.11.2020 on the compliance of Revised Recognition Order as mentioned to have submitted by the institution vide letter dated 07.12.2020 is not found attached on the institution file. A copy of the same is required to submit by the institution.

In view of the above, the Committee decided that Last final opportunity be given to the institution to comply above deficiencies.

Accordingly, last final Show Cause Notice u/s 17 (1) of NCTE Act 1993 be issued to the institution with direction to submit compliance along with requisite documents certified by the management supported with an affidavit within 15 days from the date of issue of notice and reply received from the institution be placed for consideration of WRC.
