- The institution has not submitted the certified copy of a site plan with demarcated land area for running different courses.
- The institution has not submitted the Building Safety Certificate issued by the Competent Government Authority.
- 7. The institution has not submitted the Fire Safety Certificate issued by the Competent Government Authority.
- 8. The institution has not submitted a Certificate to the effect that the building is differently abled friendly issued by the Competent Government Authority.

The institution is required to submit original valid Fixed Deposit Receipts from the Nationalized/ Scheduled Bank towards Endowment & Reserve Fund in the joint name of RD, NRC, NCTE & the representative of Management along with duly filled up Form "A" in original, verified/ signed by the Manager of the Bank.
- 13. The institution has not submitted downloaded copies of documents from the website of the institution as per provisions of sub-regulation 7(14) of the NCTE Regulations, 2014.
- 14. The website of the institution is not updated as required under sub-regulation 8(6), 8(14) and 10(3) of NCTE Regulations, 2014.
- 15. The institution is required to submit the copies of the affiliation orders for the last three years issued by the affiliating body concerned for each course being run by the institution / society.

Hence, the Committee decided that Show Cause Notice be issued to the institution to submit reply on the deficiencies mentioned above within 15 days from the date of issue of this Show Cause Notice.

College of Advance Studies', Rohini, New Delhi and other institutions recognised for NTT course by NCTE had submitted any other recognition order for E.C.C.E course issued by NRC, NCTE before applying for the affiliation with SCERT, Delhi?
- (ii) Whether the SCERT, Delhi is in receipt of any communication from NRC, NCTE to the effect that the nomenclature of NTT has been changed to ECCE? If yes, provide its copy.

- Apart from the above, NRC, NCTE also requested the institutions concerned to clarify as to whether the
 institutions received any recognition order for ECCE course by NRC, NCTE or any documents to the effect
 that nomenclature of NTT has been changed to ECCE.
- SCERT, Delhi replied vide letter dated 17.02.2025 received in NRC vide receipt No. 357042 dt. 21.02.2025 stated as under: -

"In this connection, I am directed to submit that the SCERT, Delhi issues Diploma Certificates to the students studying through its all-Govt. DIETs and other affiliated Self-Financed Private Institutes as recognized by the NRC-NCTE, Dwarka, Delhi issued from time to time with different names like NTT/ECCE/DPSE. All these courses with different names being recognized with basic qualification of 10+2 as entry qualification while the Course content and Duration of the course is similar and universally fixed with different names like: -

- a. Before year 2007, it was NTT Course.
- b. Onward 2007, it has become ECCE Course.
- Year 2015 onwards, the same course have been re-named as DPSE Course for those institutes seeking recognition from NRC-NCTE, Delhi.

Likewise, the other course with basic entry qualification as 10+2 but with different course content is granted recognition by NRC-NCTE, Dwarka, Delhi with different names like ETE/D.El.Ed.

It is a clarified position of NRC-NCTE Dwarka, Delhi also that the ECCE Programme can be treated equivalent to erstwhile NTT course, which now have been re-named as DPSE.

In view of the above and being same Entry qualification, Course Content/ Syllabi and Duration of the course, the SCERT, Delhi issues Certificates/ Diplomas for all these NTT/ECCE/DPSE named courses universally on the basis of latest nomenclature provided by the NRC-NCTE, Dwarka, Delhi to those latest recognised institutes carrying on Educational Teachers Training courses in Delhi and duly affiliated with the SCERT, Delhi on current basis.

Further, this is being done on practical basis for all institutes recognized from time to time by NRC-NCTE, Dwarka, Delhi and affiliated with the SCERT, Delhi on currently named course basis.

Further to this, the NCTE is also requested to address their software system accordingly, if there is any technical glitch on it."

- The building plan depicts the built-up area for D.El.Ed. and M.Ed. programme (s) only, however, the institution has not given any details regarding B.Ed. programme. The institution is required to submit building plan duly approved by Competent Govt. Authority depicting coursewise earmarked land and built-up area.
- The submitted BCC is signed by the Sarpanch and countersigned by representative of the institution.
 It is not approved by the Govt Engineer or any Competent Govt Authority.
- The institution has not uploaded the certificate that the institution's campus, building, furniture etc. is barrier free/Accessible for PWDs issued by Competent Govt. Authority.
- The list of faculty submitted by the institution is not approved by the affiliating body. The Committee noted that the institution has shifted to the new premises without prior approval of NCTE Regulation 2014 which is a serious violation of NCTE Regulation 2014.
