- The institution, in the online portal, has mentioned that the institution has obtained A+ NAAC certificate in the name of MANUU, Hyderabad campus. The University has not uploaded the NAAC certificate for the MANUU Campus, Varanasi, Uttar Pradesh.
- The institution has not uploaded the document for NIRF ranking 151 in respect of MANUU Campus, Varanasi.
- The University has mentioned that the MANUU campus, Varanasi is multidisciplinary institution around 25 to 30 years, but it has not uploaded any evidence in this regard.
