The Committee has taken up the following agenda items of 477th Meeting.

1. St. Xavier's D.El.Ed College of Education, Plot No. 229/3, Main Road, Alamanda Village & Post, Jami Mandal Taluk, Jami City, Vizianagaram District-535240, Andhra Pradesh.

The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

- The Notice for Contempt served by Advocate Sh. T. Vijaya Saradhi was taken for consideration in SRC-NCTE 477th Meeting held on 10/11 Nov 2025.
- This was observed that a letter the letter No. RC No. 359/A/SCERT/2019 dated 29.06.2020 received from the Commissioner, School Education (FAC), School Education Department, Govt. of Andhra Pradesh recommending therein for derecognition order in respect of 188

Pvt. D.El.Ed. colleges in A.P. since the said managements of Pvt. D.El.Ed. Colleges have made admission into the D.El.Ed. course during academic year 2018-19 on their own in violation of Government orders.

- 3. Hence the Committee decided to issue Show Cause Notice asking them to submit the documents."
- 4. Accordingly, Show Cause Notice was issued on 29/09/2020 based on recommendation made by the State of Andhra Pradesh and subsequently withdrawal order was passed on 12/04/2021.
- 5. Thereafter, the Institute approached the Hon'ble High Court of Andhra Pradesh and filed W.P © 7002/2022 and challenged the withdrawal order. The High Court pleased to pass direction vide an order dated 15/11/2022 as under:

"The order passed by respondent no. 3 is set aside. Respondent no. 3 may, if so advised, issue fresh Show Cause Notices to the petitioner-colleges and, after receiving their explanations, pass appropriate orders in accordance with law within the prescribed time."

- 6. In compliance to the Hon'ble Court's direction Show Cause Notice was issued on 16/1/2023 but no reply was received. Hence on the ground of non-submission of reply to SCN, withdrawal order was issued on 27/3/2023.
- 7. The petitioner-Institute again approached the Hon'ble High Court and filed a W.P © 15835/2024 the Court vide an Order dated 26/07/2024 and 2/01/2025 directed as under:

"This Court has set aside the impugned withdrawal order and directed the NCTE to issue fresh show cause notice."
In view of the same, the petitioners are hereby directed to file application/representation to the 2nd respondent. On making such application/representation by the petitioners, the 2nd respondent is hereby directed to pass appropriate orders". "There is no representation on behalf of respondents 5 and 6.

Hence, there shall be an interim direction to the respondents to participate in the ensuing spot admissions to be scheduled."

Keeping in view all the directions of the Hon'ble High Court and Contempt Case filed by the Advocate Sh. T. Vijaya Saradhi, the committee decided as under:

It is advised to the RD-SRC to coordinate with the Standing Counsel of SRC-NCTE at Andhra Pradesh and Department of School Education, Govt of Andhra Pradesh to represent the case before the Hon'ble High Court of Andhra Pradesh in the interest of NCTE and apprise the Hon'ble Court accordingly.

Chinaveerabhadrudu, I.A.S. Director, School Education, Andhra Pradesh, Amaravati *inter-alia* recommending the de-recognition of various private D.El.Ed. college on the ground of violation of admission rules stipulated by the state Government.

- 3. Accordingly, Show Cause Notice was issued on 18/08/2021 based on recommendation made by the State of Andhra Pradesh. It is pertinent o mention that no reply was submitted by the Petitioner Institution and subsequently withdrawal order was passed on 05/10/2021 for the D.EI.Ed-AI programme of 50 students.
- 4. Thereafter Show Cause Notices were issued for D.El.Ed programme on 18/08/2022 and on 16/09/2022 on the ground of non-functioning of the website of the Institutions which is mandatory requirement as per the NCTE Regulations, 2014. Institution when failed to submit a reply to SCN, SRC-NCTE passed a withdrawal order dated 16/12/2022.
- 5. Thereafter, petitioner-institution filed a Writ Petition: 2431/2025 and the Hon'ble passed an order with a direction to SRC as under:

"In that view of the matter, the withdrawal Order dated 05.10.2021 is set aside. Respondent No.5 may initiate proceedings by issuing fresh show-cause notice to the petitioner through e-mail as well as RPAD, within a period of three weeks from the date of receipt of a copy of this Order, if he is so advised. On receipt of such show-cause notice, the petitioner-college is directed to offer its explanation within a period of four weeks thereafter, and on receipt of explanation. if any, being offered by the petitioner-college, respondent No.5 is directed to pass appropriate orders in accordance with law. within a period of four weeks thereafter and communicated the same to the petitioner. Accordingly, the Writ Petition is disposed of. No costs."

Keeping in view all the directions of the Hon'ble High Court and Contempt Case filed by the Advocate Sh. T. Vijaya Saradhi, the committee decided as under:-

It is advised to the RD-SRC to coordinate with the Standing Counsel for SRC-NCTE at Andhra Pradesh and Department of School Education, Govt of Andhra Pradesh to represent the case before the Hon'ble Court of Andhra Pradesh in the interest of NCTE and apprise the Hon'ble High Court accordingly.

27. Status of cases where the cancellation of withdrawal order have been issued by RCs.

The SRC noted that the NCTE-HQrs had sought clarification from SRC with regard to cancellation of withdrawal issued by SRC Office. The SRC considered the entire matter and decide that following reply be furnished to NCTE-HQrs:-

Note # 102 (ii) regarding dealing of PAR matters by SRC:

- 1. The SRC has withdrawn recognition of 15 Programmes of the TEIs inadvertently, based on the list of institutions which have not submitted PAR for the academic session 2021-2022 furnished by the SRC office, even though some of the institutions have submitted PAR. Based on the representations received from the institutions which have submitted PAR, the SRC has decided to cancel the withdrawal order and continue the recognition to those Programmes of the TEIs.
- Consequently, 15 Cancellation Orders of Withdrawal were issued for Programmes of the TEIs, as decided by SRC in its 463rd meeting held on 16th June 2025.

Comments on [Point (iv) regarding dealing of PAR matters by SRC:

By issuance of Cancellation Orders of Withdrawal by SRC-NCTE for such 15 Programmes of the TEIs, the concerned Programmes of the TEIs stand recognised as on date.

28. GENERAL RESOLUTION REGARDING COURT ISSUES

The SRC observed that there was repeated absence of continuous and update communications between the Legal & Standing Counsels of different States / UTs working under the jurisdiction of SRC and SRC office, regarding the proceedings of legal matters and its outcome in the respective Hon'ble High Courts of the Southern States / UTs. As a result, the SRC is not only able to take appropriate decisions on legal issues raised by the TEIs but also put us in hard to hold legal fights to protect the interests of the NCTE in the Hon'ble Courts in Southern States / UTs at a later stage. In this connection, the SRC has repeatedly passed resolutions in the past, requesting the NCTE-HQrs to replace the Standing / Legal Counsels of NCTE working in the Southern States / UTs, however, it was not materialized. Hence, the SRC decided to once again request NCTE-HQrs to identify and appoint new Standing / Legal Counsels, who can stand with the NCTE and protect its interests in the Hon'ble High Courts of Southern States / UTs with complete professional approach.

The meeting ended with vote of thanks to the Chair.
