RESOLUTION:-

The Committee further resolved to place the following before NCTE Headquarters / Competent Authority for urgent consideration and appropriate decision:

It was noted that the SRC is in receipt of applications for shifting of premises, and owing to the absence of a clear, uniform, and approved procedural framework, ambiguity has arisen not only for the applicant institutions but also for the Regional Committees. Consequently, the matter has been agitated before the Hon'ble High Court, and in certain cases contempt petitions have also been filed. It was further observed that other Regional Committees are processing similar matters in a non-uniform and inconsistent manner, thereby exposing NCTE to avoidable legal and institutional risk.

1. That the existing framework for processing applications for shifting of premises suffers from serious systemic deficiencies, including absence of an online mechanism under Regulation 8(9), lack of approved SOPs, and non-availability of standard templates, leading to inconsistency and heightened litigation risk.

2. *That NCTE Headquarters may urgently: *

- develop a dedicated online module for shifting of premises applications.
- frame and notify comprehensive SOPs and templates to ensure uniform, transparent, and legally sustainable processing across all Regional Committees; and
- issue a formally approved clarification/circular under the authority of the Chairperson, NCTE, clearly delineating the procedure to be followed until such systems are operational.

The Committee resolved that the above issues be brought to the notice of the Chairperson, NCTE / General Body to safeguard NCTE from avoidable legal hardship, contempt exposure, and adverse judicial observations.

The Committee further resolved to inform NCTE Headquarters that, in the absence of a functional online mechanism and approved SOPs, the SRC is constrained to process the applications for shifting of premises received from institutions through offline mode, solely in order to discharge its statutory responsibilities under the NCTE Act, 1993 and the NCTE Regulations.

The meeting ended with the vote of thanks to the Chair.
