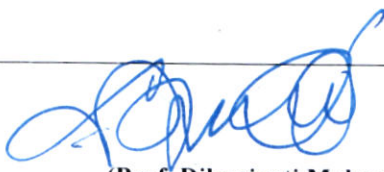

- As per decision of ERC, SCN was issued to the Institution and accordingly, the Institution has furnished the reply.
- The ERC had issued recognition order to the institution on 02.05.2017, whereas the affiliation order was issued by the Bihar Vidyalaya Pariksha Samiti, Patna on 03.02.2023. In the intervening period the college was not functioning and therefore, not able to fill the PAR for D.El.Ed programme for the session 2021-22 and 2022-23 due to non-allotment of the students by the affiliating body.

After carefully observing the reply to SCN along with other related documents, the ERC concluded that the reply is satisfactory and decided that withdrawal order dated 15.05.2025 issued by ERC to the institution may be treated as cancelled. Accordingly order be issued to the concerned institution and State Govt / affiliating body.
