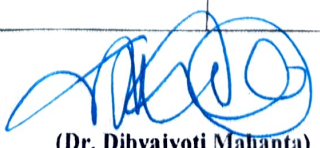

Decision of ERC:

The original file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, SOP, writ petition No. 7282/2025, representation received from the institution for changing of their medium of instructions Regulations, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following:

1. The institution has submitted representation of the change of their medium of instructions from Bengali to Hindi medium of 50 (one unit) out of 100 (two units).
2. The institution has approached to Hon'ble High Court with writ petition No. 7282/2025 regarding change of medium from Bengali to Hindi.

In view of above, the Committee decided that the change of medium of instructions by the Teacher Education Institution offering the D.El.Ed. course is a purely State Policy. However, Directorate of School Education may pursue the matter as per the policy provision/extant of law/regulation of the concerned affiliating body in order to change the medium of instructions of the institution which fulfil the need of the School Education System of the particular State.

Letter be issued to the Directorate of School Education accordingly.

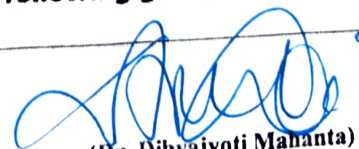

1. The institution has submitted a list of teaching faculties without seal of the Registrar of the affiliating University.
2. The institution has submitted copies of appointment letters and joining reports in r/o only fifteen teaching faculties whereas that of the total teaching faculties ie. one principal and fifteen teaching faculty is required.
3. The institution has submitted teaching faculty list wherein dates of joining of the teaching faculties at S.No. 08 to 16 is not mentioned.

In view of above, the Committee has decided that recognition granted to the institution for running B.Ed Programme be withdrawn under section 17 of the NCTE Act, 1993 with effect from the end of the session next following the date of communication of withdrawal order.

2. The institution has not submitted PAN card of the teaching staff namely Md. Asif Sahriar, Dr. Wasim Khan and Mr. Supriyo Manna.

In view of above, the Committee has decided that recognition granted to the institution for running B.Ed and D.El.Ed Programme be withdrawn under section 17 of the NCTE Act, 1993 with effect from the end of the session next following the date of communication of withdrawal order.

The original file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following: -

- First Show Cause Notice was issued to the institution on 08.05.2025. The institution has submitted reply of first Show Cause Notice on 28.05.2025.

After carefully observing the reply to SCN along with other related documents, the ERC concluded that the institution is still deficient on the following grounds:-

- The institution is not running as per the address of the recognition order issued by NCTE.
- The institution has no playground.
- The institution is required to submit latest copy of FDRs in respect of Endowment Fund & Reserve Fund along with Form 'A' duly signed by the Manger of the issuing bank.
- The institution is required to submit land use certificate, Non-Encumbrance Certificate and BCC issued by the Competent Government Authority.
- The institution is required to submit copy of salary statement for payment of salary paid to the faculty appointed in the institution.
- The institution is required to submit copies of appointment letters and joining reports clearly mentioning the names and Saving Bank account numbers of each of the faculties appointed for D.El.Ed programme and also the documents stating therein that the faculties are being paid salary through cheque/RTGS/NEFT for last six months.

In view of above, the Committee has decided that Final Show Cause Notice be issued under section 17 of the NCTE Act, 1993 to the institution before withdrawal of recognition to submit reply within 15 days from the date of issue of show cause notice.
