Decision of ERC

The online file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following: -

- Gauhati University has sent a communication dated 12.06.2025, received in NCTE on 02.07.2025, regarding HAM AK Rural College of Education with reference to Judgement of the Gauhati High Court dated 07.04.2025 in the matter of WP(C) 4212/2024.
- It has been mentioned in para 24(ii) of the Judgment (supra) as per which Respondent no. 3 i.e. NCTE was to take a decision in respect of the observation given by respondent No.1 and 2 in the resolutions No. R/EC03/2023/36(B)(xiv), dated 22.09.2023 and R/EC-03/2024/31(B) (10), dated 28.10.2024. Here, respondent No.1 and 2 refer to Registrar, Gauhati University and Academic Registrar, Gauhati University respectively. The operative part of the Judgement dated 07.04.2025 is as below:
 - 24 (i) The respondent Nos. 1 & 2 shall declare the result of 1st year B.Ed. examination of all the candidates (including 64 petitioners) for that batch of the year 2023 2024, as prayed for in I.A. (Civil) No. 444/2025, within a period of 1 (one) week from the date of receipt of the certified copy of this judgment and order.
 - (ii) Within a period of 1 (one) months from the date of receipt of certified copy of this judgment and order, the respondent No. 3, shall take a decision in respect of the observation given by respondent No.1 and 2 in the resolutions No. R/EC03/2023/36(B)(xiv), dated 22.09.2023 and R/EC-03/2024/31(B) (10), dated
 - 28.10.2024;
 (iii) Thereafter, within a period of one month, the respondent No. 1 and 2 shall take a decision in respect of the order dated 01.09.2023, bearing Memo No. GU/AFF/2023/7064-69, in respect of 'kept in abeyance' of affiliation of the petitioner college and also in respect of the admission process of the petitioner college, being kept on hold.
 - 25. The petitioners shall obtain a certified copy of the judgment and order of this Court and place before the respondent No.1, 2 and 3 within a period of one week from today.
 - 26. In terms of above, this writ petition and the connected interlocutory applications stand disposed of
- As per the judgement(supra), the petitioners were to obtain a certified copy of the judgment and order of the Court and to place before the respondent No.1, 2 and 3 within a period of one week from the date of the judgement. O/o ERC checked the records and found that no such communications have been received from the Petitioners.

- The petitioners have approached to Hon'ble Supreme Court agitating the judgement of the High Court dated 07.04.2025 and SLP has been granted by the Apex Court. The next date of hearing is 28.07.2025.
- The Executive Council, Gauhati University had taken two decisions dated 22.09.2023 and 28.10.2024 which is based on the inspection reports in respect of the institution. Both the decisions among other issues were challenged in the Hon'ble High Court of Gauhati.
- Both the decisions were communicated by the Gauhati University also to NCTE vide communication dated 08.11.2024 for information and further necessary action.
- Accordingly, the matter was placed before the ERC meeting no. 354th and the Committee had decided "to seek comments from the institution on the observation given by the Gauhati University."
- The decision of the Committee was communicated to the Institution vide letter no. 354.62/ERCAPP201646200/B.Ed/2024/70095 dated 17.12.2024. But no comments have been received so far from the institution.

After carefully observing the above facts, judgement of the Hon'ble High Court of Gauhati, Contents of the SLP along with other related documents, the ERC has decided that Show Cause Notice be issued to the institution to submit the reply on the deficiencies mentioned in the decisions of the Executive Council, Gauhati University dated 22.09.2023 and 28.10.2024 within 15 days from the date of issue of the Show Cause Notice.

 As per decision of ERC, Virtual Inspection of the Institution was conducted on 04.07.2025. The VT report was uploaded by the VT members through online mode.

After carefully observing the VT report, along with other related documents, the ERC found that the institution is deficient on the following grounds:

- Library does not have ITEP related text books, encyclopedia, paedology books, educational
 journals etc. which are essential for academic enrichment of teachers trainees.
- There is no language laboratory and psychology laboratory, both of which are mandatory components for teacher education programme.
- The institution is required to purchase books of the said courses as a minimum of 1000 titles and 4000 books, including the encyclopedia of education and journals.
- Professional Research General is required.

- Building completion certificate from the competent authority is required.
- Latest fire safety from the competent authority is required.

Hence, the committee decided that Show Cause Notice be issued to the institution to submit the reply on the deficiencies mentioned above within 7 days from the date of issue of the Show Cause Notice.
